2. Early Head Start-Child Care Partnership Grant Disabilities Waiver

Head Start Program Performance Standard 1302.14 (b) (1) states: A program must ensure at least 10 percent of its total funded enrollment is filled by children eligible for services under IDEA, unless the responsible Health and Human Services official grants a waiver.

The program will be applying for a waiver from the requirement that 10 percent of
enrollment includes children with disabilities. The program has served less than 10
percent of children with disabilities over the past two years. A waiver for this
requirement would preclude the program from receiving a deficiency.

3. Designation Renewal System HS/EHS

- In the DRS, grantees in good standing do not need to competitively apply for funding.

Fairfax County Office for Children Head Start & Early Head Start Program **Program Information Report (PIR) Summary**

Program Year 2018-2019

The Office of Head Start Program Information Report (PIR) provides comprehensive data on the services, staff, children, and families served by Head Start and Early Head Start programs nationwide. All grantees and delegates are required to submit Program Information Reports. The PIR data are compiled for use at the federal, regional, state, and local levels.

This report includes information on the children who participate in Fairfax County's **federally funded** Head Start (HS) and Early Head Start (EHS) programs and will be used for goal planning in the 2019-2020 program year.

ENROLLMENT



The program is funded to serve 734 children and pregnant women in Head Start and Early Head Start. The total number served in PY 2018-2019 was 879.

73 percent of families speak a language other than English at home.

- 44% speak Spanish
- 16% speak a Middle Eastern/ South Asian language
- 9% speak an African language
- 3% speak anotherlanguage

EDUCATION SERVICES

The program implements curricula and developmental assessment tools that are scientifically valid and reliable and are aligned with the public schools Program of Studies.

The program uses CLASS (Classroom Assessment Scoring System) to assess



effective teacher-child interactions.

In the fall of 2019, ${\bf 266}$ children transitioned from Head Start into kindergarten. **Eighty-seven** percent of newly enrolled children were screened within 45 days for developmental, sensory, and behavioral concerns.

FAMILY SERVICES



One hundred percent of families participated in health and parenting education.

One hundred ninety-nine families needed and received emergency/crisis intervention, such as food, clothing or shelter.

DISABILITIES



Children with disabilities comprised 10% of enrollment in HS/EHS grant #03CH010411, and 6% in EHS-CCP grant #03HP0003.

Fifty-five HS/EHS children served had an Individualized Education Program (IEP) and 29 EHS children had an Individual Family Service Plan (IFSP).

HEALTH & MENTAL HEALTH

Ninety-six percent of all children were current on immunizations and 89% were up-to-date on the schedule of preventative and primary health care perthestate's Early Periodic Screening, Diagnosis, and Treatment (EPSDT) schedule.

Seventy-nine children (9%) were referred for and received services from a mental health professional.

NUTRITION



Thirty-five percent of children in Head Start (ages 3-5) were identified as not being within the healthy weight category, which included children who were identified as underweight, overweight, and obese.

Nutritionists provided nutrition education, healthy food resources to address food insecurity, and information on the benefits of increased physical activity.
