### **New Business**

### 1. Town of Herndon, Department of Public Works

David C. Kockendarfer, Deputy Director, Department of Public Works provided an overview of the water system components, rates, cost saving efforts, revenue sources, availability fee, and model results.

A discussion ensued on the actual cost to distribute/sell the water, rates increases, and the cost to treat the water.

Director Liberman informed the commissioners that City of Falls Church Water Department (Falls Church Water) chose not to participate in the Consumer Protection Commission meeting of May 19 to discuss water rates and services for the City of Falls Church's water system.

Chairman Fee made the motion to authorize staff in the Department of Cable Communications and Consumer Protection and the County Attorney's office to prepare Virginia Freedom of Information Act (VFOIA) requests to the City of Falls Church; to the extent necessary, in order to be able to complete an evaluation of the City of Falls Church's water system, rates and services as part of the Commission's study on water rates for municipal water utilities in Fairfax County and subsequent report to the Board of Supervisors.

Commissioner Kirk seconded the motion. The motion passed unanimously.

A discussion ensued on the upcoming water rate presentations, whether a public hearing is needed, and results that would be gained in having a public hearing.

Director Liberman stated that staff will prepare information on holding a public hearing and present the information at the June meeting.

The meeting adjourned at 8:26PM.
