The electronic meeting was called to order at 7:31p.m. by Chairman Fielding.

# **Ouorum, Location and Audibility of Members' Voices**

Chairman Fielding conducted a Roll Call to verify that a quorum of members is participating; and that each member's voice is clear, audible, and at an appropriate volume for all of the other members; and the location from which member is participating. The roll call is as follows:

Chairman Fielding passed the virtual gavel to Vice-Chairman, Commissioner Park. A motion was made by Chairman Fielding that each member's voice can be adequately heard by each member of the Tenant-Landlord Commission (Commission). This motion was seconded by Commissioner Geier-Smith. The motion carried unanimously.

## **Need for an Electronic Meeting**

A motion was made by Chairman Fielding that the State of Emergency caused by the COVID-19 pandemic makes it unsafe for the Commission to physically assemble and unsafe for the public to physically attend any such meeting, and that as such, FOIA's usual procedures, which require the physical assembly of the Commission and the physical presence of the public, cannot be implemented safely or practically. Chairman Fielding further moved that the Commission may conduct this meeting electronically through a dedicated audio-conferencing line, and that the public may access this meeting by calling 1-866-434-5269 and entering access code 6751420. The motion was seconded by Commissioner Fusaro. The motion carried unanimously.

# Need to dispense with FOIA's Usual Procedures to Assure Continuity in Government/Continue Operations

A motion was made by Chairman Fielding that all of the matters addressed on the agenda must address the Emergency itself, are necessary for continuity in Fairfax County government, and/or are statutorily required or necessary to continue operations and the discharge of the Commission's lawful purposes, duties, and responsibilities. This motion was seconded by Commissioner Fusaro. The motion carried unanimously.

#### **Minutes**

A motion was made by Commissioner Geier-Smith and seconded by Commissioner Harberg to approve the minutes from February 13, 2020. The motion carried unanimously.

# **Report of the Chairman**

Chairman Fielding expressed appreciation for the ability to hold a Commission meeting. He welcomed new Commissioners Chamberlain and Islam.

#### **Report of the Directors**

Director Liberman discussed the Fairfax County FY 2021 budget process and the Countywide Strategic Plan. He explained how the Fairfax County FY 2021 budget aligns with the Fairfax Countywide Strategic Plan.

Director Makely discussed the Tenant-Landlord Commission FY 2020 Annual Report, stating it was in draft form and will be ready for review in September and a Commission vote at the October 8, 2020 meeting. She discussed options for a commission photo and stated the delay in the report would not impact the FY 2020 statistics.

#### **Staff Report**

Tenant landlord inquires and complaints have remained consistent during COVID-19.

A case regarding a tenant concerned about the landlord's entry into the home during COVID-19 was summarized. According to the tenant, the landlord entered the home to take measurements for home improvements and wanted to return with contractors. Due to the tenant's health and safety concerns for their family, the tenant requested the landlord and contractors not enter until the lease expired in

less than two months. After Consumer Affairs intervention, the landlord stated they followed guidelines established by the Center for Disease Control while in the rental dwelling due to the current public health crisis. However, as requested, the landlord decided not to make any improvements, unless an emergency repair is needed, until the tenants vacate the premises.

The first virtual Northern Virginia Housing expo was launched in June 2020 and will remain online through the rest of the calendar year. During the first month the page had 16,720 visits. Consumer Affairs had 51 visits. It is expected that the 2021 expo will also be virtual.

## **Commission Matters**

Commissioner Fusaro welcomed Commissioners Chamberlain and Islam and was glad the Commission could meet.

Commissioner Geier-Smith welcomed Commissioners Chamberlain and Islam and inquired about their interest in joining the Commission. She finds COVID "land" interesting.

Commissioner Harberg welcomed the Commissioners Chamberlain and Islam. She inquired about how the county is handling tenant-landlord issues during the pandemic.

Commissioner Purnell welcomed Commissioners Chamberlain and Islam. She expressed gratitude for those who are healthy and safe and concern for those facing hardships during the pandemic.

Commissioner Chamberlain is extremely thrilled to be a member of the Commission.

Commissioner Islam is excited to be a Commissioners and is thankful for the opportunity.
