The committee reviewed and approved the submission of the CCFP FY 2025-2026 Categories to the Board of Supervisors.

### Discuss HUD Notice of Allocations, FY 2024 One-Year Action Plan & Board Approval

B. Moses updated the committee on the submission and approval of the FY 2024 One-Year Action Plan to the Board of Supervisors on May 9, 2023, which included the final grant allocation figures for CDBG, HOME and ESG. Final submission of the FY 2024 Action Plan to HUD by the county will be completed no later than May 16, 2023.

### Update on Fairfax County Urban Renewal Qualification for FFY 2024-2026

J. Hsu provided an update to the Fairfax County's re-qualification with HUD as an "Urban County" for Federal Fiscal Years (FFYs) 2024, 2025, and 2026 for CDBG, HOME and ESG funds. Urban County qualification provides the county with its powers to undertake community development and housing assistance activities in the unincorporated areas of the County. It also allows the county to enter into cooperation agreements with units of general local government (UGLG) and to cooperate in the use of the county's powers for carrying out essential activities in accordance with the urban county's programs. These UGLGs include: the towns of Clifton, Herndon, and Vienna; and the cities of Fairfax and Falls Church.
