² A Half day rental is defined as any 6 hours between 8:00 am – 2:00 pm or 3:00 pm – 9:00 pm.

³ Prime days are Friday, Saturday, Sunday and Federal Holidays. Non-Prime days are Monday – Thursday.

⁴ All arena rentals include a standard drag and watering prior to time of rental. Please specify the times you will need these services in your pre-rental questionnaire. Watering and dragging service fees are for additional watering or dragging not included in the rental fee.

⁵ Rental of these items does not include setup or take down by facility. If setup is requested or takedown is required post rental the licensee will be charged for the maintenance labor at an hourly rate as listed on this sheet.

⁶Stall cleaning fee is required per stall for each stall used.

⁷ Portable sound system includes one portable speaker with charger, stand and wireless handheld microphone.

⁸Maintenance Labor covers any labor provided for the licensee by FFPF maintenance staff outside the specifications covered by this rental contract and must be approved by the Equestrian and Maintenance Manager.

All Requested Additional Services must be referenced in the rental application along with the specific dates and times the licensee will need the service. If the time/ date is not specified it is assumed that the licensee is waiving the service from their rental.

R.V. hookups are not available. Plugging any vehicle in to a FFPF outlet is strictly prohibited.
