

## Legacy System and Data Conversion

**DPD Data Conversion to PLUS** 

- All historic ZED applications/documents in ZAPS will available for viewing and research in PLUS
- Over <u>75,000</u> files (PDF, documents, etc....) converted into PLUS
- Over <u>20,000</u> ZAPs applications converted into PLUS
- SQL Server (ZAD/PD) records converted to PLUS
- In-process applications resumed in PLUS




