#### **Staff Reports**

- The number of foreclosure filings dropped about 20 percent from last November in Fairfax County. In Virginia, Prince William County is ranked number 1 this month, while Fairfax County fell to number 20. This data was provided by RealtyTrac.
- Susan Epstein, Inspector from the Fairfax County Zoning Enforcement Branch, Property Maintenance Section, will attend the January meeting. She will provide an overview of the Statewide Housing and Building codes and answer questions relating to maintenance and repair in rental dwellings.

### **Commission Matters**

- Commissioners Geier-Smith, Kiffney, and Kocsis were reappointed by the Board of Supervisors on December 7, 2009.
- There are currently two vacancies, one tenant and one citizen.
