**MOTION FOR LEAVE TO FILE EXTENDED BRIEF AND

Depp, II (“Mr. Depp”), by and through his undersigned counsel, pursuant to the Rules of the Supreme Court of Virginia, and sub-section 1.05 of Section E of the Fairfax Circuit Court Practice Manual (2018 ed.), hereby files this Motion for Leave to File Extended Brief and for Briefing Schedule on Demurrer and Plea in Bar, and in support thereof states as follows:

1. Mr. Depp, by counsel, has filed a Demurrer and Plea in Bar with respect to the Counterclaims filed by Defendant and Counterclaim Plaintiff Amber Laura Heard (“Ms. Heard”).



3. Mr. Depp also requests oral hearing on the Demurrer and Plea in Bar on Friday Motions Day, October 16, 2020, limited to thirty (30) minutes total.
