IT APPEARING that Jessica N. Meyers is an attorney in good standing with the state of New York and Commonwealth of Massachusetts; and

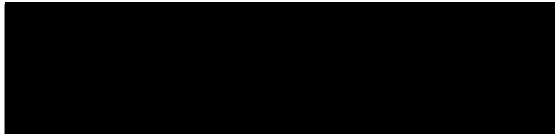
IT APPEARING that there is no objection to such admission; and
