APRIL 13, 2022**

The Service Delivery Oversight Committee of the Fairfax-Falls Church Community Services Board met electronically due to the COVID-19 pandemic that has made it unsafe to physically assemble a quorum in one location or to have the public present. Access was made available via video and web conferencing platform to CSB Board members, CSB staff, and members of the public. The meeting notice, including participation instructions, was posted electronically and on the building in which the meeting is typically held. Additionally, attendees were offered an opportunity to register for public comment during the 30 minutes prior to the meeting being called to order.

The motion was seconded by Captain Derek DeGeare and unanimously passed, following the return of the virtual gavel to Committee Chair Anne Whipple.

7. Trauma Informed Community Network (TICN)

Wellness, Health Promotion & Prevention Manager Marla Zometsky provided the staff presentation by highlighting the importance of the Trauma Informed Community Network (TICN) and bringing different entities to collaborate and implement principles of trauma-informed care. TICN is a multi-disciplinary, multi-agency effort to implement and support Trauma Informed Care initiatives across the Human Services System. It is an initiative of the Partnership for a Healthier Fairfax. TICN's goals are to create a mechanism for collaboration and sharing information and resources. TICN also offers free training for the staff. It's a 90-minute training to build empathy.
