SEXUAL ABUSE AND SEXUAL HARASSMENT ALLEGATIONS AND INVESTIGATIONS IN THIS FACILITY

	<p>Fairfax Juvenile Detention Center (FFJDC) Policy Chapter 6 (Prison Rape Elimination Act - PREA) outlines the Center’s approach to implementing the Federal PREA standards; the policy mandates zero tolerance of all forms of sexual abuse and sexual harassment and requires the designation of a PREA Compliance Manger. The PREA Coordinator is an upper-level Facility Manager in the management hierarchy of the Agency. The supervisory structure of the facility supports the facility's efforts to comply fully with the PREA standards. The PREA Coordinator confirmed through the interview process with the auditor that there is sufficient time and authority to develop, implement, and oversee efforts to comply with the PREA standards. The PREA Compliance Manger also confirmed with the auditor that there is sufficient time and authority to develop, implement, and oversee efforts to comply with the PREA standards. Facility policy provides the required PREA definitions and outlines the guidelines and procedures for preventing, detecting, and responding to sexual abuse and sexual harassment. The staff were able to speak to considerations given to challenges of the physical plant; addressing corners, blind spots, or areas that may inhibit line-of-sight or effective supervision of residents, and past, present, and future trends in the resident population. Facility policy Chapter Three: Program Operations outlines its approach to complying with supervision and monitoring of residents that supports compliance with the standard. In addition to direct supervision of residents, the facility has video monitoring capabilities that supplements supervision and supports efforts to protect residents from sexual abuse and sexual harassment. The system has been upgraded since the last audit and is equipped with video playback, recording and short-term storage capabilities. The auditor was able to observe staff postings during waking and sleeping hours, as well as the use of the camera system to supplement supervision and monitoring by staff. Consistent facility practice supported by documentation</p>

and mandated by Policy Chapter Three: Program Operations which requires upper-level staff to conduct unannounced rounds so they to prevent, identify, and deter staff sexual abuse and sexual harassment demonstrates proper implementation of this section of the standard. The rounds are documented by staff as they are conducted. A physical review of documentation, video and staff interviews confirmed the practice of conducting unannounced rounds. Designated upper-level staff conduct and document unannounced rounds on all shifts as reflected in facility documentation and captured on video. The review of a random sampling of these rounds supported compliance with section 115.313 (e) of the standard. Facility operations, including supervision and monitoring of residents were observed by the auditor on all shifts. Review of documentation, physical observations by the auditor and interviews of staff confirm that FFJDC maintains the required staffing ratio of 1:8 during waking hours and a minimum ratio of 1:16 during sleeping hours. The agency provided a staffing pattern report that is reviewed and updated at least annually to ensure adequate staffing to meet the needs of the facility.

	Policy prohibits cross-gender searches absent exigent circumstances. This prohibition does not apply to qualified medical personnel conducting medical procedures, staff conducting routine room checks, or in unusual circumstances when a response to a serious threat to life and safety is necessary; these searches must be justified. Cavity searches are prohibited unless authorized in writing by the courts. Staff who perform pat down and strip searches are trained in how to conduct

	<p>searches of transgender and intersex residents in a professional and respectful manner consistent with security needs and in the least intrusive manner possible. During the past 12 months, there were no cross-gender strip or visual body cavity searches and no cross-gender pat-down searches of residents. Interviews with residents and staff confirm compliance with facility policy and procedures. Further observations during the tour of the facility confirmed the practice of the cross-gender announcement. The facility has implemented policies and procedures that enable residents to shower, perform bodily functions, and change clothing without non-medical staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incidental to routine cell checks (this includes viewing via video camera). However, facility policy states: "Residents shall be provided privacy from routine sight supervision by staff members of the opposite sex while bathing, dressing, or conducting toileting activities except when constant supervision is necessary to protect the resident due to mental health issues involving self-injurious behaviors or suicidal ideations or attempts." - Resident's Privacy page 214. This statement is incongruent with the federal standard, as it does not meet the definition of exigent circumstances. Upon knowledge of any allegation of sexual abuse or sexual harassment the facility takes immediate action to provide for safety and security of residents and begins an administrative investigation. Fairfax County Police Department has responsibility for conducting all criminal investigations, including those related to sexual harassment and sexual abuse. Fairfax County Police is responsible for investigating allegations of sexual abuse. It is reported by the facility that they follow a uniform evidence protocol that maximizes the potential for obtaining usable physical evidence for administrative proceedings and criminal prosecution policy requires that all residents who experience sexual abuse are offered access to forensic medical examinations. The uniform evidence protocol was not provided, nor was it documented that it was requested by the facility but not received. The policy also requires that where possible the forensic examinations are conducted by a Sexual Assault Forensic Examiner (SAFE) or a Sexual Assault Nurse Examiner (SANE). When a SAFE or SANE is not available a qualified medical practitioner performs forensic medical examinations. Efforts to provide access to a SAFE or SANE are documented by the facility. The facility ensures that resident victims have access to these services at no cost to the victim. There have been no forensic medical exams conducted during this reporting period. The facility ensures that each resident victim of sexual abuse is provided with a qualified victim advocate for advocacy services that include but are not limited to accompaniment to forensic examinations and investigatory interviews. Intake staff reviews the information with the residents and residents sign verifying receipt of the information. The PREA information is presented in a manner that is accessible to all residents; it is comprehensive and age appropriate. During the facility tour the auditor observed the presence of PREA posters and reporting instructions posted throughout the facility. The facility has access to interpreting and translation services for residents with limited English proficiency and those residents who may have hearing or visual impairments. Signage language is clear, easy to understand, and at an appropriate reading level for residents. The signage also speaks to the services, such as emotional support services and external reporting and includes language that clearly details what services are available and for what purposes in an age-appropriate reading level. Signage is provided in English and Spanish, the</p>

	<p>languages most commonly spoken in the facility. The composition and placement of signage accommodates most readers, including those of average height, low vision/visually impaired, or those physically disabled/in a wheelchair, etc. The information provided by the signage is not obscured, unreadable by graffiti, or missing due to damage. The information on all signs is accurate and consistent throughout the facility. The signs were placed in areas that ensure accessibility to staff and residents confined in the facility and other persons who may need the information or services provided. Staff and visitors also receive pertinent PREA information at the entrance of the facility which runs on a monitor. 277 residents admitted during the past 12 months received this information at intake, the information was presented in a comprehensive age-appropriate fashion and included information on their rights to be free from sexual abuse and sexual harassment, freedom from retaliation for reporting such incidents, and on facility policies and procedures for responding to such incidents within ten days of intake. Further, information is shared with parents, legal guardians and visitors who may file grievances on behalf of residents if such a need arises. Third parties may assist residents in filing requests for administrative remedies relating to allegations of sexual abuse and shall also be permitted to file such requests on behalf of residents. Domestic and Sexual Violence Services (DSVS) for outside victim advocacy service provision to residents of the Detention Center. The MOU establishes that services will include: the provision of victim advocacy, counseling, crisis intervention services, assessment, and identification of special needs of victims, provide information related to reporting methods, legal options, and other relevant and supportive contacts. If requested by the victim, accompaniment to the hospital and relevant interviews and court proceedings. Residents have access to the phone number and mailing address for both agencies. Resident interviews confirmed that they knew how to report using various avenues including reporting directly to staff, reporting to their attorney or probation staff, and reporting to parents and guardians. Residents were able to answer that they would receive various forms of help if they called the number. Residents said they could get counseling, help with services, someone to speak to and therapy. Residents understood that that their communications using the telephone would be confidential unless there was an issue of safety, but that the call would most likely be recorded. The facility informs residents of the mandatory reporting rules governing privacy and confidentiality regarding disclosures of sexual abuse made to outside victim advocates. Staff and resident interviews confirmed that residents have reasonable access, and that access is provided in as confidential a manner as possible. Interviews with residents and staff confirm that residents have access to their attorneys, other legal representation, and parents and legal guardians. Residents reported that they were able to make phone calls, visit with professional service providers, parents, and guardians, and send and receive mail from parents and guardians and their legal representatives. Accommodations are made to schedule alternate visiting times for visitors that may require them. During the onsite tour and throughout the five day visit, this auditor observed various posters, flyers, brochures and handouts that provided this information to residents. Lastly, during the onsite visit and thirty days after the visit, this auditor called the hotline to confirm that reports from the Detention Center would be taken and responded to immediately. The operator confirmed that they take reports from the Center and forward reports as agreed upon in the Memorandum of Understanding.

If the screening using the indicates that a resident has experienced prior sexual victimization, whether it occurred in an institutional setting or in the community, staff shall ensure that the resident is offered a follow-up meeting with a medical or mental health practitioner within 14 days of the intake screening. In the past 12 months, no residents disclosed prior victimization during screening. Staff maintain secondary materials (e.g., forms, logs) documenting compliance with the above required services. The information gleaned from the Vulnerable Population Worksheet is limited to those who have a need to know to ensure that sensitive information is not exploited to the resident's detriment by staff or other residents. In keeping with the standard, policy requires that any information related to sexual victimization and abusiveness that occurred in an institutional setting shall be strictly limited to medical and mental health practitioners and other staff as necessary, to inform treatment plans and security and management decisions, including housing, bed, work, education, and program assignments, or as otherwise required by Federal, State, or local law. The completed worksheet is maintained in the resident's file. A review of the worksheet form resulted in recommendations from the auditor to clarify which questions needed to be asked by the screener and answered by the residents, and which questions might benefit from gleaning additional information from historical documents, including court records, charges, previous incident reports, and similar documentation. The form asks for comments and additional information from the screener and the section was rarely used, which is a lost opportunity to ensure the facility is utilizing the tool they developed in the most effective way possible to maximize their chances of ensuring sexual safety for all residents, especially those who might be more vulnerable due to abuse history. In the past 12 months, no residents disclosed they had previously perpetuated sexual abuse during the screening; subsequently there were no follow up meetings with a mental health practitioner. During the onsite portion of the audit, resident files and other documents were inspected and reviewed. The storage area for all hard copies of sensitive information meets the requirement of secure maintenance and limited access. Electronic safeguards are in place for all information and documentation collected and maintained electronically pursuant to the PREA Standards. Anyone accessing electronic records has been provided access based on their roles and a need to know, to safeguard these files which are protected by password, secure storage, and accessibility to the storage.
