<u>Scope Approval – Alabama Drive Park Athletic Field Lighting and Irrigation Systems</u> Replacement (Dranesville District)

ISSUE:

Approval of the project scope to replace the lighting and irrigation systems at Alabama Drive Park.

RECOMMENDATION:

The Park Authority Executive Director recommends approval of the project scope to replace the lighting and irrigation systems at Alabama Drive Park.

TIMING:

Board action is requested on March 27, 2019, to maintain the project schedule.

BACKGROUND:

Alabama Drive Park is located at 1100 Alabama Drive in Herndon, Virginia (Attachment 1). Existing facilities include two lighted diamond and one unlighted rectangular natural turf fields with irrigation and two lighted multiuse courts.

The approved Planning and Development Division FY 2019 Work Plan includes a 2016 Park Bond project for lifecycle replacement of the lighting and irrigation systems at Alabama Drive Park. A project team was assembled with representatives from the Park Operations and Planning and Development Divisions to establish the project scope for the lighting and irrigation replacement.

The project team has confirmed that the existing irrigation system at each of the three fields is beyond its useful life and needs to be replaced. The controller and pumping unit are in good condition and do not need to be replaced. The project scope recommended by the project team includes installing a new irrigation system at each field to include new lateral and station piping, valves, sprinkler heads, quick couplers, and control wire.

The project team has also confirmed that the lighting at the diamond fields and multiuse courts is beyond its useful life and needs to be replaced. The project scope for lighting recommended by the project team includes installing new LED fixtures at the diamond

fields, installing new fixtures with new poles at the multiuse courts and installing a new lighting control cabinet.

The project cost estimate to design and replace the lighting and irrigation systems is \$670,000 as detailed in Attachment 2. Staff estimates these improvements will result in no additional annual revenue. Staff estimates a slight decrease in annual operating and maintenance costs. Staff estimates a lifecycle cost of \$120,000 for the replacement of the irrigation system in year 20 and \$550,000 for the replacement of the lighting system in year 40.

The proposed timeline for completing the project is as follows:

FISCAL IMPACT:

Based on the scope cost estimate, funding in the amount of \$670,000 is necessary to fund this project. Funding is currently available in Fund 300-C30400 in the amount of \$500,000 in PR-000078-073, Alabama Drive Lighting & Irrigation Replacement and in the amount of \$120,000 in PR-000078-074, Alabama Drive Outdoor Court Lighting, both in the 2016 Park Bond and in Fund 300-C30010 in the amount of \$50,000 in PR-000067-018, Alabama Drive Lighting Replacement in the General County Construction Fund for a total funding amount of \$670,000 to complete this project.

ACTION

<u>Scope Approval – Rocky Run Stream Valley Trail Improvements in Greenbriar (Springfield District)</u>

ISSUE:

Approval of the project scope to reroute 400 linear feet (LF) of existing gravel trail by installing 200 LF of concrete trail and a new pedestrian bridge in the section of the Rocky Run Stream Valley Park between Middle Ridge Road and the Fairfax County Parkway.

RECOMMENDATION:

The Park Authority Executive Director recommends approval of the project scope to reroute 400 LF of existing gravel trail by installing 200 LF of concrete trail and a new pedestrian bridge in the section of the Rocky Run Stream Valley Park between Middle Ridge Road and the Fairfax County Parkway.

TIMING:

Board action is requested on March 27, 2019, to meet desired construction schedules.

BACKGROUND:

The Park Authority Board approved the list of trail projects identified for funding from the 2016 Park Bond designated for trail improvements on October 25, 2017. This list of projects includes improvements to an existing section of stream valley trail in the Rocky Run Stream Valley between Middle Ridge Drive and the Fairfax County Parkway in the Springfield District.

A public meeting was held on June 21, 2018, to inform the residents the three phases of work planned for this section of the stream valley. This includes this bridge replacement and two Sinking Fund funded paving projects east and west of Middle Ridge Drive. Staff gave a presentation of the work and a question and answer session was held. Many residents expressed support for this project. Based on the meeting results, it was decided that we would proceed with this work.

A project team was assembled with representatives from Park Operations, Resource Management and Planning and Development Divisions to establish the project scope in accordance with the approved FY 2019 Planning and Development Division Work Plan.

The civil engineering firm of Christopher Consultants was hired to assist the project team in developing the project scope.

Staff recommends the following scope of work for this project to include:

- Demolition and removal of approximately 400 LF of gravel trail
- Demolition and removal of an existing concrete stream crossing
- Construction of a 60' x 10' steel pedestrian bridge
- Construction of 200 LF of 8-foot-wide concrete trail to the bridge

The detailed cost estimate for the construction of trail improvements, including the associated contingency and administrative costs as outlined above is \$329,850 (Attachment 2). This project will not generate any additional revenue. Staff estimates a decrease of \$214 in annual maintenance costs for this trail with a lifecycle replacement cost of \$47,300 in year 20 for repaving the trail and a lifecycle replacement cost of \$272,500 in year 70 for replacement of the bridge.

The proposed timeline for the project is as follows:

FISCAL IMPACT:

Based on the scope estimate, funding in the amount of \$329,850 is necessary to fund the Rocky Run Stream Valley trail improvements. Funding is currently available in Fund 300-30400 in the amount of \$249,550 in PR-000078-025, Rocky Run SV Trail Improvements, 2016 Park Bond, and in Fund 300-C30010 in the amount of \$80,300 in PR-000108, Capital Sinking Fund for Parks, General County Construction for the total amount of \$329,850 required to fund this project.



Approval of Huntley Meadows Park Master Plan Administrative Update (Lee District)

ISSUE:

Administrative update of the Huntley Meadows Park Master Plan to conform with the approved Comprehensive Plan Amendments 2018-IV-BK1 and 2018-IV-TR1.

RECOMMENDATION:

The Park Authority Executive Director recommends approval of the Huntley Meadows Park Master Plan administrative update to conform with the approved Comprehensive Plan Amendments 2018-IV-BK1 and 2018-IV-TR1.

TIMING:

Board action is requested on March 27, 2019.

BACKGROUND:

Huntley Meadows Park is a 1,559-acre park located at the intersection of Harrison Lane and Lockheed Boulevard in the Alexandria area of Fairfax County in the Lee District Supervisory District. The park is one of the region's premiere resource-based parks and is home to diverse forests, wetlands, and meadow habitats and nearly 500 species of plants and wildlife, many of which are recognized as threatened, rare, or uncommon. Multiple significant cultural resource sites are proximate to the subject transportation corridor alignments, such as the northern boundary markers for George Washington's estate and ditching associated with Washington's Muddy Hole Farm. Recreational amenities such as trails, interpretive features, and other low-impact facilities also serve the park.

The Huntley Meadows Park Master Plan approved by the Park Authority Board in October 1978 (Attachment 1) included a planned trail on the southern and eastern borders of the park (minor paved trail) and a planned trail on the northern border of the park (shared use path). Neither trail has been constructed as studies and assessments of the parks natural and cultural resources conducted over time since the master plan was approved have informed park staff of the potential negative impacts of these trails to the park's resources.

The shared use path is included in the current Countywide Bicycle Master Plan, a component of the Fairfax County Comprehensive Plan. The minor paved trail is included in the Countywide Trails Plan, a component of the Fairfax County Comprehensive Plan, and related Area Plan guidance. The Board of Supervisors adopted Comprehensive Plan Amendment 2015-IV-MV1 as a result of the Embark-Richmond Highway study in March 2018 and authorized the consideration of Plan Amendments 2018-IV-BK1 and 2018-IV-TR1, to remove a planned minor paved trail and a shared use path through Huntley Meadows Park (Attachment 2) from the Fairfax County Comprehensive Plan. These Plan Amendments were led by the Fairfax County Department of Transportation, with support from the Department of Planning and Zoning and Park Authority (Attachment 2).

The Planning Commission recommended the removal of the shared use path and minor paved trail after hearing public comment on the proposed amendments on January 30, 2019 (Attachment 3). The Board of Supervisors concurred and approved the Comprehensive Plan Amendments after hearing public comment on February 5, 2019 (Attachment 4). Action by the Board of Supervisors removes the shared use path and minor paved trail from the Countywide Bicycle Master Plan and Countywide Trails Plan components of the Fairfax County Comprehensive Plan. The Board of Supervisors further directed County staff to investigate alternatives to the planned trails that would not negatively impact the resources in Huntley Meadows Park.

Staff is planning a future update of the park master plan, however, to eliminate confusion with ongoing County planning efforts staff is recommending an administrative update to the Huntley Meadows Park Master Plan now to remove the shared use path and minor paved trail from the park master plan to conform with the changes to the Fairfax County Comprehensive Plan.



PA 2018-IV-BK1 COMPREHENSIVE PLAN AMENDMENT (HUNTLEY MEADOWS PARK PATH FROM TELEPATH ROAD TO HARRISON LANE) — The proposed amendment concerns the shared use path planned between Telegraph Road and Harrison Lane in Huntley Meadows Park (Tax Maps 92 1, 92 3, and 92 4) in the Lee Supervisor District. The amendment will consider removal of this shared use path from the Countywide Bicycle Master Plan, a component of the Comprehensive Plan. (Lee District)

PA 2018-IV-TR1 COMPREHENSIVE PLAN AMENDMENT (HUNTLEY MEADOWS PARK PATH FROM TELEGRAPH ROAD TO LOCKHEED BOULEVARD) — The proposed amendment concerns the minor paved trail planned between Telegraph Road and Lockheed Boulevard in Huntley Meadows Park and along Hayfield Road (Tax Maps 91 4, 92 3, 92 4, 100 2, 101 1, and 101 2) in the Lee Supervisor District. The amendment will consider removal of this minor paved trail from the Countywide Trails Plan, a component of the Comprehensive Plan, and related Area Plan guidance. (Lee District)

Decision Only During Commission Matters (Public Hearing on January 16, 2019)

Commissioner Migliaccio: Second item is a decision only and it was for the Huntley Meadows Park plan amendments and we have a few staff members who just settled in and I don't know if any fellow Commissioners have questions to staff before I move into my motion. If they do, now is the time.

Chairman Murphy: Are there any questions? Mr. Niedzielski-Eichner.

Commissioner Niedzielski-Eichner: I don't have any questions per se but I do –

Chairman Murphy: Is your mic on?

Commissioner Niedzielski-Eichner: I just want to state that - Mr. Chairman - that I'm going to support this motion. I believe, with the assurances that Supervisor McKay's commitment has reflected in his December 18th, 2018 letter to the Trails and Sidewalks Committee will be memorialized in a follow-on motion by Commissioner Migliaccio recommending that staff be directed to begin immediately identifying connectivity alternatives in advance of the Countywide Trails and Bicycle Master Plan update. I would note, in this regard, staff indicated the public hearing that the Trails and the Bicycle Master Plan update is not yet a funded activity. My hope is that by approving Supervisor McKay's motion, the Board of Supervisors and the Park Authority Board, would also see to it that the master plan update is funded. Thank you.

Commissioner Migliaccio: I will give you my motion now.

Chairman Murphy: Mr. Migliaccio.

Commissioner Migliaccio: Thank you. Thank you, Mr. Chairman. On January 16th, we held a public hearing on the issue of whether to remove two conceptual bike trails from the Comprehensive Plan for Huntley Meadows Park. I would like to thank the citizens who spoke

that evening and all the people who took the time to send in written comments. I know that the comments have been distributed to all Planning Commissioners and entered - entered into the official record for these two plan amendments. To those who do not think that this process is the preferred way to amend the Comprehensive Plan, I tend to agree. It is almost always better for us to look at items in a holistic manner, but that is not what we are presented with today. The Board of Supervisors has charged the Planning Commission to look at the two plan amendments and to make a recommendation. While this process is not perfect, it has allowed a spirited debate on this topic. Multiple public hearings were held and no less than 80 individual comments were received by the Planning Commission and that's not to mention the hundreds upon hundreds of petitions both for and against removal of the trails. Groups such as the Audubon Society, FABB, the Park Authority, the Trails Committee, the Virginia Native Plant Society, and Friends of Huntley Meadows Park all gave their opinions. We even heard from one state senator and two state delegates. I do not think that anyone can state that this issue flew under the radar. Just the opposite. In fact, I think that if this was attached to amending the 120-page Master Bike Plan, it may not have received as much attention and as many public hearings on this, or public meetings. After reading all the information found in the public comments and staff report, I am convinced that even if we had the money and capacity to build these trails as they are depicted today - excuse me, today it would not be the correct choice. The damage done to Huntley Meadows Park, a regional gem, would outweigh any benefits. The original master park plan that placed the trails on the map was done prior to any true knowledge of what existed in the park. We have since discovered rare flora and fauna that needs protection and the wetlands have been more fully mapped. Because of this, I will be making a motion to support the staff's recommendation to remove the trails from the Comprehensive Plan. That being said, I do agree with FABB that the process could be better and my follow-on motion addresses that issue. It captures what Commissioner Niedzielski-Eichner had mentioned, that Supervisor McKay had committed to the community, to FABB, and to the Trails Committee, that they will start to immediately look for alternative routes. I deferred my decision until tonight to allow time to review the information heard at the public hearing and to allow the Lee District Land Use Committee to have a chance to vote on this item. That vote took place on Monday night after hearing from staff and hearing from the opponents and proponents of staff's recommendation, the Land Use Committee voted 15-0-2 to support staff's position. Therefore, Mr. Chairman, I MOVE THAT THE PLANNING COMMISSION RECOMMEND THAT THE BOARD OF SUPERVISORS ADOPT THE STAFF RECOMMENDATION FOR PLAN AMENDMENTS 2018-IV-BK1 AND 2018-IV-TR1 FOUND ON PAGE 18 OF THE STAFF REPORT DATED NOVEMBER 29TH, 2018.

Commissioners Ulfelder, Sargeant, and Strandlie: Second.

Chairman Murphy: Seconded by Mr. Ulfelder, Mr. Sargeant, and Mrs. Strandlie. All those in favor of the motion to recommend to the Board of Supervisors that it adopt PA 2018-IV-BK1 and PA 2018-IV- TR1, say aye.

Commissioners: Aye.

Chairman Murphy: Opposed? Motion carries.

Commissioner Migliaccio: And the follow-on motion that everyone wants. I MOVE THAT THE PLANNING COMMISSION RECOMMEND THAT THE BOARD OF SUPERVISORS

DIRECT STAFF TO IMMEDIATELY BEGIN BRINGING IMPACTED STAKEHOLDERS TOGETHER AND IDENTIFYING CONNECTIVITY ALTERNATIVES TO THE SUBJECT TRAILS FOUND IN THESE TWO PLAN AMENDMENTS IN ADVANCE OF THE COUNTYWIDE TRAILS AND BICYCLE MASTER PLAN UPDATE.

Commissioners Strandlie, Cortina, Tanner, and Clark: Second.

Chairman Murphy: Seconded by Mrs. Strandlie, Ms. Cortina, and Mr. Tanner. And Mr. Clark. Why don't you just say everybody seconded the motion? Okay. Is there a discussion? All those in favor of the motion, say aye.

Staff recommends the Comprehensive Plan be modified as shown below. Text proposed to be added is shown as <u>underlined</u> and text proposed to be deleted is shown with a strikethrough. Text shown to be replaced is noted as such.

DELETE: Fairfax County Comprehensive Plan, 2017 Edition, Area IV, Rose Hill Planning District, as amended through March 20, 2018, RH7-Huntley Meadows Community Planning Sector, Parks and Recreation, Recommendations, page 95:

"Due to ecological and engineering constraints including flooding and unconsolidated soils, development of the proposed perimeter trail on the western and southern boundaries of Huntley Meadows Park would not be prudent. This portion of the trail should either be relocated or deleted from the countywide trail system."

COMPREHENSIVE LAND USE PLAN MAP:

The Comprehensive Land Use Plan Map will not change.

COUNTYWIDE TRANSPORTATION PLAN MAP:

The Countywide Transportation Plan Map will not change.

BICYCLE MASTER PLAN MAP:
