A-2 <u>Designation of Stephen C. Thormahlen as Director Emeritus of the Fairfax County Park</u> Foundation Board

Dr. Carter made a motion to approve Stephan C. Thormahlen's designation as Director Emeritus of the Fairfax County Park Foundation; seconded by Mr. Quincy. The motion carried by all members present; Dr. Aidoo and Messrs. Hackman, Khan, and Zook were absent.

CHAIRMAN'S MATTERS

Mr. Bouie congratulated the entire staff and board. He thanked Mr. Quincy and everyone
that attended the Board of Supervisors meeting on June 25 to receive the proclamation for
Park and Recreation Month. All the Supervisors, with the exception of two, spoke very
highly of their love of parks and the things Parks does to promote the quality of life in
Fairfax County.

One of the things he noted in his remarks was the Memorandum of Understanding (MOU) with the Board of Supervisors and the Ordinance which expires in October 2021. Rather than waiting until late in 2020 he would like staff to put together a plan to present the MOU and what changes Parks would like to make or discuss making in the July timeframe so that Parks is ready to engage the current Board of Supervisors and potentially be able to get that done this year.

• He reported that he a great time in Albuquerque at the Senior Olympics. He was the flag bearer for the Commonwealth of Virginia. There were 89 athletes from Virginia among the 14,500 athletes that attended. It was the biggest senior games ever with teams from Mexico, Barbados, Bahamas. It was unbelievable.

On Tuesday night he had the opportunity to have dinner with Julia "Hurricane" Hawkins. Julia is the world record holder in the 50- and 100-meter dash. She is 103 years old and did not start running until she was 100. She beat four people under 90 in her races and was a double-gold medalist last year. She also rides her bike three times a week, and it's not with training wheels. She was fascinating.

He learned that one of her bigger claims to fame is that during World War II she collected more scarp metal for the war effort shipbuilding than any other person in the United States. A Navy ship was named after her town and she led that effort to name the ship,

Ms. Hawkins told him that she is having a great time and is a former schoolteacher and some of her students were about to turn 80.

Mr. Bouie and his wife went for four gold medals and brought home four gold medals.

DIRECTOR'S MATTERS

- Mr. Kincannon reported that Aimee Vosper had attended the NACPRO conference and picked up 2019 Historical / Cultural Facility Award for the Resident Curator Program.
- Twin Lakes hosted the second annual Women & Golf Reception to rave reviews! The event featured free mini clinics provided by Golf Fairfax instructors from seven golf courses as well as ten golf-centric local exhibitors including The First Tee, Virginia Stage Golf Association, Callaway and the Workhouse Art Center. Attendees enjoyed goody bags and giveaways thanks to sponsor contributions of over \$5,000 in goods and services. Top sponsors included Martini Golf Tees, Moe's Southwestern Grille, and Dominion Wedding Entertainment who donated a DJ for the reception. Pinecrest Golf Course catered a delicious taco and salad bar complete with allergy friendly options. The event wrapped up with guest speakers from Women on Course, LPGA Amateurs DC, Women's Congressional Golf Association, and Golf Fairfax. This event showcased our diverse offerings for women and children as well as rental facilities at our seven golf courses, we heard great feedback on site regarding the event and facility. We appreciate the support of our committee, instructors, golf course managers and the Fairfax County Park Foundation.

BOARD MATTERS

- Dr. Carter had nothing to report.
- Ms. Godbold attended the Women in Golf event at Twin Lakes Golf Course. The event was well-attended and was a lot of fun.

On Sunday, June 16, she and Aimee Vosper attended the Sully Car Show, which was the 100th show. There was a big parade of cars. The weather was beautiful and there were a lot of people.

Barbara Nugent invited her to attend the Resource Management Division's manager meeting. The meeting lasted about 1 ½ hours and she will be doing more touring soon.

Attended the American Public Gardens Association 2019 Conference in Washington D.C., which was held June 17-21. She attended one day of the conference to see Sarah Munro, the President of FROGS. She moderated a panel called, "Genius From Gender Diversity in Design", which talked about women in landscape architecture and design. She talked about the history of Green Spring Gardens and someone was there from Dumbarton Oaks. It was fascinating.

She attended two other sessions that aligned with her personal interests. One was called "Dance Performance Sharing Mission through Movement." This was how parks and other public spaces could use dance performances to bring people into the spaces and see them differently.

The last one was called the Living Landscape: "The Changing Face of America's Public Garden Spaces and Community Gardens." It was about developing community gardens that specializes in the food that immigrant communities and refugee communities bring.

Ms. Godbold is willing to share more information if anyone is interested.

• Mr. Kendall also attended the American Public Gardens Association conference. He noted that APGA also held a tour of Green Spring Gardens on Monday prior to the conference kickoff. Roughly 50 people came on a bus to tour the gardens. He learned that Green Spring has an accredited witch hazel collection which everyone wanted to see. They were well-versed in horticulture and come from every garden all over the country, mostly public gardens, a lot of them fee-based gardens.

The kickoff for the concert series was held last week. This was the fifth concert in the series and there was no rain and about 600 people have been in attendance.

He offered thanks to the staff and the managers at the Park Authority for the work they have done in this past year. They have been put under tremendous stress and under conditions they probably would not like to replicate in the coming year. We are hoping that is not going to be true, but he really appreciates all the work they put in with the short staff and lack of resources.

- Mr. Thompson reported that the Sports Tourism Task Force met and talked about a variety of projects and met with the consultant about the ski complex in the Mount Vernon area.

He commented on an interesting article on Facebook about a baseball complex in the Boston area that is being developed in partnership with Perfect Game, a scouting service, for \$800,000,000. There will be mixed use facilities to include shopping, etc. Construction of the facility will take place on October 1. This is an example of some of the projects of this scope that are taking place around the country.

Beatrix Farrand was a landscape architect and founding member of the American Society of Landscape Architects. One of the gardens she designed is in Washington, DC. Staff added that she designed Green Springs. He added that she had designed over 110 gardens around the country in the 1700s.

• Mr. Quincy noted that he and Mr. Gorham also attended the Sully Car Show. It is his Father's Day present to himself.

Mr. Quincy stated that Parks had a very successful ribbon cutting on Saturday, June 22, at Quantum laying field in Tysons. This is the second field to be completed in Tysons. He thanked Judy and her family for helping out with the event. He noted that the field is already being scheduled for use.

He reported that he is serving on the Merrifield Development Task Force. Parks and recreational facilities are a hot topic of the task force. Andi Dorlester is attending those meetings regularly and is making very valuable contributions. For those not familiar with Merrifield, the area that is being developed is the old Exxon Mobile site on Gallows Road which is being into an INVOA research center and housing campus.
