Mr. Hackman made a motion to approve the Mastenbrook Volunteer Matching Fund Grant Program request from Overlook Foundation in the amount of \$18,500 to assist with controlling invasive plants in the Turkeycock Run Stream Valley; seconded by Mr. Thompson. The motion carried by all members present; Messrs. Kendall and Khan were absent.

CHAIRMAN'S MATTERS

- Mr. Bouie commented that the presentation the board received about the Vulnerability Map during the Budget Committee with Funding Policy and Bond meeting is intriguing and enlightening. He encouraged the board to take some time to look at it. It will be the foundation of discussions with various Supervisors. He noted that a number of the Park Board members have had those meetings with their Supervisors. He, Kirk Kincannon, and Dave Bowden will meet with Supervisor Alcorn on Friday, February 14.
- He noted that Parks is getting into the throws of the spring season, so all the maintenance crews will be busy. He extended kudos to all those heroes ahead of time because they will be very busy with more participating and the season getting longer.

DIRECTOR'S MATTERS

• Mr. Kincannon stated that the Park Authority was honored by the Fairfax County Tree Commission with an award for tree preservation.

Commission members voted to present the Tree Conservation Award for Tree Preservation to the Park Authority for its work on the Difficult Run at Brittenford Drive Stream Restoration Project. Urban Forester Hugh C. Whitehead of the Urban Forest Management Division said, "This is a testament to the outstanding tree preservation planning and implementation achieved with this project. Visitors to the park and residents of the surrounding community will benefit from this valuable contribution for many years to come."

The award was presented in a Government Center ceremony on Friday, January 24, 2020.

• Mr. Kincannon noted that upon entering the Herrity Building this spring one will notice that the class registration unit is moving to the first floor of the building in an effort to improve customer service related to equity and access. That should be completed by the end of March.

Appointment of Laura Eakin Erlacher to the Fairfax County Park Foundation Board

ISSUE:

Appoint Laura Eakin Erlacher to the Board of Directors of the Fairfax County Park Foundation.

RECOMMENDATION:

The Park Foundation Board recommends the appointment of Laura Eakin Erlacher to the Foundation's Board of Directors.

TIMING:

Board action is requested on February 26, 2020.

BACKGROUND:

In accordance with the Bylaws of the Fairfax County Park Foundation, the Foundation Board nominates individuals to become members of the Foundation Board of Directors. Appointments are effective following the concurrence of the Park Authority Board.

The Foundation Board has nominated Laura Eakin Erlacher for appointment to the Foundation Board of Directors on February 26, 2020.

Ms. Eakin Erlacher was recruited by the Park Foundation Director, Tim Eakin Walsh. His appointment will be for a three-year term.

Laura Eakin Erlacher is the Director of Government Affairs & Policy for GE Gas Power. She analyzes domestic and global energy trends and climate policies and Provides strategic guidance on Federal and state legislation and regulations of importance to the natural gas industry.

Prior to her current position, Laura was the Washington DC publicist of the Emilie Brzezinski Sculpture where she coordinated, promoted and installed two successful art exhibits of monumental wood sculptures at Jim Kempner Fine Art (NYC) and the Katzen Art Center, American University (WDC).

Ms. Eakin Erlacher served as PPL Corporation Manager of Federal Government Relations in Washington DC where she advocated Fortune 500 electric and gas utility corporate positions on key federal legislative and regulatory issues before U.S.

Congressional members, senior federal government officials, and international government representatives.

Previous roles with PPL Corporation include Manager of U.S. Business Development, PPL Global, and Analyst of International Business Development in Fairfax, Virginia.

Other experience includes Business School Intern, Investment Development at an Overseas Private Investment Corporation, Community Relations assistant at the Boston University Office of the President, and Assistant to the Vice President for Programs & Projects at the Atlantic Council of the United States.

Positions held in Prague, Czech Republic are Secondary School English Teacher and Assistant in the Central European University Office of the Chief Executive.

Ms. Eakin Erlacher earned her Master of Business Administration from Boston University School of Management. She holds a Bachelor of Arts in Foreign Affairs from the University of Virginia.

She was the first member to represent the Eakin Family on the Park Foundation Board, having served on the inaugural Board from 2001-2004. During that time, she supported Fairfax County Park Authority by raising supplemental funds from private sector, grants and collaborative partnerships. The major fundraising initiative was Clemyjontri Park, a two acre accessible playground in McLean, Virginia.

In recent years, Ms. Eakin Erlacher joined her cousin, Tim Eakin Walsh, to present the annual Eakin Philanthropy Awards, established by the Park Foundation to recognize visionary financial and material contributions that significantly enhance Fairfax County parks.

In 1951, LeRoy Eakin, Sr. donated 14 acres of land which was Fairfax County's first park. The Eakin family gave another 240 additional acres which ultimately became the Fairfax County Park Authority. Laura is interested in joining the board to continue the Eakin Family legacy.
