(BACs) Alta Newman, Chair, Fairfax County Commission for Women, presented highlights of reports that summarized all the work of the Commission and the Office for Women on its FY 1999 Annual Review.

Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and asked unanimous consent that the Board direct staff to determine why the Virginia Employment Commission's data is different from the County data regarding cultural outreach statistics. Without objection, it was so ordered.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

Following discussion, with input from J. Thomas Manger, Chief of Police, Supervisor Dix moved that the Board accept this report and refer it to staff for review and report its findings. Supervisor Connolly seconded the motion and it carried by unanimous vote.

Supervisor Dix referred to page nine of the report and moved that the Board direct the Department of Community and Recreation Services, working with the Park Authority, to:

- Develop a plan for a multi-field complex or equivalent modifications to existing fields.
- Report its findings to the Board by the end of March 2000.

Supervisor Connolly seconded the motion and it carried by unanimous vote.

<u>ADMIN 8 – INSTALLATION OF MULTI-WAY STOP AT SADDLE ROAD</u> <u>AND CARRHILL ROAD (HUNTER MILL DISTRICT)</u>

- Directed staff to request the Virginia Department of Transportation to install the multi-way stop at the earliest possible date.

ADMIN 9 – SUPPLEMENTAL APPROPRIATION RESOLUTION (SAR) AS 00043 FOR THE FAIRFAX COUNTY POLICE DEPARTMENT TO ACCEPT A GRANT AWARD FROM THE VIRGINIA DEPARTMENT OF MOTOR VEHICLES FOR A DEER CRASH ABATEMENT PROGRAM

- (SAR) Approved SAR AS 00043 in the amount of \$40,000 to fund a Deer Crash Abatement Program through a grant award from the Commonwealth of Virginia. No additional County funding is required.

Supervisor Hyland moved that the Board:

• Defer decision on the granting of HOME and CDBG Program funds to New Hope Housing, Incorporated until December 6, 1999.

Supervisor Connolly seconded the motion and it carried by unanimous vote.

18. I-1 - CONTRACT AWARD FOR RENOVATIONS/UPGRADES AT THE PARK TOWNHOUSES (LEE DISTRICT) (Tape 4)

The Board next considered an item contained in the Memorandum to the Board dated November 22, 1999, requesting authorization for the Fairfax County Redevelopment and Housing Authority to award a contract to Mid Atlantic General Contractor's, Incorporated, in the amount of \$171,930 for the interior and exterior improvements under the Department of Housing and Urban Development, Comprehensive Grant Program at the Park (Project VA-19-06 and VA 07-07).

The staff was directed administratively to proceed as proposed.

ADDITIONAL BOARD MATTERS

19. **GEOGRAPHIC INFORMATION SYSTEMS (GIS) OPEN HOUSE** (Tape 4)

Chairman Hanley said that a round of applause is in order for the County's GIS, Mapping Services, and Land Survey Branch of the Department of Public Works and Environmental Services for its interactive GIS Day on Friday, November 19, 1999. The open house gave everyone an opportunity to meet the hardworking employees who play such an important but not often recognized role in the day-to-day affairs and to see the technology associated with modern mapping. She expressed thanks to everyone who made this informative day possible.

20. FAIRFAX COUNTY FIREFIGHERS COMPETE IN FIREFIGHTING SKILLS COMPETITIONS (Tape 4)

Chairman Hanley said that November has been a very good month for members of the Fairfax County Fire and Rescue Department competing in various firefighting skills competitions. On Saturday, November 6, 1999, Fairfax County took home the coveted Metro Cup at the Third Annual Fire Department Rodeo, beating out teams from the City of Alexandria, Prince Georges, Montgomery, and Arlington Counties.

Earlier this month several members of the Fairfax County Fire and Rescue Department participated in the eighth Annual World Firefighter Combat Challenge. The challenge involved close to one hundred teams of firefighters representing fire departments from the United States (US) and Canada. Chairman Hanley said the Fairfax County team finished ninth in the World, and sixth among US, and that Sam Gray finished tenth overall in the individual competition, in a field of more than 500 competitors.

Therefore, Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and moved that the Board direct staff to:

- Prepare certificates recognizing the outstanding achievements of the Fairfax County Firefighter Combat Challenge Team and the Fire Department Rodeo Team.
- Invite the appropriate individuals to appear before the Board on December 6, 1999.
- Invite the Urban Search and Rescue Team to appear before the Board on December 6, 1999.
- Schedule the December 6, 1999, Board meeting to begin at 8:30 a.m.

Supervisor Gross seconded the motion.

Following discussion, Supervisor Bulova asked to amend the motion to schedule the Board meeting on December 6, 1999, at 9 a.m., and this was accepted.

The question was called on the motion, which carried by unanimous vote.

21. **<u>QUARTERLY REPORT OF THE AUDIT COMMITTEE</u>** (Tape 4)

Chairman Hanley called the Board's attention to the quarterly report of the Audit Committee and reminded Board Members that an Audit Committee meeting will be held on November 30, 1999.

22. **LETTER FROM THE BUREAU OF THE CENSUS** (Tape 4)

Chairman Hanley circulated copies of a letter she had received from the Bureau of Census regarding the Census 2000 special place address list and asked unanimous consent that the Board refer this letter to staff. Without objection, it was so ordered.

23. **LETTER REGARDING FIRE INSPECTION REVIEWS** (Tape 4)

Chairman Hanley referred to a copy of a letter she had received from Patrick Dean, Executive Director, Associated Builders and Contractors, regarding fire inspection review in connection with the development process in Fairfax County.

Following discussion, with input from Robert J. O'Neill, Jr., County Executive, Chairman Hanley asked unanimous consent that the Board direct staff to provide an update on this issue. Without objection, it was so ordered.

Supervisor McConnell asked unanimous consent that the Board direct staff to determine ways to streamline the entire fire inspection review process. Without objection, it was so ordered.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

24. FAIRFAX COUNTY URBAN SEARCH AND RESCUE TEAM DEMONSTRATION (Tape 4)

(NOTE: Earlier in the meeting, Chairman Hanley announced that the Search and Rescue Team would appear before the Board on December 6, 1999. See Clerk's Summary Item CL#20.)

Supervisor Hyland said that Fairfax County has one of the two elite Urban Search and Rescue Teams in the United States. In the last ten years they have assisted search and rescue teams in Russia, the Philippines, and Oklahoma City. In the last three years they have traveled to Georgia, Kenya, Columbia, Turkey, Taiwan and back to Turkey. He said that their skills and compassion are beyond anything imaginable; they smell death, and yet they still go searching under very dangerous circumstances. They succeed in locating victims even while earthquake after shocks are occurring. The task is always the same: daunting, risky, sad, and joyous. The Fairfax County Urban Search and Rescue Team is remarkably well trained and is willing to demonstrate to the general public what is typically done in a search and rescue mission.

Therefore, Supervisor Hyland asked unanimous consent that the Board direct staff to invite the Urban Search and Rescue Team to demonstrate a search and rescue mission during the *Celebrate Fairfax* event and at the *Fall Festival* in 2000. Without objection, it was so ordered.

26. **<u>GARDENER'S HOLIDAY</u>** (Tape 5)

Supervisor Gross invited Board Members and those interested individuals to the reception for Gardener's Holiday to be held on Saturday, December 4, 1999, from 6 until 8 p.m. at Green Spring Gardens Park. She said that it would be an evening of music, gardening displays and art.

27. <u>MCLEAN MUSTANGS</u> (Tape 5)

Supervisor Mendelsohn said that the McLean Mustangs, a County Youth Football League, sent an unprecedented three teams to the County Championship games on Saturday, November 13, 1999. Two of those teams, the 110-pound team and the 125-pound team, won the Central Division County Championship in their respective weight classes. A third team, the 95-pound team, boasted an undefeated regular season record, but lost in the championship game.

Supervisor Mendelsohn moved that the Board direct staff to invite the members of the 110-pound team, the 125-pound team and their coaches to the Board meeting scheduled for December 6, 1999, to receive the Board's recognition and congratulations. Chairman Hanley seconded the motion and it carried by unanimous vote.

28. <u>LEE DORSON PUBLIC SERVICE AND CITIZENSHIP AWARDS</u> (Tape 5)

Supervisor Kauffman announced that the following Lee Dorson Public Service and Citizenship Awards would be presented at the Lee District Holiday Banquet on December 8, 1999, at the Springfield Hilton:

- Distinguished Public Service Leadership Award to David P. Bobzien, County Attorney, for his steady and supportive interpretation of land use and zoning laws for Fairfax County and Lee District, as well as his citizen service to the County as Centreville District Planning Commissioner and Chairman of the 1987 County Goals Commission.
- Distinguished Public Service Professional Award to Ms. Marianne Gardner of the Department of Planning and Zoning, who served as Staff Coordinator for the Area Plan Review Process

and the rigorous Richmond Highway Special Study over the past three years.

• Lee District Citizenship Award to Mr. Jack Kelso for his faithful service with Lee Mount Vernon Chamber of Commerce, the Southeast Fairfax Development Corporation, and as Lee District Representative to the Planning Commission.

29. **LEAF COLLECTION** (Tape 5)

Supervisor Connolly stated that as the construction season nears its end, contractors working for the Virginia Department of Transportation (VDOT) are finishing repaving work on neighborhood streets throughout Fairfax County. This work coincides with the fall leaf collection provided by Fairfax County.

Therefore, Supervisor Connolly asked unanimous consent that the Board direct staff to work with VDOT to better coordinate VDOT's paving activities and the County's leaf collection. Without objection, it was so ordered.

30. FAIRFAX COUNTY PUBLIC SCHOOLS STUDENTS SELECTED IN NATIONAL HISPANIC SCHOLAR RECOGNITION PROGRAM (Tape 5)

Supervisor Connolly announced that 28 Fairfax County Public School students have been selected in the 2000 National Hispanic Scholar Recognition Program, which recognizes academically outstanding Hispanic students as part of the effort to encourage colleges and universities to recruit them and provide them with financial support. REQUEST FOR CONCURRENT PROCESSING AND PUBLIC HEARINGDATE FOR A&R GENERAL PARTNERSHIP; AUSTIN-WESTONCENTER - PROFFERED CONDITION AMENDMENT APPLICATIONPCA 82-P-084-1 (Tape 5)

Supervisor Connolly said that A&R General Partnership filed Proffered Condition Amendment Application PCA 82-P-084-1 to permit construction of a building addition to an existing medical office building. The .65 acre subject site is located on Old Meadow Road in Tysons and is currently developed with a 5,334 square foot single story medical office building and an accessory trailer for additional storage.

Supervisor Connolly moved that the Board direct the:

- County Executive to schedule a public hearing to be held before the Board on <u>February 7, 2000, at 4:30 p.m.</u>
- Director of the Department of Public Works and Environmental Services to concurrently process the site plans with the building plans and permits for the A&R General Partnership, Proffered Condition Amendment Application PCA 82-P-084-1.

This action does not prejudice the consideration of this review in any way. Supervisor Hyland seconded the motion and it carried by unanimous vote.

32. <u>CENTREVILLE HIGH SCHOOL WINS REGIONAL FOOTBALL</u> <u>CHAMPIONSHIP</u> (Tape 6)

Supervisor Frey announced that Centreville High School defeated Lake Braddock Secondary School by a score of 21-17 to win the Northern Region Championship. As a result of a wager on this game, Supervisor Bulova would be treating Supervisor Frey to lunch.

33. **LIFESAVING ACT AT TERRASET ELEMENTARY SCHOOL** (Tape 6)

Supervisor Dix reported on a recent lifesaving action by two teachers and the clinic nurse at Terraset Elementary School. Ms. Ellen Lopez, a substitute teacher, had collapsed and was unconscious when clinic nurse Gladelle Hardenbergh and teachers Ms. Cheryl Reames and Ms. Marylou Sybert responded to the emergency situation and began CPR. Because of their efforts, Ms. Lopez was revived prior to the arrival of paramedics and, following several subsequent surgeries, she has recovered.

Because of this heroic act, Supervisor Dix asked unanimous consent that the Board direct staff to:

- Invite Ms. Hardenbergh, Ms. Reames, Ms. Sybert, and representatives of Terraset Elementary School to appear before the Board on December 6, 1999.
- Prepare an appropriate Certificate of Appreciation.

Without objection, it was so ordered.

34. **TASK FORCE ON REGIONAL WATER SUPPLY ISSUES** (Tape 6)

Supervisor Dix stated that he and Supervisor Gross served on the Council of Governments (COG) Task Force on Regional Water Supply Issues. He said that the COG Board of Directors recently adopted a resolution that supports recommendations from the task force. He, along with the director of environmental programs in Montgomery County, Maryland, authored a set of recommendations on a region-wide approach on how to notify the public and how area local governments should proceed should another water situation similar to the one experienced this past summer occur again. He asked unanimous consent that the Board direct staff to share this information with the Board.

Supervisor Dix also acknowledged and expressed appreciation to the Water Authority for its leadership and planning. He noted that the County's water supply was never at risk this past summer and could always meet the demand.

Without objection, the request was so ordered.

A brief discussion ensued.

35. **<u>RESTON 2000 TASK FORCE</u>** (Tape 6)

Supervisor Dix reported that the Reston 2000 Task Force has now completed its mission. This citizen task force sought and received community input to determine the desired future of the community.

Supervisor Dix asked unanimous consent that the Board direct staff to invite the chairman, the two co-chairs, and the chairman of each of the respective seven committees to appear before the Board on December 6, 1999, to be recognized for their extraordinary effort over the past two years. He also stated that he would share a copy of the report with Members of the Board. Without objection, it was so ordered.

36. <u>CATS</u> (Tape 6)

(NOTE: Earlier in the meeting, Supervisor Gross presented a Board Matter regarding feral cats. See Clerk's Summary Item CL#25.)

With tongue-in-cheek, and with a reference to a Board Matter on feral cats, Supervisor McConnell sent out a message to her cats Puffy, Squeaker, Flippin, Dusty, and Pixie that they will not be arrested for going out in the yard.

37. <u>SCHOOL STREET AREA OUT-OF-TURN PLAN AMENDMENT</u> (Tape 6)

Supervisor Bulova stated that for several years representatives of the County, Schools, City of Fairfax, and George Mason University (GMU) have been working together to shape the redevelopment of the School Street area. This area is located east of Route 123 between the city and GMU and includes the Eleven Oaks School, which is used for administrative offices and school bus parking.

Supervisor Bulova said that in 1997, the Board approved a Comprehensive Plan amendment that incorporated a redevelopment option into the Plan. This option allows for the consideration of mixed-use development to include residential use at 12-16 dwellings units per acre (du/ac) and a hotel and conference center with support retail use if the entire area, including the school site, is consolidated for redevelopment. To date, efforts at finding an alternative school bus parking area and consolidating the school property have been unsuccessful.

To provide incentives for less than full consolidation of the parcels, Supervisor Bulova moved that the Board authorize an Out-of-Turn Plan Amendment for the area east of Route 123 between the City of Fairfax and GMU. She said that this proposed amendment should consider restoring the option for residential use at 8-12 du/ac with conditions related to parcel consolidation, transportation access, and urban design. This option would be in addition to the mixed-use and higher density residential options that are available with the full consolidation of the area. Supervisor McConnell seconded the motion.

Following discussion, Supervisor Connolly asked unanimous consent that the Board direct staff to add discussion of the Krasnow property to the agenda of the next City/County Committee meeting. Without objection, it was so ordered.

The question was called on the motion, which carried by unanimous vote.

38. LAKE BRADDOCK SECONDARY SCHOOL FOOTBALL COACH TO <u>RETIRE</u> (Tape 6)

Supervisor Bulova announced that Francis Dall, football coach at Lake Braddock Secondary School will be retiring after 11 years. She asked unanimous consent that the Board direct staff to invite Mr. Dall to appear before the Board to be thanked and recognized for his years of service. Without objection, it was so ordered.

Supervisor Frey announced that Mr. Dall, while retiring as coach, will be the athletic director at the new high school in Sully District.

39. FURTHER DISCUSSION OF THE STARTING TIME FOR THE DECEMBER 6, 1999, BOARD MEETING (Tape 6)

(NOTE: Earlier in the meeting, the Board set the starting time for the December 6, 1999, Board meeting for 9 a.m. See Clerk's Summary Item CL#20.)

Following discussion regarding the early start time for the December 6, 1999, Board meeting, with input from Catherine A. Chianese, Assistant to the County Executive, Chairman Hanley took a straw poll for a preference between 8:30 and 9 a.m. Following the results, she announced that the meeting would begin at **9 a.m.** as previously announced.

At 12:50 p.m., Supervisor Connolly moved that the Board recess and go into closed session for discussion and consideration of matters enumerated in *Virginia Code* Section 2.1-344 and listed in the agenda for this meeting and in addition:

Supervisor Hyland seconded the motion.

Following discussion, with input from David P. Bobzien, County Attorney, Chairman Hanley announced that should the motion carry, the Board would convene closed session at 2:15 p.m.

The question was called on the motion, which carried by unanimous vote.

Mittereder, Legislative Liaison, Chairman Hanley closed the public hearing, but noted that the record would remain open for the submission of written testimony on the Proposed Legislative Program that the County will present to the 2000 Virginia General Assembly. Board adoption is scheduled for December 6, 1999.

Supervisor Connolly announced that the proposed Legislative Committee meeting scheduled for November 29, 1999, would be cancelled.
