#### **WELCOME AND CALL TO ORDER:**

Co-Chair Kerrie Wilson called the meeting to order at 9:38 AM and reviewed the AHAC meeting agenda.

#### **REMOTE PARTICIPATION POLICY:**

Kerrie Wilson read the electronic remote participation policy script to identify and confirm AHAC members participating remotely could be heard and were allowed to participate. David Levine and Mary Paden participated remotely for medical reasons.

#### **VFOIA DISCUSSION AND QUESTIONS:**

Kerrie Wilson confirmed everyone watched the VFOIA video and asked if the AHAC members had questions for Cynthia Bailey from Fairfax County's Office of the County Attorney. There were no questions for Cynthia Bailey.

#### **EQUITY PRESENTATION AND DISCUSSION:**

Karla Bruce, Fairfax County's Chief Equity Officer made presentation about equity covering the following topic areas:

- Chairman's Equity Task Force
- Historical roots of inequities and inequity in Fairfax County
- One Fairfax data group and indicators
- Inclusive Community Engagement Framework

#### INTEGRATING EQUITY INTO AHAC'S WORK:

Judith Cabelli presented Fairfax County's Department of Housing and Community Development's 2021 Equity Impact Plan Goals to AHAC as background information before AHAC's equity discussion. Kerrie Wilson thanked Karla Bruce for her presentation and asked AHAC to think about her presentation when developing policy and looking at the affordable housing dashboard.

Next, Kerrie Wilson asked Tom Fleetwood if he would like to make any remarks before the equity discussion began. Tom Fleetwood touched on equity in terms of access to affordable housing, the cost of developing land in different parts of the County, and ensuring the availability of resources and policies to put people in a community of opportunity. Next, AHAC members engaged in a discussion about integrating equity into AHAC's core work areas: budget, legislation, preservation and production. The AHAC members provided their comments, concerns, and questions on equity in the context of those topic areas. They also discussed equity in relation to affordable housing, homelessness, neighborhood communities, faith-based communities, funding, planning/zoning, manufactured homes, and partnerships with businesses and corporations. Karla Bruce closed out the discussion by offering any support when integrating equity into the work of AHAC.



#### **OTHER BUSINESS:**

Kerrie Wilson proposed to use AHAC's January 7 meeting as a workgroup session. She suggested creating AHAC subcommittee's which AHAC members would lead.
