The Fairfax County Consolidated Community Funding Advisory Committee (CCFAC) is interested in hearing from ALL residents, including those who need, or are receiving, affordable housing or other human services assistance; and from local community and faith-based organizations, and private enterprises that provide direct services to or advocate for County residents.

This public hearing is being held to receive public comment and input as the County is developing its HOME Investment Partnerships Program (HOME)-American Rescue Plan (ARP) allocation plan that it will be submitting to the U.S. Department of Housing and Urban Development (HUD).

Fairfax County received an award of \$7.88 million in HOME-ARP funding from HUD to address homelessness assistance and supportive services. Funds may be used for 1) development and support of affordable housing, 2) tenant-based rental assistance, 3) provision of supportive services, and 4) acquisition and development of non-congregate shelter units.

Qualifying populations to be served under HOME-ARP are: 1) Homeless; 2) At risk of homelessness; 3) Those fleeing, or attempting to flee, domestic violence, dating violence, sexual assault, stalking, or human trafficking; and 4) Other families requiring services or housing assistance to prevent homelessness, or Households at greatest risk of housing instability

After engaging in a consultation process required by HUD, the following allocations are proposed:
