What is ITPAC?

- In February 1997, the Fairfax County Board of Supervisors established the Information Technology Policy Advisory Committee (ITPAC). This Committee reflects the Board's commitment to ensure that the County government keeps pace with appropriate emerging trends in information technology
- ITPAC is an advisory public body whose purpose is to provide input to the County that is based on the experience and expertise of ITPAC members on information technology trends and strategies. Recommendations shall evaluate opportunities, benefits, and the challenges of technological innovation and seek to achieve benefits for County government
- ITPAC advises the Board, the Chief Technology Officer (CTO)/Director of DIT, and key IT staff on emerging information technology trends and on the application of those technology changes in information technology to government services, policies, and procedures
- ITPAC reviews the strategy and framework of the County's technology program and provides counsel to the County government concerning opportunities and/or risks in the field of information technology

Who is ITPAC?

- ITPAC members are private citizens who have experience in information technology and who hold no paid office or employment with Fairfax County Government or any entity that receives funding directly from the County
- The Committee is made up of 15 members, including one member nominated by each member of the ten members of the Board of Supervisors, one member nominated by the Fairfax County School Board, one member nominated by the Fairfax County Chamber of Commerce, one member nominated by the Fairfax County Federation of Civic Associations, one member nominated by the League of Women Voters of Fairfax, and one member nominated by the Northern Virginia Technology Council
