SUBJECT: Amendments to Virginia Erosion and Sediment Control Law Effective July 1, 2001

Revisions to the Virginia Erosion and Sediment Control Law require, as a prerequisite to the approval of an erosion and sediment control plan, that the person responsible for carrying out the plan (owner/developer/permittee) shall provide to the plan approving authority the name of an individual holding a certificate of competence issued by the Department of Conservation and Recreation (DCR) who will be responsible for carrying out the land disturbing activity. This information must be kept current for the life of the plan. Plans approved prior to July 1, 2001, are not subject to these requirements.

Individuals holding Virginia Professional Engineer Licenses, Virginia Land Surveyor Licenses, Virginia Landscape Architect Licenses, Virginia Architect Licenses, Combined Administrator Certification, Administrator Certification, Plan Reviewer Certification, Inspector Certification, and Contractor Certification are qualified as Responsible Land Disturbers without further certification. DCR is developing a program that will provide learning materials and examination opportunities to obtain a Responsible Land Disturber Certificate. This new certification program is expected to be available via website learning and examination and through conventional learning and examination by the end of June. Effective July 1, 2001, the name of the individual holding a Responsible Land Disturber Certificate or qualified professional as noted above, who will be responsible for carrying out the land disturbing activity, must be provided prior to plan approval for the following types of plans:

Please take special note that lot grading plans in bonded subdivisions are not covered by the associated subdivision construction plan and must separately demonstrate compliance with the new requirements.

The owner/developer/permittee shall submit a copy of the attached form to the Plan Control Counter for the Office of Site Development Services (OSDS) prior to plan approval and whenever the individual responsible for carrying out the land disturbing activity changes during the life of the approved plan.

RESPONSIBLE LAND DISTURBER CERTIFICATION Effective July 1, 2001

Amendments to the Virginia Erosion and Sediment Control Law, §§ 10.1-563 and §§ 10.1-566 of the Code of Virginia

Revisions to the Virginia Erosion and Sediment Control Law require, as a prerequisite to the approval of an erosion and sediment control plan, that the person responsible for carrying out the plan (owner/developer/permittee) shall provide to the plan approving authority the name of an individual holding a certificate of competence (Virginia Professional Engineer, Virginia Land Surveyor, Virginia Landscape Architect, Virginia Architect, Combined Erosion and Sediment Control Administrator, Erosion and Sediment Control Plan Reviewer, Erosion and Sediment Control Inspector, Erosion and Sediment Control Contractor, Responsible Land Disturber) issued by the Department of Conservation and Recreation (DCR) who will be responsible for carrying out the land disturbing activity. Please note that a contractor's business license issued by the State or County does not satisfy the requirement for certification from DCR; a special exam on the principles and practices of erosion and sediment control is required to obtain this certification.

This information must be kept current for the life of the plan. Plans approved prior to July 1, 2001 are not subject to this requirement. The requirement is applicable to the following plan types:
