#### **Approval of the Minutes**

#### **Presentation**

Nicole Wynands, Fairfax County Department of Transportation, presented the proposed Active Fairfax Plan. This presentation will be presented to the Fairfax County Planning Commission Transportation Committee. The plan will bring together a number of currently separate plans and also will include new information.

#### Staff report

*I-495 NEXT project* – there is a stakeholder group that is meeting regularly to discuss this project. However, the FCDOT Pedestrian and Bicycle staff are not attending these meetings. There was a general discussion of this issue. FCDOT staff will present an update on the project at the December 2019 FCTSB Committee meeting.

*McLean Task Force* – staff has met with the task force about bicycle issues and planning for the revised McLean plan. There was a discussion of the need to include adequate bicycle facilities in this plan.

Alternative trail surfaces – staff is working with the FCDOT Planning Department to consider and evaluate alternative types of trail surfaces that could be used in the future.

### **Other Business**

Potomac Heritage National Scenic Trail – PHNST representatives were invited to discuss two current gaps in this trail in Fairfax County in the Lorton area and in the McLean area. The representatives showed several possible ways and routes to fill these gaps. Committee Member Jim Klein pointed out that the PHNST is part of the East Coast Greenway trail. He will work with the FC Park Authority to appropriate signage related to the Greenway trail and the PHNST.
