- Two Way Left Turn lane in center median.
- Major Utility Poles with dual Dominion circuits on South side.








# **Existing Conditions**

• Westgate **Elementary School** students pick-up queuing lanes are located along WB Magarity Road shoulder, and EB left turn lane.








#### Project Limits - Ware Road to Peabody Drive

 2500' - 8' wide Asphalt Walkway with grass buffer strip and curb and gutter along South side of Magarity Road.

#### Ware Road to Tremayne Place Crosswalks

- New unsignalized Crosswalks at Ware Road, Cherri Drive, and Tremayne Place
- Relocate Holly Ridge and Griffith Road Crosswalks
- Pedestrian Refuge Islands at Cherri Dr. & Tremayne Pl.








#### Westgate Elementary School frontage

 Addition of a raised concrete island at the School drop-off / pickup entrance to prohibit exiting left turns








#### Westgate Elementary School frontage

- 8'wide asphalt walkway on north side from School drop-off / pickup entrance to Peabody Drive
- High Visibility Crosswalks & Refuge Island at Peabody Drive









- Preliminary Phase Completed Reviews to Date:
  - FC Public Schools Review and Comment
  - Dranesville and Providence Districts Review and Comment
  - VDOT Preliminary Review and Comment
- Intermediate Design Phase (60% -70% design) To Begin following this Citizens Meeting
  - Estimated Land Acquisition- Spring 2021 thru Fall 2021
  - Construction Early Summer 2022 thru Spring 2023
