Introduction

The Partnership for a Healthier Fairfax (PFHF) is a coalition of community members and organizations that are dedicated to enhancing the local public health system and fostering community well-being since its inception in 2010. Guiding the development of objectives and actions within the Community Health Improvement Plan (CHIP), the Partnership ensures alignment of actions with its overarching vision. Traditionally, the CHIP is crafted every five years; it serves as a roadmap for collaborative endeavors.

The first CHIP covered the years occurring between 2013 – 2018. The current CHIP (CHIP 2.0) was originally developed to cover the 2019-2023 time period. Due to COVID-19 disruptions, the typical five-year cycle was extended to accommodate the exceptional circumstances. CHIP 2.0 now runs for a 6-year cycle through December 31, 2024.

CHIP 2.0 comprises three core priorities, eight goals, 20 objectives, and 69 key actions aimed at addressing identified public health challenges. This annual report specifically focuses on accomplishments during 2023, marking the fifth year of CHIP 2.0 implementation.

Vision

Fairfax – An engaged and empowered community working together to achieve optimal health and well-being for all those who live, work, and play here.

Introduction

CHIP 2.0 (2019 -2024) outlines three priority issues -- Behavioral Health, Healthy Eating and Healthy Environment and Active Living -- alongside their respective goals, objectives, and key actions. Additionally, these Teams have selected population health indicators to serve as long-term measures for assessing progress in their respective areas. Annual reports provide ongoing updates on key actions and population health indicators, tracking progress throughout the implementation phase. This annual report serves as a status update and review of accomplishments for the fifth year of implementation, 2023.

- *Real Food For Real Change Toolkit* was implemented as part of an afterschool program at Lake Braddock Secondary School

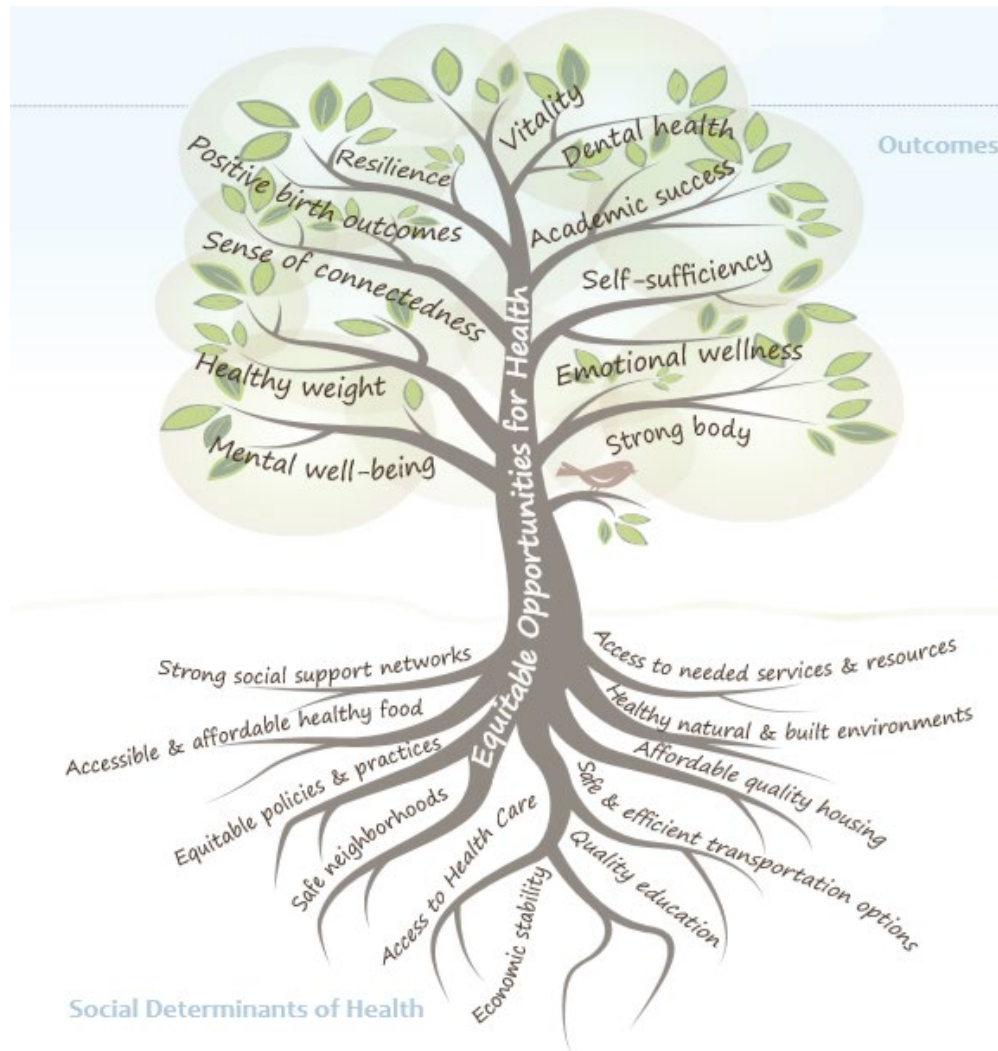
Healthy Environment and Active Living Team

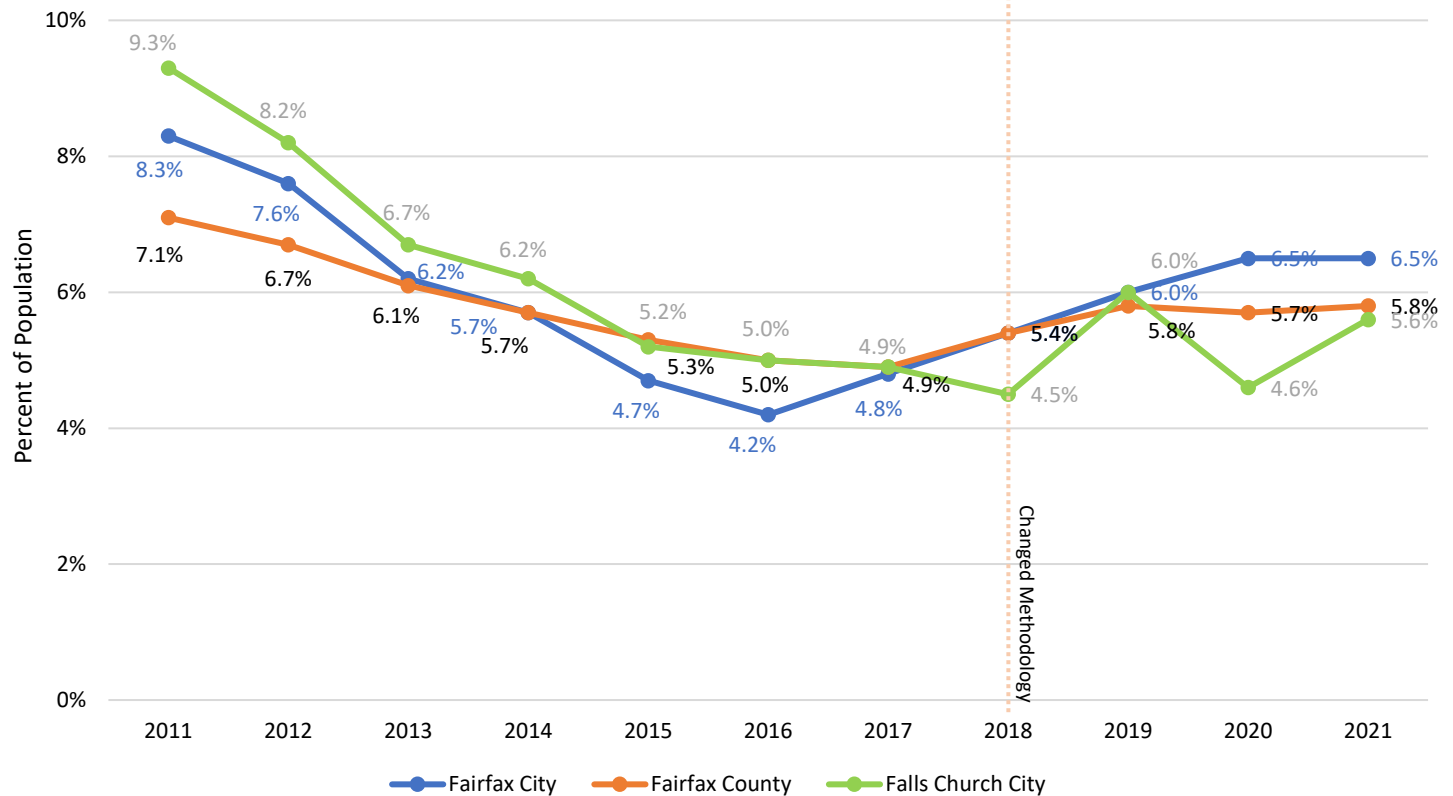

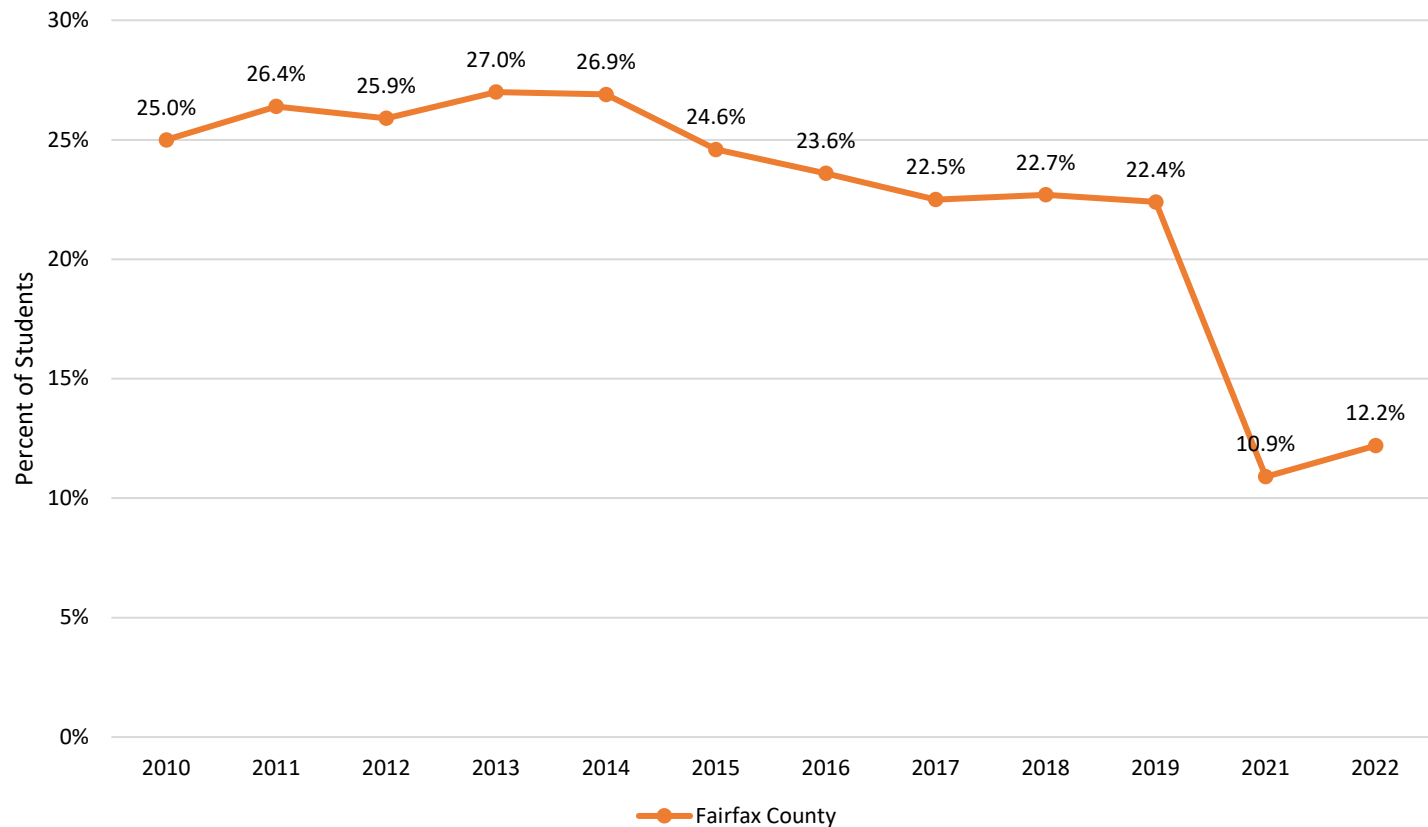
Food Insecurity Rate

Food insecurity is defined as limited or uncertain availability of nutritionally adequate food or the inability to acquire these foods by a socially acceptable manner. This indicator shows the percentage of the population that experienced food insecurity at some point during the year. In 2021, food insecurity in Fairfax City was 6.5%. The percentage of the population that experienced food insecurity in Falls Church City increased to 5.6% and in Fairfax County to 5.8% for the year 2021.



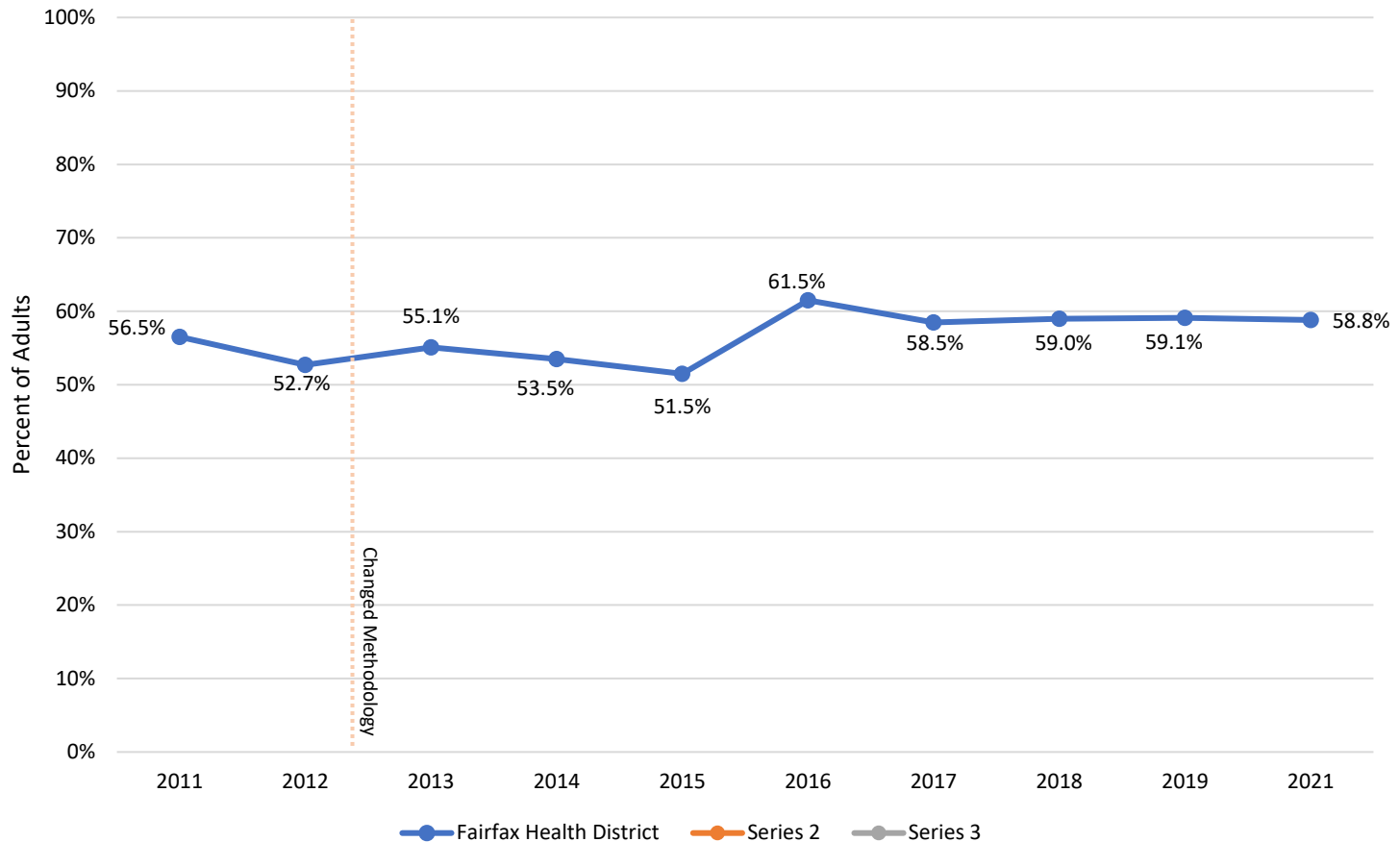
Youth Who Eat 5 Servings of Fruits and Vegetables

This indicator shows the percentage of students in grades 8, 10, and 12 who reported eating fruits (excluding fruit juice) and vegetables at least five times a day. The percentage of students in Fairfax County who reported eating fruits and vegetables at least five times a day dropped from 22.4% (2019) to 12.2% (2022). Data was not available for 2020.



Adults Who are Overweight or Obese

This indicator shows the percentage of adults who are overweight or obese according to the Body Mass Index (BMI). A BMI between 25 and 29.9 is considered overweight and a BMI of 30 or greater is considered obese. Of Fairfax Health District adults, 58.8% had a BMI in the overweight or obese range in 2021, lower than the Virginia average of 68.1% of adults.

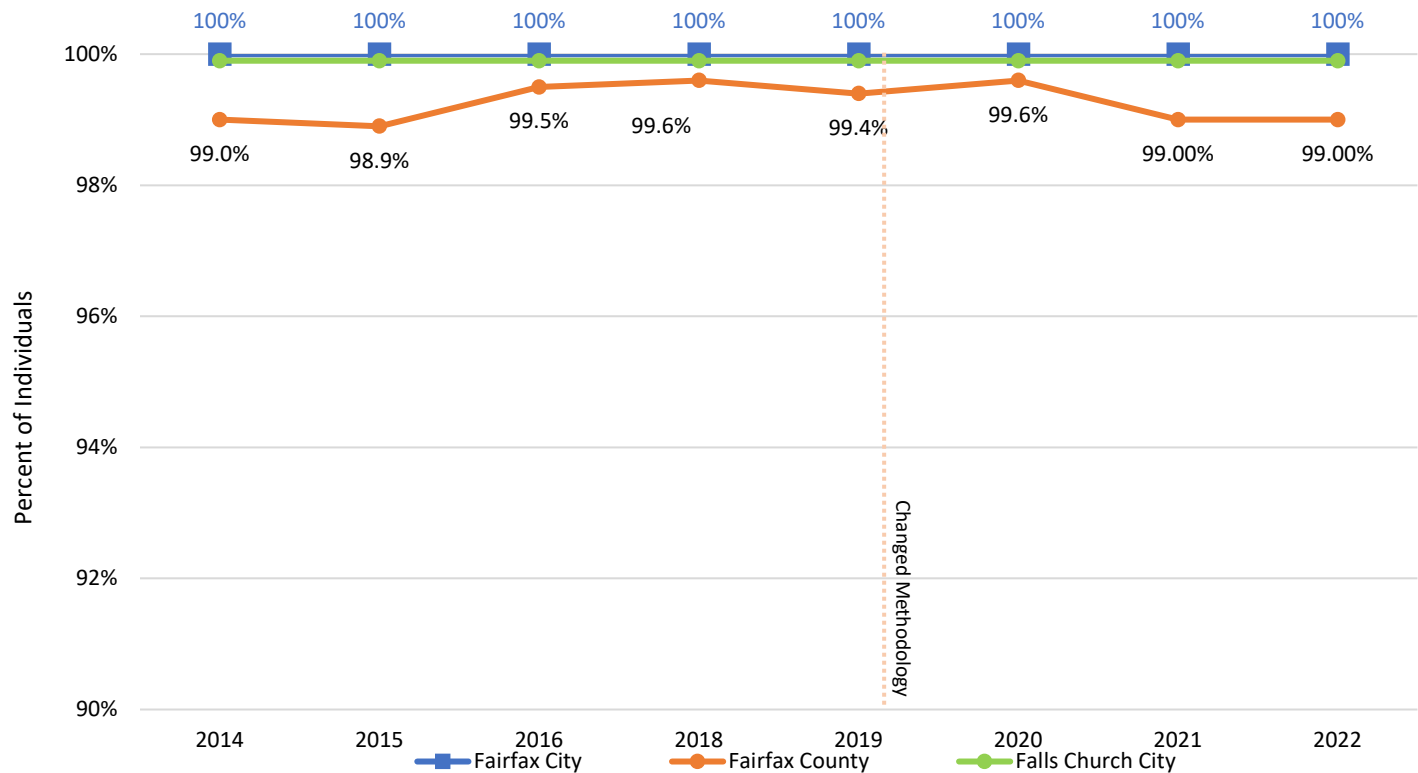

Resident Access to a Park or Recreation Facility

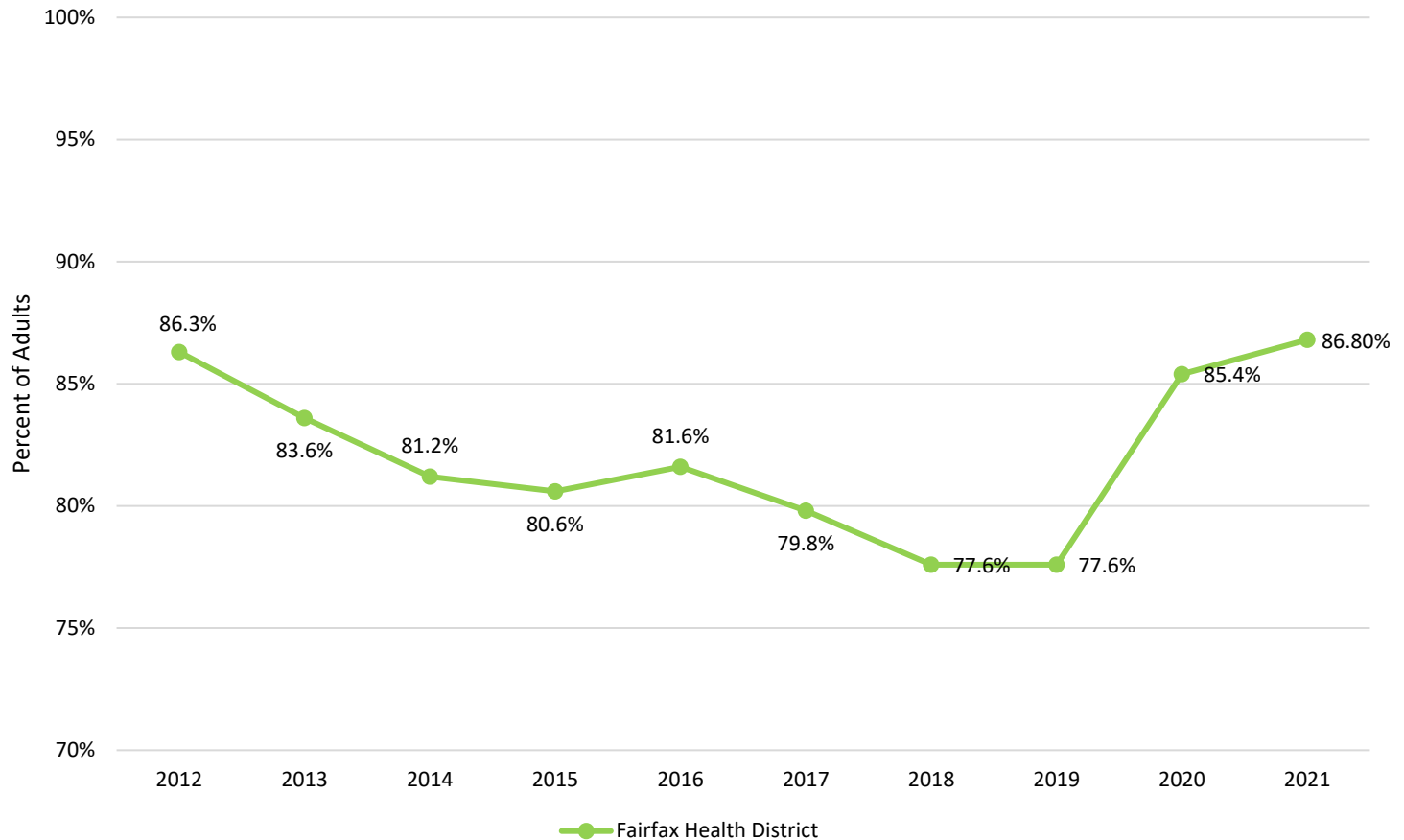

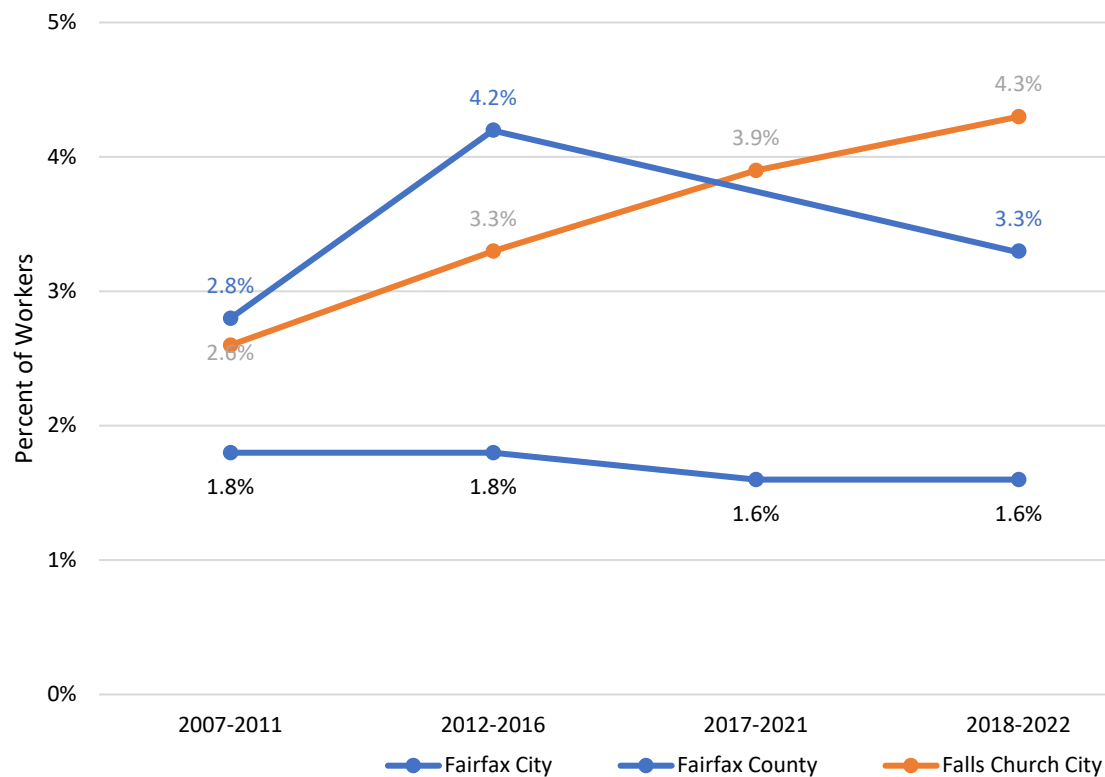
Adults Engaging in Physical Activity

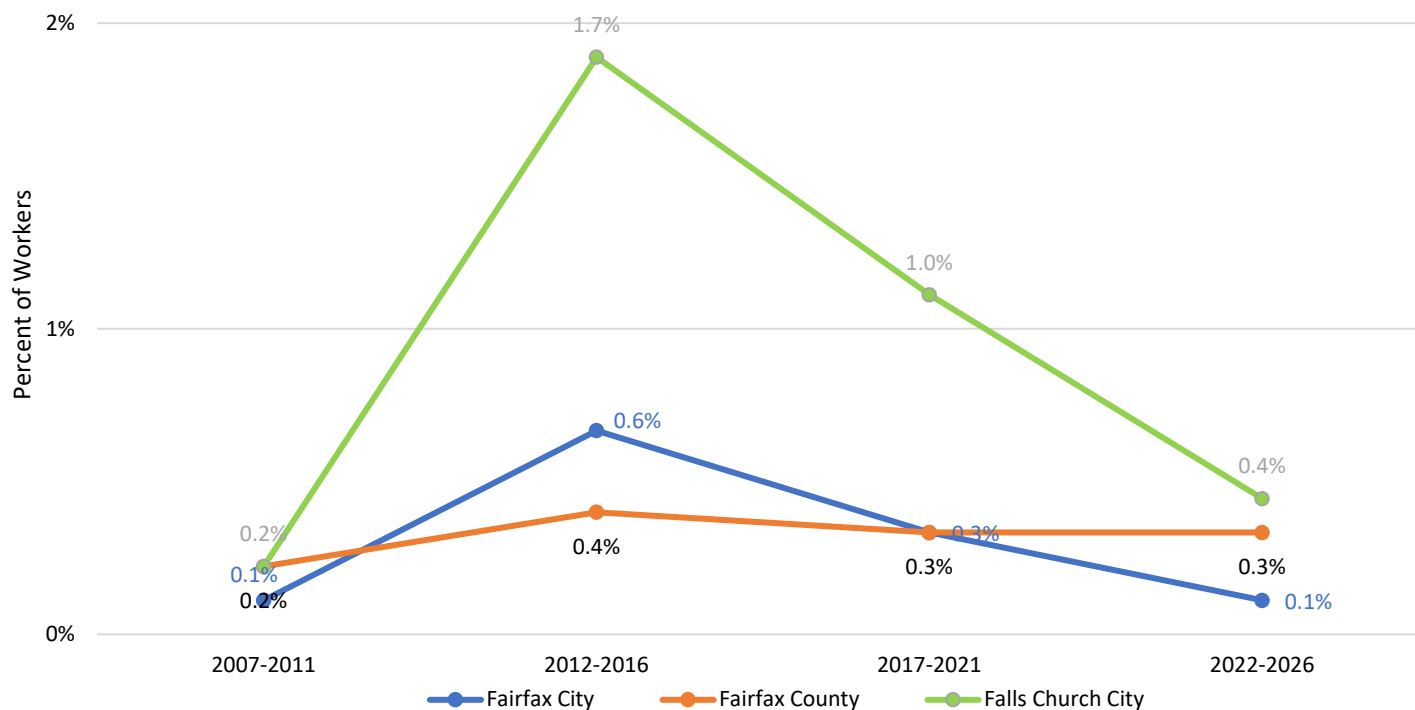
Workers Who Walk to Work

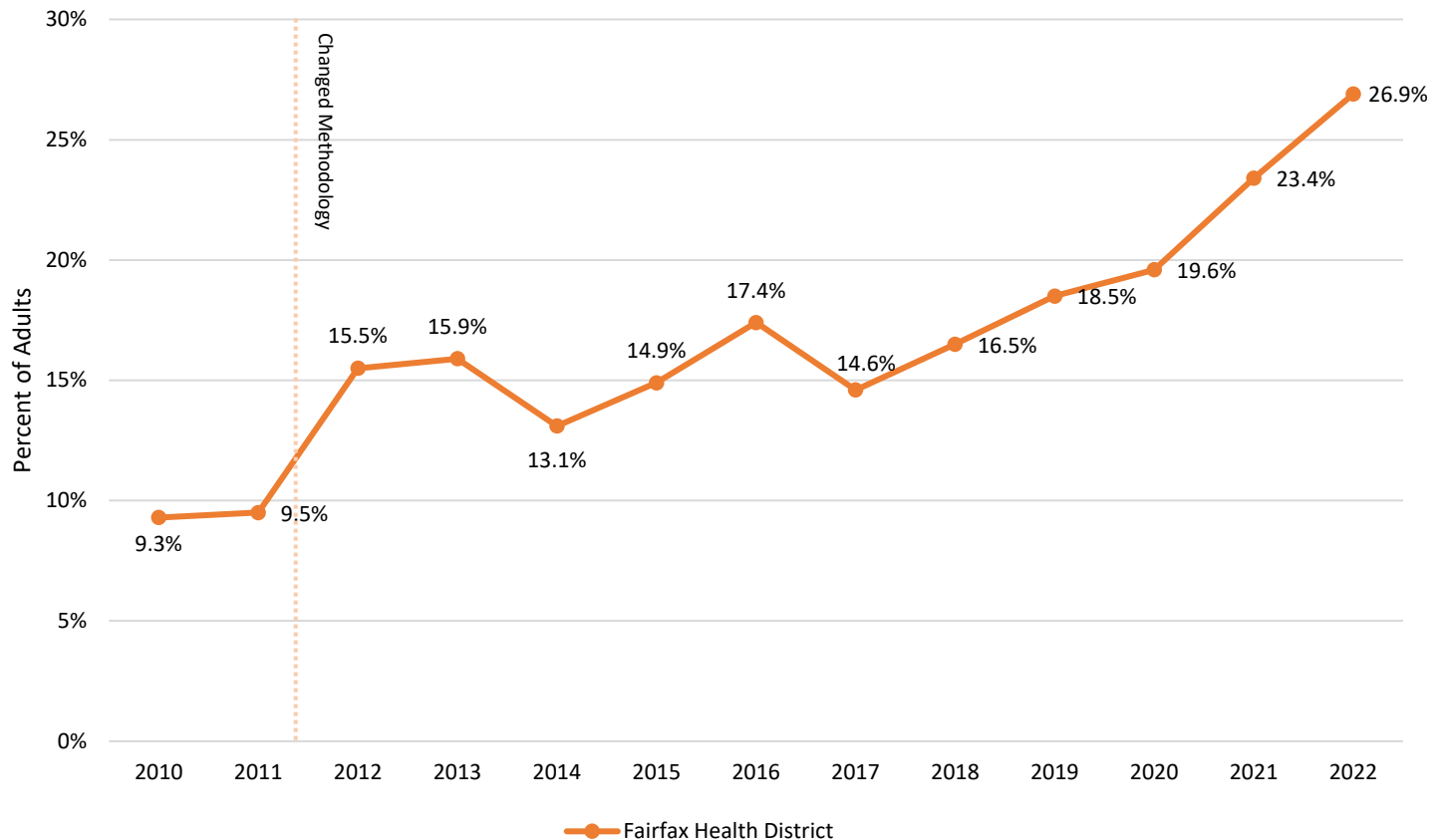

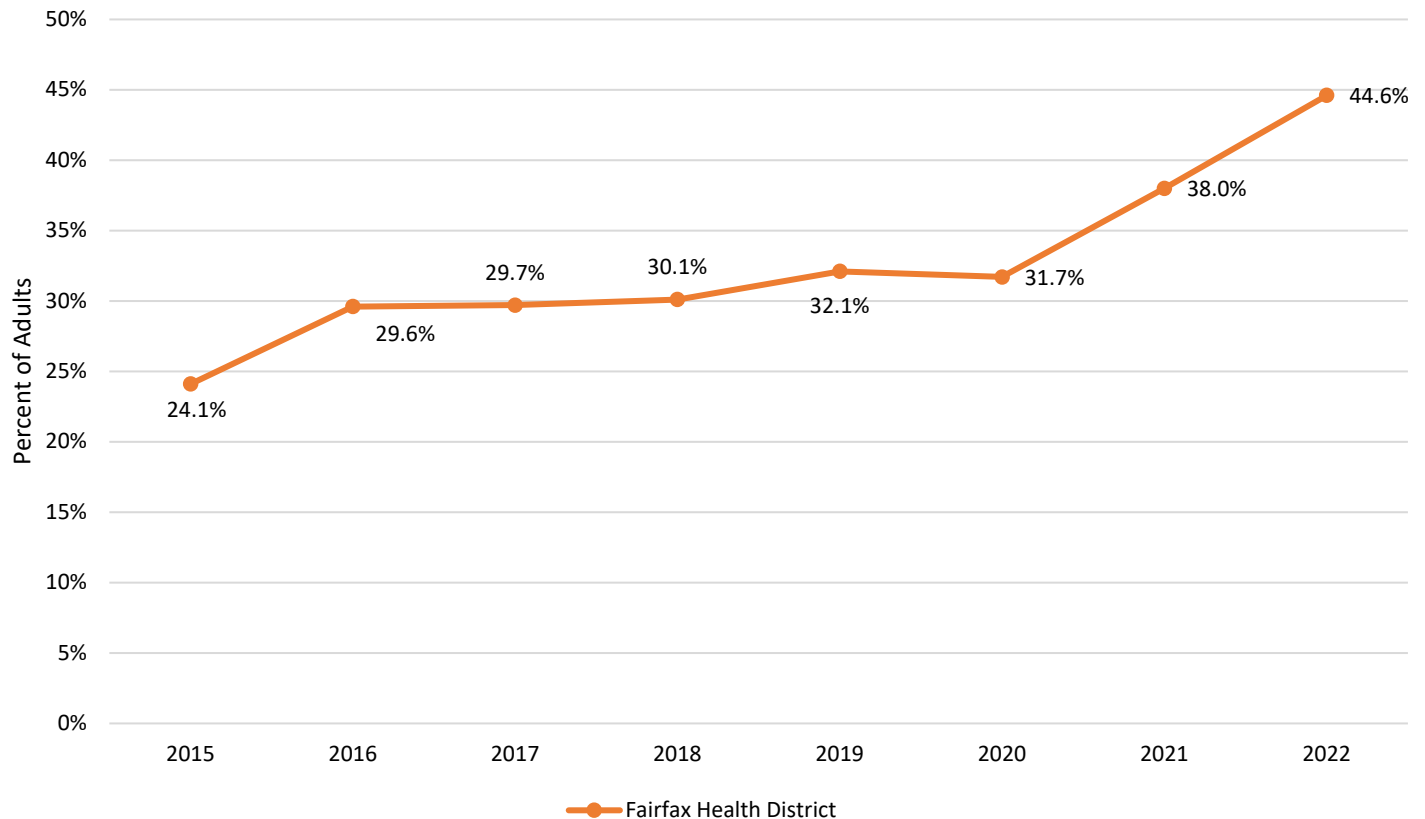
Poor Mental Health: 5+ Days

This indicator measures the percentage of adults who stated that their mental health was not good for five or more days within the past month. In 2022, the percentage of adults who had five or more poor mental health days in the Fairfax Health District was 26.9%, an increase from 23.4% (2021). In Virginia, 29.6% of adults stated that their mental health was not good for 5+ days in the last month.



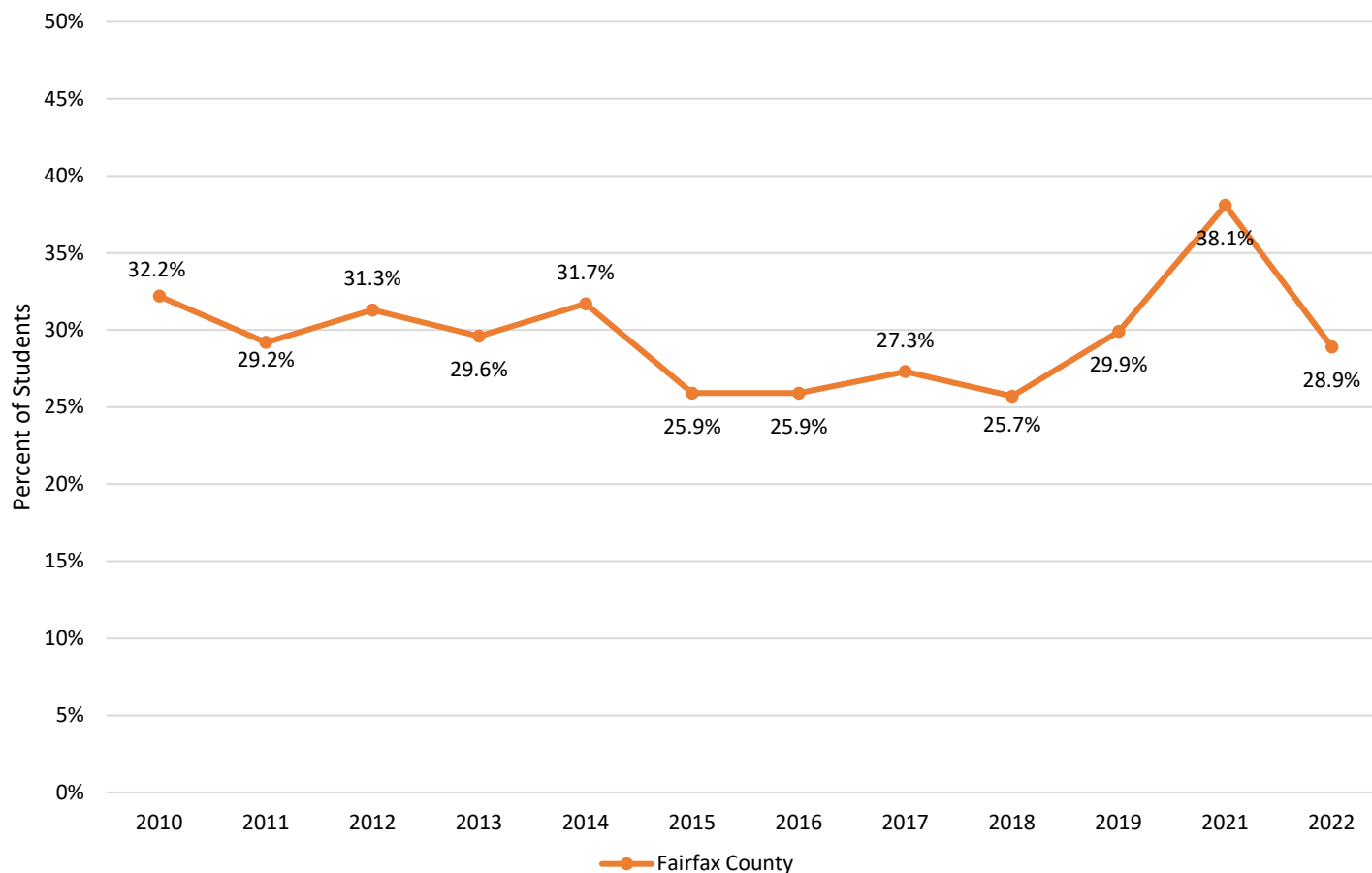
Poor Mental Health: 1+ Day

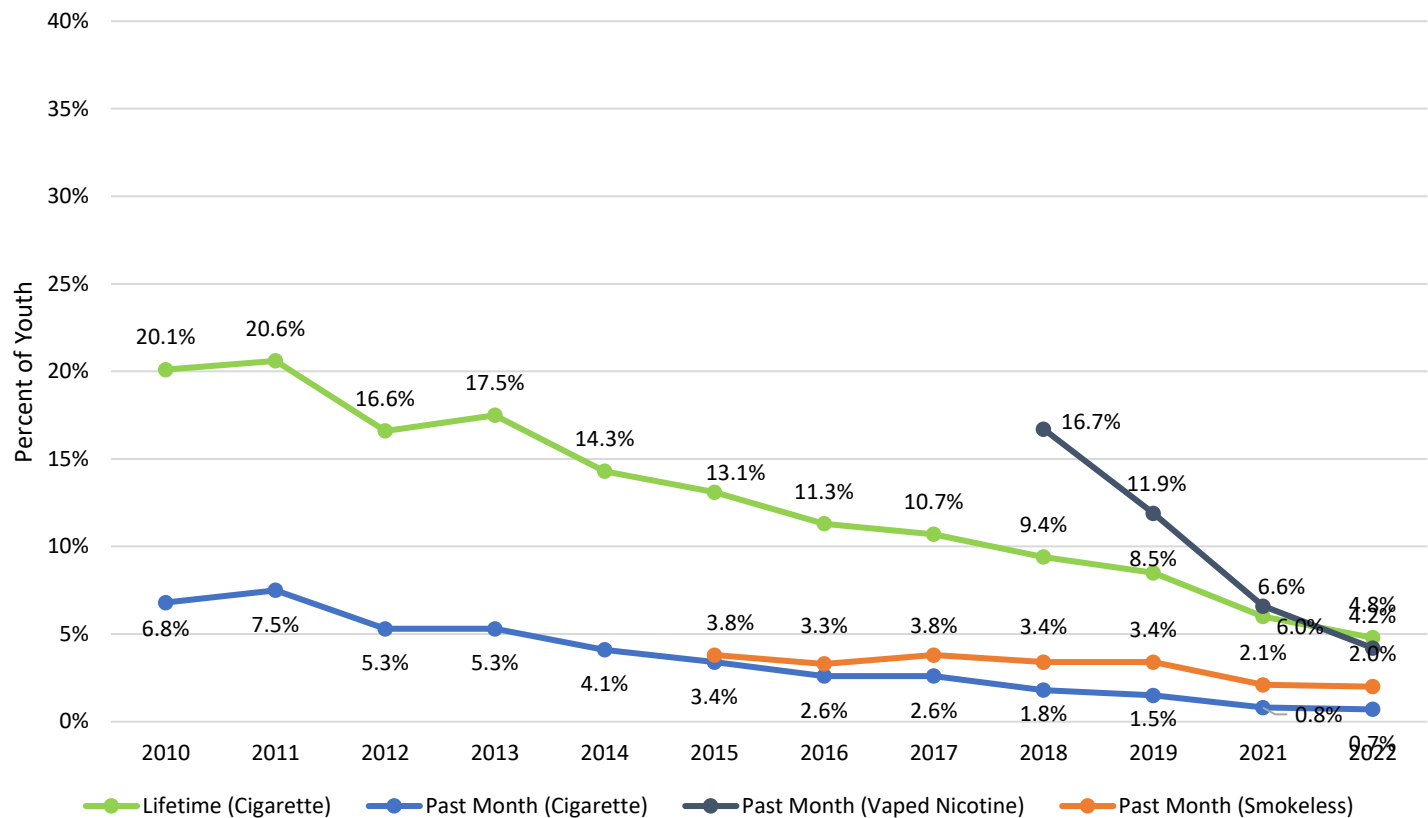
Students Who Feel Sad or Hopeless

Past month cigarette use, past month smokeless tobacco use, and past month vaped nicotine are also shown here. In 2022, lifetime use of cigarettes (4.8%), past month cigarette use (0.7%), past month smokeless tobacco use (2.0%), and past month vaping of nicotine (4.2%) all decreased for Fairfax County students in 8th, 10th, and 12th grades.

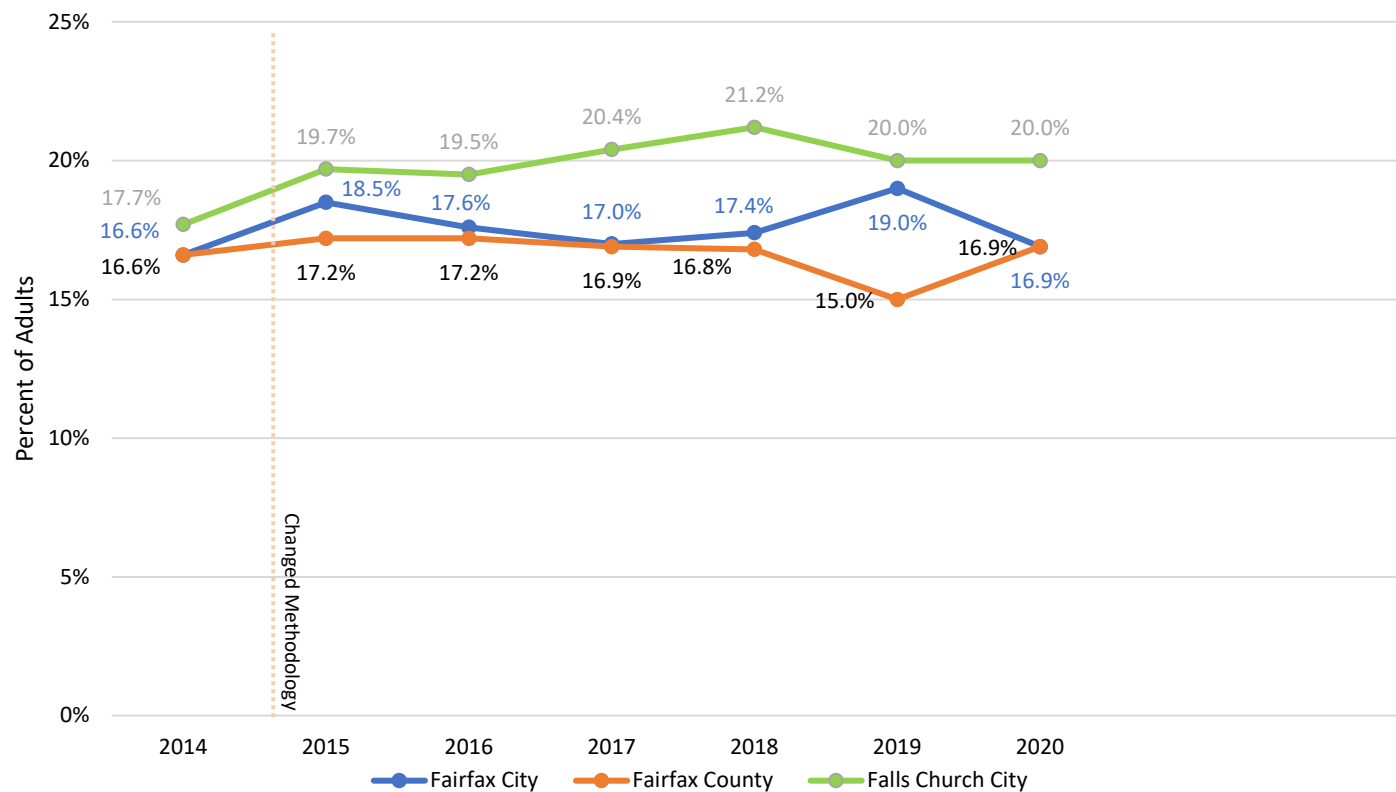

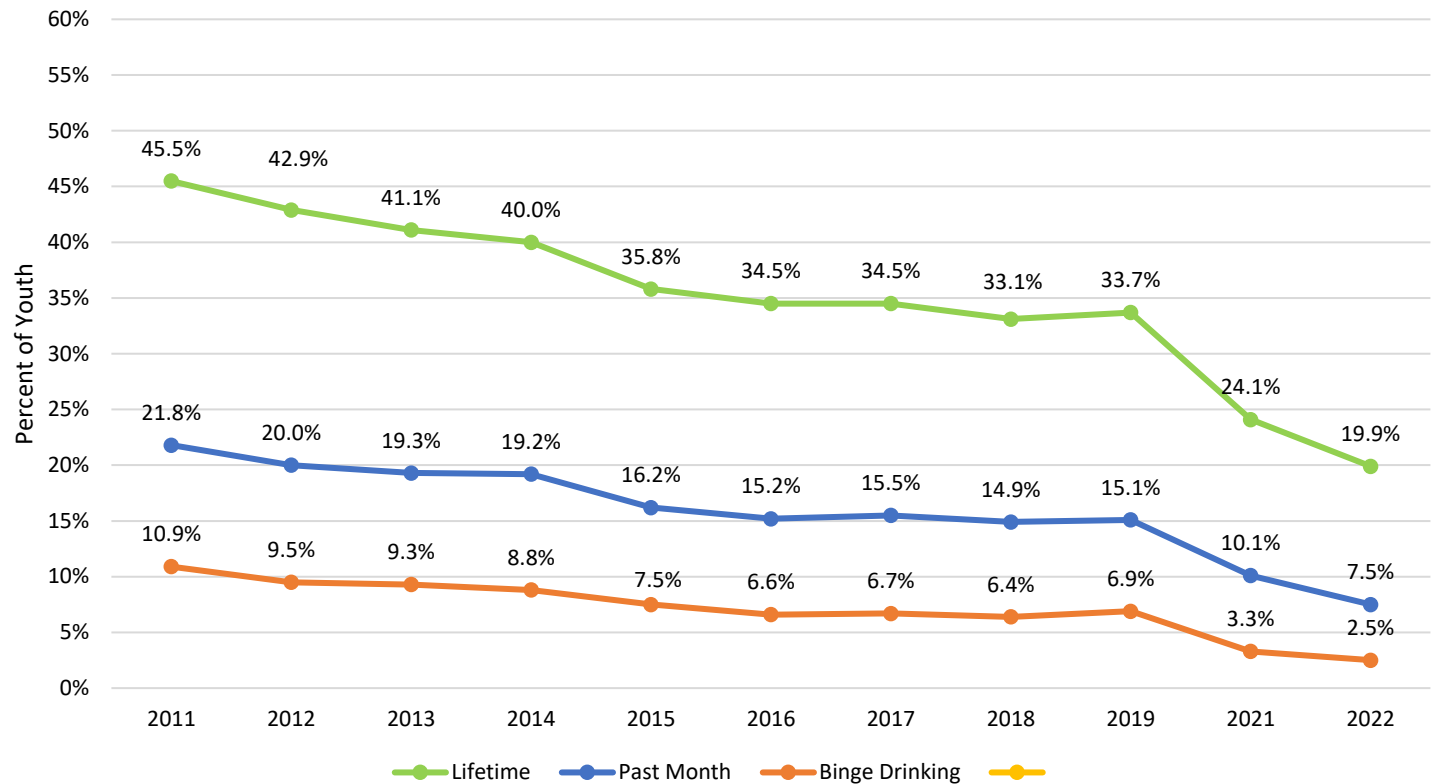
Adults Who Drink Excessively

This indicator measures the percentage of adults who reported heavy drinking 30 days before the survey or binge drinking at least once during the 30 days. In 2020, the rate of adults in Fairfax County who reported heavy drinking was 16.9%, an increase from 2019 (15.0%). The rate of adults who drink excessively in the City of Falls Church is 20.0%, which is constant (20.0% in 2019) and decreased for Fairfax City, 16.9% (19.0% in 2019).



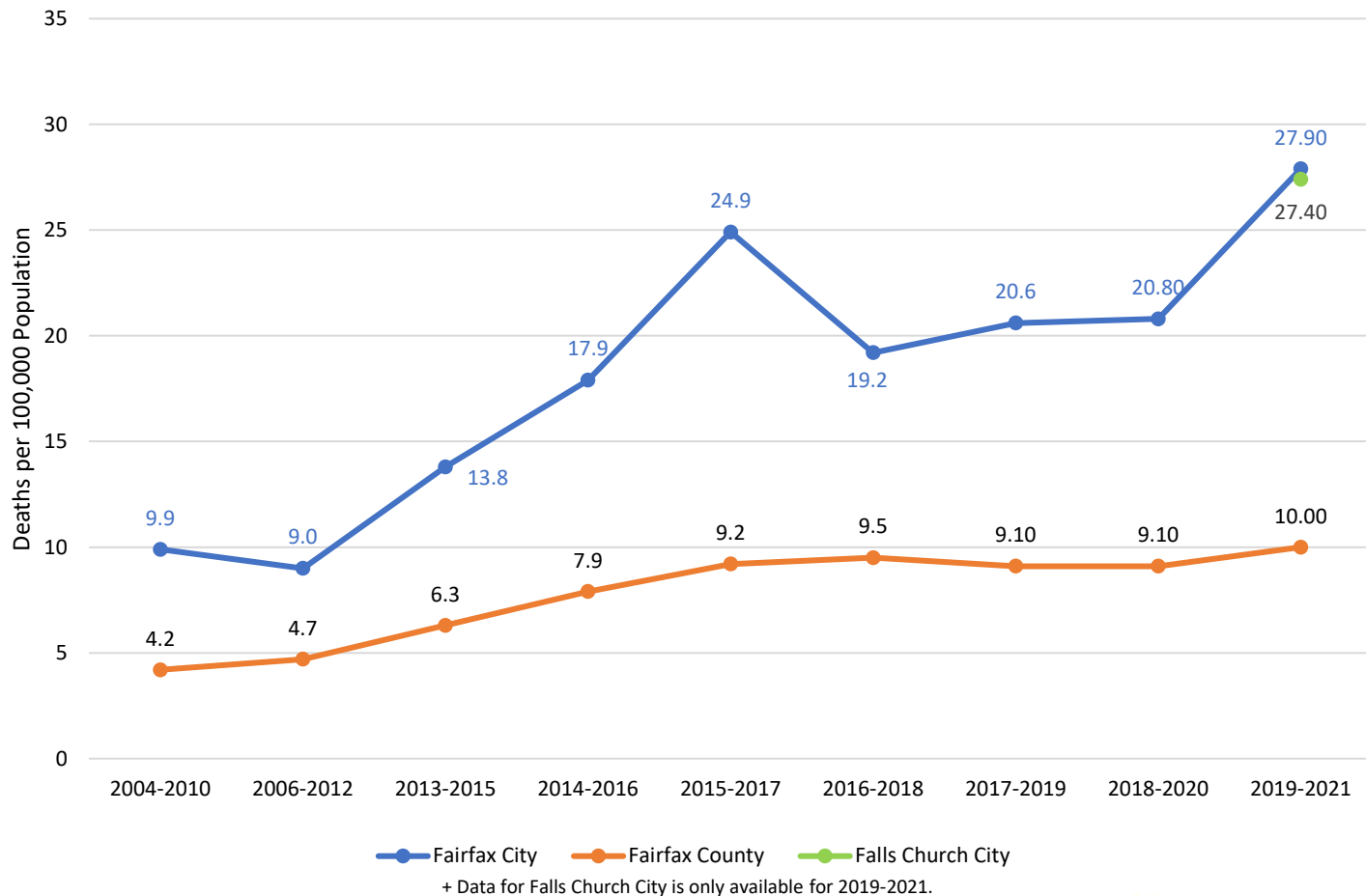
Youth Alcohol Use

This indicator shows the percentage of 8th, 10th, and 12th graders in Fairfax County who have consumed alcohol at least once in their lifetime. Alcohol use during the past month and binge drinking, defined as five or more drinks in a row, during the past month are also shown here. In 2022, 19.9% of Fairfax County students consumed alcohol at least once in their lifetime compared to 7.5% of students who drank alcohol within the past month. Of the students in Fairfax County, 2.5% reported binge drinking.



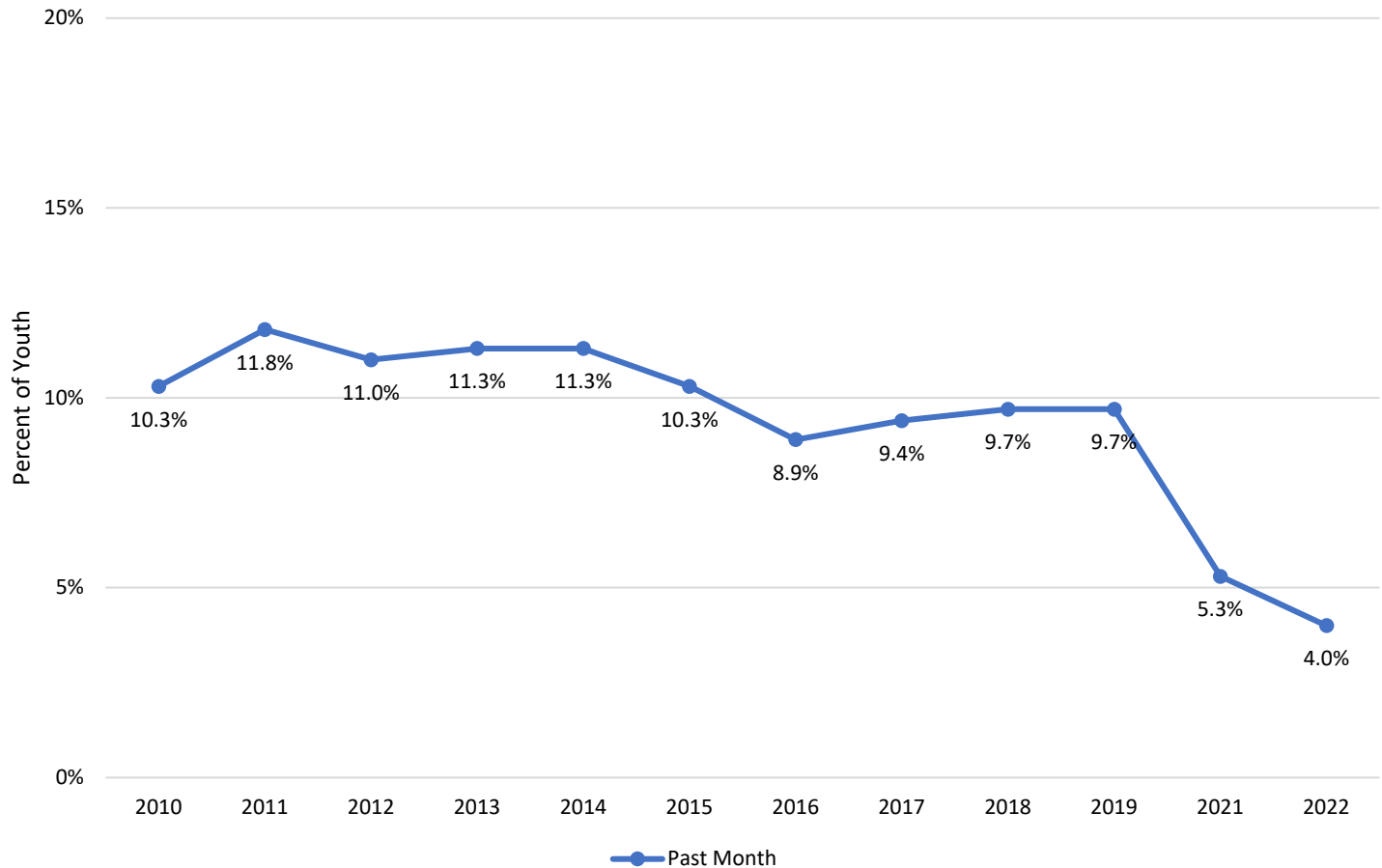
Death Rate Due to Drug Poisoning

This indicator measures the death rate per 100,000 population due to drug poisoning. From 2019-2021, a death rate of 10.00 per 100,000 was reported in Fairfax County in comparison to a death rate of 27.9 per 100,000 in Fairfax City and 27.4 per 100,000 in Falls Church City.



Youth Marijuana Use

This indicator shows the percentage of Fairfax County students in 8th, 10th, and 12th grades who used marijuana at least once in the past month. In 2022, 4.0% of students reported marijuana use within the past 30 days.



Conclusion

The Fairfax Health District's Community Health Improvement Plan 2.0 is a 6-year plan. While the CHIP was originally a 5-year plan, it was expanded to six years due to the unexpected delays and new priorities that occurred during the and recovery period of the Covid-19 pandemic.

While overall the CHIP 2.0 progress slowed, it continued to move the community forward. As we complete year five, we address the three identified priority issues: Behavioral Health, Healthy Eating and Healthy Environment and Active Living.

As of December 31, 2023, of the 69 key actions in CHIP 2.0, 35% of the actions have been completed, 51% are in progress and 14% were not started because they were deemed no long feasible or relevant.

Before, during and after the pandemic, achieving improved health outcomes takes times, resources and dedication of many individuals. Only when diverse community stakeholders and partners in the Fairfax Health District work together can the Partnership achieve our vision of optimal health and well-being for all who live, work and play in the Fairfax Community.

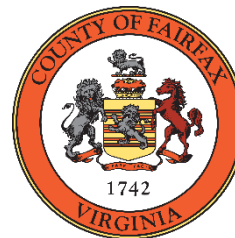
