The meeting was called to order at 9:40 a.m., with all Members being present, with the exception of Supervisor Frey, and with Chairman Hanley presiding.

Supervisor Frey was absent from the entire meeting.

Others present were Anthony H. Griffin, County Executive; David P. Bobzien, County Attorney; Catherine A. Chianese, Assistant to the County Executive; Christina M. Manning, Assistant to the County Executive; Nancy Vehrs, Clerk to the Board of Supervisors; and Patti M. Hicks, Deputy Clerk to the Board of Supervisors.

### **BOARD MATTERS**

1. **EXPRESSION OF CONDOLENCES TO DAVID P. BOBZIEN, COUNTY ATTORNEY** (Tape 1)

Chairman Hanley expressed the Board's condolences to David P. Bobzien, County Attorney, on the death of his mother.

2. **SEPTEMBER 11, 2001, TERRORIST ATTACKS ON THE UNITED STATES** (Tape 1)

Chairman Hanley made a statement about the terrorist attacks of September 11, 2001, and the County's response and expressed appreciation to all the County firefighters, police officers, and public employees who worked to save lives and to restore and maintain order.

As part of the Moment of Silence, Chairman Hanley asked everyone to reflect on what it means to be an American, and to keep the victims and their families in thoughts and prayers.

Following discussion, with input from Anthony H. Griffin, County Executive, Captain Robert "Mike" Mohler, representing the Fairfax County Firefighters, briefed the Board on the activities of the Department of Fire and Rescue in response to the attacks, both at the Pentagon and in New York City.

In regard to information being developed by Captain Mohler on charitable contributions for firefighters, Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and asked unanimous consent that the Board direct the Office of Public Affairs to include this in information being publicized regarding opportunities for persons to make contributions relating to the September 11, 2001, incident. Without objection, it was so ordered.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

J. Thomas Manger, Chief of Police, briefed the Board on the Police Department's response to the attacks and ensuing bias crimes.

### **AGENDA ITEMS**

3. **RESOLUTION TO COMMEND THE PARK AUTHORITY BOARD ON THE OCCASION OF ITS ACQUISITION OF THE 20,000 ACRE OF PARKLAND, AND I-4 – PARK AUTHORITY BOARD SELECTED FOR THE OUTSTANDING BOARD OR COMMISSION AWARD OF THE NATIONAL RECREATION AND PARK ASSOCIATION** (Tape 1)

Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and moved adoption of the Resolution presented to Frank de la Fe, Chairman of the Park Authority, commending the Park Authority on the occasion of its acquisition of the 20,000th acre of parkland. Supervisor Connolly and Supervisor Hyland jointly seconded the motion and it carried by a vote of nine, Supervisor Frey being absent.

Mr. de la Fe presented to the Board copies of the 2002 Calendar of Fairfax County Parks and announced that the calendars were a fundraiser that would be sold at the Government Center, all of the park facilities, through the mail, and through the website. Proceeds from the sale of these calendars will go to the open land preservation fund.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

4. **CERTIFICATE OF RECOGNITION PRESENTED TO NORTHERN VIRGINIA CONSERVATION TRUST (NVCT)** (Tape 1)

Supervisor Mendelsohn moved approval of the Certificate of Recognition presented to Paul Gilbert, President, NVTC, on behalf of NVTC for its efforts to pursue preservation and conservation of land in Northern Virginia. Supervisor Connolly seconded the motion and it carried by a vote of seven, Supervisor Kauffman and Supervisor McConnell being out of the room, Supervisor Frey being absent.

Noting that the County celebrated the 20,000th acre for the Park Authority, Supervisor Connolly asked unanimous consent that the Board direct the Office of Public Affairs to provide data indicating the acreage from the other Park holdings and land preservations efforts in the County, and provide the comparable figure in aggregate. Without objection, it was so ordered.

Further discussion ensued.

Supervisor Mendelsohn moved approval of the Certificate of Recognition presented to Mr. Basim Naga for winning first place at the State competition of the Virginia Skills - VICA Culinary Institute in Norfolk. Chairman Hanley seconded the motion and it carried by a vote of eight, Supervisor McConnell being out of the room, Supervisor Frey being absent.

6. **CERTIFICATE OF RECOGNITION PRESENTED TO MPO JAMES F. KELLY, JR.** (Tape 2)

Supervisor Hyland moved approval of the Certificate of Recognition presented to MPO James F. Kelly, Jr. of the Mount Vernon District Police Station for 25 years of service to Fairfax County. Supervisor Kauffman seconded the motion and it carried by a vote of seven, Supervisor McConnell and Supervisor Mendelsohn being out of the room, Supervisor Frey being absent.

7. **PROCLAMATION TO DECLARE OCTOBER AS "DISABILITY EMPLOYMENT AWARENESS MONTH" IN FAIRFAX COUNTY** (Tape 2)

Chairman Hanley relinquished the Chair to Vice-Chairman Hyland and moved approval of the Proclamation presented to Janet Samuelson, President and CEO, ServiceSource, declaring October as "*Disability Employment Awareness Month*" in Fairfax County. Supervisor Connolly seconded the motion and it carried by a vote of seven, Supervisor Kauffman and Supervisor McConnell being out of the room, Supervisor Frey being absent.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

8. **10 A.M. – PRESENTATION BY THE FAIRFAX COUNTY LIBRARY BOARD OF TRUSTEES** (Tape 2)

Elizabeth McManus, Mount Vernon District Representative, Fairfax County Library Board of Trustees, announced that the month of September is “National Library Card Sign up Month.” To commemorate the event, the Library is introducing library cards in the new key chain format.

Ms. McManus introduced a new book entitled *Fractured Land*, which captures the voting records and newspaper articles from the period of May 23, 1861, when Fairfax County citizens voted to secede from the Union, and a second book entitled *Return to the Union*, which details Fairfax County’s role in the adoption of the Virginia Constitution of 1870.

Chairman Hanley recognized the presence of Edwin “Sam” Clay, III, Director, Library Administration, and Joyce D. Andrews, At-Large Representative, Fairfax County Library Board of Trustees, and warmly welcomed them to the Board Auditorium.

#### **ADDITIONAL BOARD MATTERS**

20. **UPDATE ON THE NIMDA COMPUTER VIRUS** (Tape 5)

David J. Molchany, Chief Information Officer, and Wanda Gibson, Director, Department of Information Technology, briefed the Board on the NIMDA computer virus and the valiant staff effort to eradicate it from the County's computer systems. A brief discussion ensued, with input from Mr. Molchany and Ms. Gibson.

21. **FIRE PREVENTION WEEK AND RECOGNITION OF STAFF WHO ASSISTED AT THE PENTAGON** (Tape 5)

Chairman Hanley stated that the week of October 7-13, 2001, will be celebrated nationally as Fire Prevention Week. The Department of Fire and Rescue will host open houses at all 34 County fire and rescue stations on Saturday, October 13, 2001, to feature "Cover the Bases and Strike out Fire." Accordingly, she relinquished the Chair to Vice-Chairman Hyland and moved that the Board direct staff to invite:

- Representatives from the Department of Fire and Rescue to appear before the Board at the October 1, 2001, meeting to receive a proclamation declaring the week of October 7-13, 2001, as "*Fire Prevention Week*" in Fairfax County.
- Members of the VATF1 who were called to assist at the Pentagon

to appear before the Board on October 1, 2001, as well.

Supervisor Connolly seconded the motion, which carried by a vote of nine, Supervisor Frey being absent.

22. **RESOLUTION REGARDING THE EVENTS OF SEPTEMBER 11, 2001**  
(Tape 5)

(R) (NOTE: Earlier in the meeting the Board made reference to the terrorists attacks of September 11, 2001. See Clerk's Summary Item CL#\_.)

Chairman Hanley called the Board's attention to copies of a draft resolution that the National Association of Counties had sent regarding the terrorist attacks of September 11, 2001, and noted that Supervisor Hyland had also circulated a Board Matter with the same resolution. Accordingly, she moved adoption of the Resolution. Supervisor Connolly seconded the motion, which carried by a vote of nine, Supervisor Bulova, Supervisor Connolly, Supervisor Gross, Supervisor Hudgins, Supervisor Hyland, Supervisor Kauffman, Supervisor McConnell, Supervisor Mendelsohn, and Chairman Hanley voting "AYE," Supervisor Frey being absent.

23. **PARKING ISSUES RESULTING FROM TRANSPORTATION CHALLENGES FOLLOWING THE ATTACK ON THE PENTAGON**  
(Tape 5)

Chairman Hanley said that the terrorist attack on the Pentagon and subsequent tightening of the security around the Pentagon and other facilities created a major transportation challenge. In response to a request by the US Department of Defense, the Metrorail system now opens at 5 a.m. to handle the additional demand on the transit system. She noted that this resulted in a need for additional parking around the Metro stations. She pointed out that the Connector services are opening earlier and that additional County parking areas are being publicized to handle the rush hours.

In recognition of the need to address the parking issue immediately at the Vienna Metro Station, Chairman Hanley stated that a lot was opened on Wednesday, September 19, 2001, across from the recently built parking garage to handle overflow parking. It will be used only after the other spaces are filled. Since no one knows how long this situation will last, she asserted that the Board should pursue necessary actions to ensure that this important public use is available as long as it is needed. Accordingly, she moved that the Board direct staff to:

- Immediately work with the property owner and Washington Metropolitan Area Transit Authority to determine the best course of action to ensure that the parking lot is available, including the need to charge a parking fee, to meet the tremendous demand on the Metrorail system.

- Provide its findings and recommendations to the Board as soon as possible for appropriate action.

Supervisor Bulova seconded the motion and asked to amend it to direct staff to work with the Virginia Railway Express staff to create and provide at least some temporary additional parking at County lots. This was accepted.

Chairman Hanley restated the motion as directing staff to continue efforts at all parking lots to find expansion opportunities.

Supervisor Bulova asked unanimous consent that the Board direct staff to pursue funding opportunities based on the national emergency implications. Without objection, it was so ordered.

Following discussion, Supervisor Connolly asked unanimous consent that the Board direct staff to publicize and participate in the next Washington Area Conference on Telework scheduled for Tuesday, October 23, 2001, at Loews, L'Enfant Plaza Hotel. Without objection, it was so ordered.

Following further discussion, the question was called on the motion, as amended, which carried by a vote of nine, Supervisor Frey being absent.

24. **OFFICE FOR CHILDREN CELEBRATES 25 YEARS** (Tape 5)

Chairman Hanley announced that this year the Office for Children celebrates the twenty-fifth anniversary of its inception. She noted that it has effectively provided and administered services and programs such as School Age Child Care Centers and Head Start. Accordingly, she moved that the Board direct staff to invite representatives from the Office for Children and appropriate community members to appear before the Board on October 1, 2001, to receive a resolution commending the Office for Children for its 25 years of exemplary service to the citizens of the County. Supervisor Mendelsohn seconded the motion, which carried by a vote of nine, Supervisor Frey being absent.

25. **AMERICA RECYCLES DAY** (Tape 5)

Chairman Hanley moved that the Board direct staff to:

- Prepare a proclamation declaring November 15, 2001, as "*Fairfax County Recycles Day*" in Fairfax County.
- Invite the appropriate individuals to appear before the Board on October 22, 2001, to accept it.

Supervisor Connolly seconded the motion, which carried by a vote of nine, Supervisor Frey being absent.

26. **OPERATION TOOLS FOR SUCCESS PARTNERSHIP** (Tape 5)

Chairman Hanley moved that the Board direct staff to invite representatives of the Operation Tools for Success Partnership, which includes EDS, Saint Mary's of Sorrows Catholic Church, Riggs Bank, Kids R First, and Cox Communications, to appear before the Board on October 1, 2001, to accept certificates of recognition for their efforts. Supervisor Bulova and Supervisor Connolly seconded the motion, which carried by vote of nine, Supervisor Frey being absent.

27. **RECOGNITION OF ELECTION OFFICIALS** (Tape 5)

Chairman Hanley stated that 14 of the County's election officials have served in more than 50 elections. With reference to her written Board Matter on the subject, she moved that the Board direct staff to invite the long-serving election officials and the student pages to appear before the Board on December 3, 2001, to accept Certificates of Recognition. Supervisor Connolly seconded the motion, which carried by a vote of nine, Supervisor Frey being absent.

28. **CENTER FOR MULTICULTURAL HUMAN SERVICES THEATRICAL EVENT** (Tape 5)

Chairman Hanley called the Board's attention to a flyer from the Center for Multicultural Human Services which it would like to publicize regarding its theatrical fundraiser event on October 4 and 5, 2001, at the Rosslyn Spectrum Theatre.

29. **QUARTERLY STATUS REPORT OF THE AUDIT COMMITTEE**  
(Tape 5)

(BACs) Chairman Hanley moved that the Board accept the quarterly status report on the operations of the Audit Committee, as distributed to the Board by mail. Supervisor Bulova seconded the motion, which carried by a vote of nine, Supervisor Frey being absent.

30. **LETTERS REGARDING RONALD REAGAN WASHINGTON NATIONAL AIRPORT** (Tape 5)

Chairman Hanley called the Board's attention to two letters that she had signed as chief elected official of the County regarding the status of Ronald Reagan Washington National Airport. One, from the mayors and chairs of Northern Virginia, addressed the issue of Ronald Reagan Washington National Airport and the need to keep it open. The other, from the entire region, urged the reopening of that airport.

Chairman Hanley noted that several Board Members had planned to present Board Matters on the subject of reopening Ronald Reagan Washington National Airport and she moved that the Board indicate its support to the President and the

Congressional Delegation of reopening and keeping open that airport in a safe manner. She noted that safety is recognized as the number one issue. Supervisor Connolly seconded the motion.

Following discussion, the question was called on the motion, which carried by a vote of nine, Supervisor Frey being absent.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

31. **RELIEF FOR SOME UNEMPLOYED INDIVIDUALS** (Tape 6)

Noting that there are a number of layoffs and reservists being called up, Supervisor Mendelsohn asked unanimous consent that the Board direct staff to determine if there are any funds that may be used to match-up some of the unemployed individuals to back-fill for the reservists. Without objection, it was so ordered.

32. **MENTORING PROGRAM** (Tape 6)

Supervisor Mendelsohn said that research has shown that the introduction of a mentor can have a powerful impact on the emotional and educational development of children and teenagers. Mentors can assist in preventing drug abuse and youth violence while greatly enhancing the young person's prospects for leading a fulfilling and productive life. The challenge has always been to recruit large numbers of mentors.

Currently in Fairfax County, more than 700 children are on the waiting list for mentors through local programs. In addition, thousands more children could benefit from a mentoring relationship if only there were enough caring adults to volunteer their time. The Fairfax Mentoring Partnership, an initiative of the Fairfax Partnership for Youth, works closely with all the mentoring programs in the County, educating and recruiting mentors for these children.

During the recent events that have taken place in the country, Supervisor Mendelsohn said that there seems to be a renewed feeling of reaching out, especially to children. He referred to a mentoring program that was adopted by the state of Florida and allows government employees up to one hour of administrative leave per week to participate in established mentoring programs.

Therefore, Supervisor Mendelsohn asked unanimous consent that the Board:

- Direct the County Executive to examine the Florida mentoring program and determine its applicability for Fairfax County and the feasibility of allowing County employees to participate in this or similar government sponsored mentoring programs.

- In conjunction with the National Mentoring Partnership who has designated January 2002 as National Mentoring Month, that the Board follow suit and declare January 2002 as *Mentoring Month* in Fairfax County.

Supervisor Connolly seconded the motion and it carried by a vote of seven, Supervisor Bulova and Supervisor Kauffman being out of the room, Supervisor Frey being absent.

33. **TEEN CENTERS** (Tape 6)

Supervisor Mendelsohn said that based on an earlier request from this Board, the Fairfax County Department of Community and Recreation Services (CRS) has been reviewing the Teen Center structure to include regionalizing services. This past summer, CRS piloted a program using the Herndon Resource Center for afternoon programs and the Reston Teen Center for evening programs. Teens from within the region were encouraged to participate in both programs. The opportunity to provide afternoon summer programming was a new initiative for teen centers and produced very positive results. The afternoon program, which included transportation to and from the center, averaged 20 middle school youth per day from the Herndon and Reston area.

Therefore, Supervisor Mendelsohn moved that the Board direct staff to explore the idea of regionalizing CRS Teen Center services on a permanent basis and to present an implementation plan to the Board as soon as possible. Supervisor Hudgins seconded the motion.

Supervisor Connolly asked to amend the motion to direct the County Executive to report with an evaluation of and a plan to redress the lack of equalization of services, and this was accepted.

Following discussion, the question was called on the motion, which carried by a vote of nine, Supervisor Frey being absent.

34. **RETT SYNDROME** (Tape 6)

Supervisor Connolly asked unanimous consent that the Board proclaim October as "*Retts Syndrome Month*" in Fairfax County.

Following discussion, Chairman Hanley relinquished the Chair to Vice Chairman Hyland and asked to amend the request that the Board direct the Office of Public Affairs to publish information about Rett Syndrome. Without objection, the request as amended, was so ordered.

Vice-Chairman Hyland returned the gavel to Chairman Hanley.

35. **SAFETY HELMET AWARENESS DAY** (Tape 6)

Supervisor Connolly said that this past Saturday, the Fairfax County Police Department, in conjunction with the INOVA Regional Trauma Center of INOVA Fairfax Hospital/INOVA Fairfax Hospital for Children, hosted the second annual mountain bike competition at Lake Accotink Park in the Springfield District. Proceeds from this event benefit the pediatric head trauma unit at the INOVA Fairfax Hospital for Children. Law enforcement officers from throughout the region competed in a five-mile course, an obstacle course, and a bike toss.

Supervisor Connolly said that Supervisor McConnell joins him in suggesting that this worthwhile event be expanded. He said that they propose an effort to encourage all children to wear safety helmets to prevent head injury while riding bicycles, scooters, or roller-blades.

Therefore Supervisor Connolly moved that the Board direct the Police Department to declare a springtime Saturday as Safety Helmet Awareness Day. He encouraged INOVA Fairfax Hospital and INOVA Fairfax Hospital for Children as well as sports stores and manufacturers to join this effort as the Police Department and especially the bicycle officers reach out to children and parents throughout Fairfax County. Supervisor McConnell seconded the motion.

Supervisor Bulova asked to amend the motion to incorporate this "day" into future bike competitions held by the Police Department, and this was accepted.

The question was called on the motion, as amended, and it carried by a vote of eight, Supervisor Mendelsohn being out of the room, Supervisor Frey being absent.

36. **DISABILITY AWARENESS** (Tape 6)

(NOTE: Earlier in the meeting, during presentations, there was discussion of this issue. See Clerk's Summary Item CL#7.)

Supervisor Connolly said that the Board issued a proclamation declaring October as "*Disability Employment Awareness Month*" in Fairfax County. He said that he has noticed an increasing frequency of drivers ignoring signs reserving parking spaces for the handicapped. He said that he has personally confronted drivers and found that they were not unaware that they had occupied a space reserved for the handicapped.

Therefore, Supervisor Connolly moved that the Board direct the County Executive and the Police Department to determine how public awareness could be raised and develop an intensive campaign to cite the violators. Supervisor McConnell seconded the motion and it carried by a vote of eight, Supervisor Mendelsohn being out of the room, Supervisor Frey being absent.

37. **PROVIDENCE DISTRICT VOLUNTEERFEST PROJECT TO SEND "WE SUPPORT YOU" PACKAGES TO TROOPS DEPLOYED IN ANTI-TERRORISM EFFORT** (Tape 6)

Supervisor Connolly noted that Providence District has long set the tone for a good-natured competition during the County's annual VolunteerFest Day. He said that Providence District has the longest standing VolunteerFest Committee made up of citizens, business groups, faith communities, civic associations, and Fairfax County employees.

Supervisor Connolly said that after much discussion the committee decided on a project that it hopes will give everyone the opportunity to come together in support of the effort to combat terrorism. He said that he is working with Providence District schools, businesses, faith communities, and civic groups, to plan a gathering on Saturday, October 27, VolunteerFest Day, where they will be putting together "We Support You" packages for military troops who are being deployed to answer the terrorist acts of September 11. They are collecting paperback books, cards, games, powdered drinks, candy, toiletries, and most importantly, personal letters and drawings from the school children and other citizens.

Supervisor Connolly said he hopes Board Members will join Providence District in this or similar efforts on October 27 and turn the friendly competition into a significant, healing effort for the community. He invited all to join in this project and said that he would be glad to share information on the organizing effort with all that are interested. He added that he will be announcing the names of businesses and other participating groups, as well as further details about location and time, as they develop.

38. **THISTLE LANE** (Tape 6)

(A) Supervisor Connolly said that on August 6, 2001, the Board adopted an Order abandoning a portion of Thistle Lane that consists of 1,385 square feet. With the abandonment, the County continues owning the underlying land area.

Winchester Homes, Incorporated, has requested the conveyance of the abandoned portion of Thistle Lane to incorporate the area for the construction of townhouse sites and has agreed to pay the County \$11,080. This amount is the fair market value of the land as determined by an independent expert real estate appraiser.

In accordance with Board Policy and Section 15.2-1800 of the *Code of Virginia*, a public hearing is required prior to the sale of County-owned property.

Therefore, Supervisor Connolly moved that the Board authorize the advertisement of a public hearing to be held before the Board on **October 22, 2001, at 4 p.m.** regarding the proposed conveyance of the abandoned portion of Thistle Lane. Supervisor McConnell seconded the motion and it carried by a vote of eight, Supervisor Mendelsohn being out of the room, Supervisor Frey being absent.

39. **GREATER WASHINGTON BOARD OF TRADE AD** (Tape 6)

Chairman Hanley announced that the Greater Washington Board of Trade is providing a copy for an ad to run in this Wednesday's *Washington Times*.

Supervisor Connolly moved that the Board endorse the statement. Supervisor Gross seconded the motion and it carried by a vote of eight, Supervisor Mendelsohn being out of the room, Supervisor Frey being absent.

40. **DEFERRAL OF AREA PLANS REVIEW (APR) NUMBER 01-II-17V**  
(Tape 6)

Supervisor Hudgins said that on Thursday, September 13, 2001, the Hunter Mill District APR Task Force requested the deferral of APR Number 01-II-17V, 1731 Gosnell Road, located at Tax Map 29-3((1))35. The deferral will allow this nomination to be considered with the 12 APR nominations deferred on August 6, 2001, in the Providence District.

Supervisor Hudgins moved that the Board direct the Planning Commission to defer APR Number 01-II-17V and include this nomination with the Providence District Tysons Corner nominations which were deferred until the completion and issuance of the Environmental Impact Statement and the National Environmental Policy Act report. Supervisor Connolly seconded the motion.

Following discussion, the question was called on the motion and it carried by a vote of eight, Supervisor Mendelsohn being out of the room, Supervisor Frey being absent.

41. **MULTICULTURAL FESTIVAL** (Tape 6)

Supervisor Hudgins asked unanimous consent that the Board direct staff to invite the Multicultural Festival Committee and representatives of the Reston Police Station to appear before the Board to be recognized for its work. Without objection, it was so ordered.

42. **HUNTER MILL DISTRICT COMMUNITY MEETING** (Tape 6)

Supervisor Hudgins announced that on Saturday, September 29, 2001, there will be a Hunter Mill District Community meeting, "Planning for the Future Transit Oriented Development in the Dulles Corridor." The meeting will be held from 8:30 a.m. until 1 p.m. at the South Lakes High School.

43. **"LIGHT THE NIGHT" WALK** (Tape 6)

Supervisor Hudgins announced that there will be a "Light the Night" walk for Leukemia and Lymphoma at the Reston Town Center on Saturday, September 29, 2001, at 6:30 p.m.

44. **NEW RESIDENT OF THE HUNTER MILL DISTRICT** (Tape 6)

Supervisor Hudgins welcomed soon-to-be new resident Chairman Hanley to the Hunter Mill District.

45. **MAP – MULTICULTURAL FESTIVAL** (Tape 6)

Supervisor Hudgins displayed for the Board a map of the world which was used at the Multicultural festival showing where residents came from prior to moving to the County.

46. **CAR WASHES RAISE MONEY FOR THE RED CROSS RELIEF EFFORT** (Tape 6)

Supervisor Gross said that Fairfax County residents have responded to the terrorist attack on America in a variety of ways - giving blood, volunteering to help rescue crews, and writing checks to the American Red Cross, the Salvation Army, and other service organizations. For one family, however, the urge to do something goes well beyond the usual. The Welch sisters were told they were too young to give blood, so they decided to find another way to help. The weekend after the September 11 attacks, Ashley (15), Aubrey (15), Alana (14), and Alyssa Welch (10) set up special car washes in Mason District to raise money for the Red Cross relief effort. That first weekend they raised more than \$10,000.

On this past Saturday, the Welch sisters again spearheaded a series of car washes, now dubbed "Wash America: To Wash Away the Hurt." They enlisted the help of their classmates and teachers at Annandale High School and Parklawn Elementary School. A simple effort by children to do something to help caught the fancy of the nation and car washes are being held across the country. The girls have been asked to appear on the "Today" show, "Good Morning America," and the "Oprah" show to talk about their effort.

Therefore, Supervisor Gross moved that certificates of recognition be presented to the Welch sisters and their parents, Lieutenant Colonel Tracy Welch and Cherrie Welch, at a future Board meeting. It also would be appropriate to invite a representative of the American Red Cross and the school system to participate in the presentation. Supervisor McConnell seconded the motion and it carried by a vote of seven, Supervisor Hyland and Supervisor Mendelsohn being out of the room, Supervisor Frey being absent.

47. **TWENTY-SECOND ANNUAL MASON DISTRICT PARK FESTIVAL** (Tape 6)

Supervisor Gross said that the twenty-second annual Mason District Park Festival will be held this Saturday, September 29, 2001, from 10 a.m. until 4 p.m. at Mason District Park on Columbia Pike in Annandale. The Festival will feature live entertainment on the showmobile stage, including Mexican mariachi music,

cloggers, Korean music and dance, American jazz, and Irish airs. Other festival activities scheduled are demonstrations by the police and fire departments, food, crafters, and children's rides, admission to the festival is free.

Supervisor Gross invited everyone to come to Mason District Park on Saturday and enjoy the dynamic and diverse community festival. Raindate is Sunday, September 30, same hours.

48. **ACTIVATION OF RESERVISTS** (Tape6)

Supervisor Gross asked unanimous consent that the Board direct the County Executive to report at the Board meeting scheduled for October 1, 2001, with recommendations regarding authorizations for the County Executive to take regarding activation of reservist's when the Board is not meeting. Without objection, it was so ordered.

49. **BURKE FIRE STATION** (Tape 6)

Supervisor McConnell said that in 1999 the Board approved a cooperative agreement with the Burke Volunteer Fire and Rescue Department to replace the Burke Fire Station. Construction of that station is nearing completion, but there have been construction delays that have adversely affected the volunteers' ability to reimburse the County in accordance with the original agreement. The County and the volunteers have been working on a proposal to amend the original agreement that would address the current financial problem of the volunteers.

Supervisor McConnell moved that the Board direct staff to prepare a consideration item for the Board meeting scheduled for October 1, 2001. Supervisor Bulova seconded the motion and it carried by a vote of seven, Supervisor Kauffman and Supervisor Mendelsohn being out of the room, Supervisor Frey being absent.

50. **TRANSPORTATION AND EDUCATION REFERENDUM** (Tape 6)

Supervisor McConnell noted that last year she proposed a transportation and education referendum. This referendum would have allowed the citizens of the County to make the decision on whether to increase the sales tax in Fairfax County by one cent, with one-half of the proceeds to be used for targeted local transportation projects vital to relieve traffic congestion and the other half to be used for critical capital improvements for the Fairfax County School System. Unfortunately, the proposal did not pass; nonetheless she is once again seeking the public support for the referendum. During its meeting of September 19, 2001, the Economic Advisory Commission overwhelmingly voted to urge the Board to support this referendum.

Therefore, Supervisor McConnell moved that the Board vote to support this vital measure. Supervisor Hyland seconded the motion and it carried by a vote of eight, Supervisor Mendelsohn being out of the room, Supervisor Frey being absent.

Supervisor Bulova stated that the County has initiated a study regarding the dredging of Lake Accotink to enhance the recreational opportunities within the park. 52. **METRO BUS** (Tape 7)

Supervisor Bulova stated that she met with a constituent who used the Metrobus that formerly went to the Pentagon and now goes to Pentagon City. Because the bus is being mired in the same traffic as commuter cars, that constituent asked whether the bus could use a dedicated lane to avoid the congestion.

Following discussion, Supervisor Bulova asked unanimous consent that the Board direct staff to review this problem and determine whether there is any express way for buses to travel in that area. Without objection, it was so ordered.

53. **METRO COMMENDATION** (Tape 7)

Supervisor Kauffman stated that at its last meeting the Metro Board commended Metro staff for remaining in operation on September 11, 2001.

54. **INTENT TO DEFER THE PUBLIC HEARING ON REZONING APPLICATION RZ 2000-MD-062** (Tape 7)

Supervisor Kauffman announced his intent to defer, at the appropriate time later in the meeting, the public hearing for Rezoning Application RZ 2000-MD-062 until October 1, 2001, at 3 p.m.

(NOTE: Later in the meeting the public hearing was formally deferred. See Clerk's Summary Item CL#62.)

55. **VETERANS DAY OPPORTUNITY TO SHOW RENEWED PATRIOTISM**  
(Tape 7)

(R) Supervisor Hyland stated that the recent terrorist acts in New York, Virginia, and Pennsylvania caused a resurgence of patriotism. Unity of mind, purpose, and spirit are being demonstrated everywhere. Terrorism on US shores has caused the US to come together in a way that is meaningful and sincere.

With reference to his written Board matter regarding a community-wide effort to designate a special day to come together and express themselves, Supervisor Hyland moved that the Board:

- Proclaim Veterans Day on Monday, November 12, 2001, as “*A Day Out for Democracy*” in Fairfax County and invite all County neighborhoods and communities to participate in a way which is appropriate for memorializing those who died defending this country, who died through no fault of their own in the terrorist acts of September 11, 2001, and those who gave their lives trying to save others and, in so doing, demonstrate the unity of the citizens and support of the nation’s leaders.
- Under cover letter from the Chairman, direct staff to provide members of the Northern Virginia Congressional Delegation with copies of the resolution requesting that Congress designate Veterans Day, November 12, 2001, as Veterans/Remembrance Day encouraging communities, city, and county organizations throughout the US to find a way to memorialize those who died defending this country, who died through no fault of their own in the terrorist acts of September 11, 2001, and those who gave their lives trying to save others and, in so doing, demonstrate the unity of the citizens and support of the nation’s leaders.

Supervisor McConnell seconded the motion.

Following discussion, the question was called on the motion, which carried by a vote of nine, Supervisor Bulova, Supervisor Connolly, Supervisor Gross, Supervisor Hudgins, Supervisor Hyland, Supervisor Kauffman, Supervisor McConnell, Supervisor Mendelsohn, and Chairman Hanley voting “AYE,” Supervisor Frey being absent.

56. **WOODLAWN ROAD AND BEULAH ROAD IN FORT BELVOIR** (Tape 7)

Supervisor Hyland stated that after September 11, 2001, Woodlawn Road has been closed within Fort Belvoir. He asked unanimous consent that the Board direct staff to:

- Provide information regarding details of the easement for the Virginia Department of Transportation.
- Determine from Fort Belvoir officials their future plans for that roadway.

Without objection, it was so ordered.
