The recessed meeting was called to order at 3:07 p.m., with all Members being present, with the exception of Supervisor Hudgins, and with Chairman Bulova presiding.

Supervisor Hudgins arrived at 3:21 p.m.

Following the testimony of Amanda Anvere (Speaker Three), Supervisor Hudgins thanked Ms. Anvere for her work with the Hunter Mill District Budget Committee. Supervisor Hudgins also noted that Ms. Anvere was selected as “Best of Reston 2013.”

(3:51 p.m.)

Following the testimony of Anne Andrews (Speaker 11), Representative of the South County Task Force for Human Services, Supervisor Hyland thanked Ms. Andrews for her commitment on the Route One corridor.

(4:04 p.m.)

Following the testimony of Shannon Steen (Speaker 14), Representative of the Fairfax County Alliance for Human Services, Supervisor Gross raised a question regarding the housing choice vouchers, and discussion ensued, with input from Edward L. Long Jr., County Executive.

Supervisor Gross asked unanimous consent that the Board direct staff to provide information regarding the housing choice vouchers.

Chairman Bulova relinquished the Chair to Acting-Chairman Hyland and asked to amend the request to also direct staff to recirculate the information regarding the housing choice vouchers. Without objection, the request, as amended, was so ordered.

Acting-Chairman Hyland returned the gavel to Chairman Bulova.

Following the testimony of Mattie Palmore (Speaker 18), Representative of the Women’s Group of Mount Vernon, Chairman Bulova noted that a couple of months ago she and Patricia D. Harrison, Deputy County Executive, met with Red Cross representatives and discussed the services it provides.

Following the testimony of Kari Warren (Speaker 19), Representative of Beth El House, Supervisor McKay thanked Ms. Warren for her testimony.

Supervisor Hudgins asked unanimous consent that the Board direct staff to provide information regarding the number of children that are being identified by age in terms of services requested, in collaboration with both schools and County. Without objection, it was so ordered.

Chairman Bulova relinquished the Chair to Vice-Chairman Gross and asked unanimous consent that the Board direct staff to provide information regarding what type of triage is done and/or how individuals are prioritized when they request assistance from the County. Without objection, it was so ordered.

Vice-Chairman Gross returned the gavel to Chairman Bulova.

Following the testimony of Randy Creller (Speaker 24), Chair of the Employees Advisory Council, Chairman Bulova raised a question regarding the cost of his proposal, with input from Mr. Creller.

Following the testimony of David Broder (Speaker 27), Statewide President of the Service Employees International Union of Virginia 512, Supervisor Hyland raised a question regarding comparisons made by Mr. Broder concerning the salary of two employees.

Following discussion, with input from Mr. Broder, Supervisor Hyland asked unanimous consent that the Board direct staff to provide additional information regarding the factors that influenced the salary of the two employees.

Following the testimony of Glenn Kamber (Speaker 31), Supervisor Hudgins thanked Mr. Kamber for his service to the County.

Following the testimony of Jay Myerson (Speaker 45), Representative of the Fairfax Bar Association, Supervisor Cook expressed his opinion regarding the elimination of the Sheriff's Deputies in certain courtrooms.

Following the testimony of Joseph Dailey (Speaker 48), Chair of the Juvenile and Domestic Relations Committee, discussion ensued regarding the proposed elimination of the Sheriff's Office deputies, with input from Fairfax Bar Association Representatives Jay Myerson (Speaker 45), David Gogal (Speaker 46), Patrick Blanch (Speaker 47), and Mr. Dailey.
