I sometimes use the phrase that an issue has “moved onto the front burner.” This year it seems that all the burners are blazing away. As you’ll see inside these pages, we’ve been busy, busy, busy. There is no such thing as apathy in the Braddock District!

Residents of Braddock have been busy working with my office to assist in the design of a **new library in Burke**. The design lets the outdoors in, using lots of glass to highlight trees on the site, and incorporates the path of the sun to brighten the rooms. The library, to be constructed at Burke Centre Parkway and Fred’s Oak Rd., will be one of the projects featured on a Library Bond Referendum this fall.

Neighbors near the **Burke Centre VRE Station** participated in a **Task Force** this fall and winter to ensure that the location and the design for a **structured parking facility** would be aesthetically pleasing, compatible with the residential community, would provide multi-modal accessibility, and be environmentally sensitive. The group also dealt with operational issues, such as safety during and after the construction phase of the parking structure, and made recommendations for maximizing non-motorized access to the Burke Centre VRE Station (i.e., trails, sidewalks).

This year’s Braddock District **Community Dialog Series** engages neighbors, school officials and business leaders in the Heritage area of Annandale to address emerging **gang activity**. The Dialog began in February and will conclude on June 9th. You will have a chance to learn more about the Community Dialog at my **Spring Town Meeting on Wednesday, June 23, at 7:30 PM**, when participants in the series discuss what they learned and present their recommendations. The Town Meeting will be held at the Kings Park Library Community Room. If you are unable to attend, please contact my office to find out what dates the program will appear on Channel 16.

County staff has informed my office that the history feature on our Braddock web page has scored the most “hits” from visitors over the past few years. History buffs will have another reason to visit the site now that an important piece of history has been saved. Working through my office, preservationists and residents of the Oak Hill neighborhood in Annandale were successful in saving the **historic Oak Hill mansion**. Built in 1790, Oak Hill is the last remaining home in Fairfax County built by the Fitzhugh family. A photo of Oak Hill and its history can be found inside this issue of the Byline.

And lastly, lest anyone think we are all work and no play, you’ll enjoy perusing this year’s 10th anniversary schedule for our wonderful **Braddock Nights summer concert series**. Bring a blanket or lawn chairs and stretch out with a picnic dinner. Life doesn’t get any better than being entertained by outstanding performers, while the sun drifts down over beautiful Royal Lake in Fairfax and Lake Accotink in Springfield. Hope to see you there!

ROADWORKS UPDATE

The state budget crisis appears to have been resolved with the passage of a new biennial budget that provides significant increases in funding for many needs with the exception of transportation. Projects already in the pipeline are being funded. However, with no added money, delays in new construction will continue and no new projects can be added. Here in Braddock, the following road projects are going forward:

Burke Lake Rd. - Widen from 2 to 4 lanes from Fairfax County Parkway to Burke Centre Parkway (State Project - 1 mile) Right-of-way acquisition is completed and utilities are being relocated. Last month, VDOT awarded the construction contract and held a "Pardon Our Dust" Meeting to go over the project details with area residents and introduce the contractor and VDOT personnel overseeing the project. The most significant feature of this project is the temporary closure of the road from east of Windward Dr. to just beyond Wilmington Dr. to the east. The road will be closed while schools are in recess this summer. This brief closure will shorten the project length significantly. The entire project is scheduled to be completed by October 2005. Rt. 236 (Little River Turnpike) Spot Capacity and Safety Improvements - Pickett Rd. to Lake Blvd. at entrance to NVCC (State project - 2 miles) A citizens' task force has been involved in design of this project. Right-of-way acquisition is underway with bid advertisement scheduled for winter 2005. Construction is scheduled to begin in 2006. While Rt. 236 is *ultimately* planned to be widened to 6 lanes, this project provides for *spot capacity and safety improvements at key intersections* in the corridor.

Safety improvements on Zion Dr. (east of Roberts Rd. to Windsor Hills Dr.) were approved as part of a rezoning proffer package. The developer, Stanley Martin, will dedicate and construct frontage improvements along Zion Drive to include curb, gutter and a trail, construct a third lane on this portion of Zion to allow for protected left turns; and "shave the hump" on Zion Drive by lowering the vertical elevation of the road. In order to minimize disruption and shorten the length of the project, Zion Drive will be closed to through traffic from west of Windsor Hills Dr. to east of Roberts Rd. The road will be

closed during the summer while schools are in recess. The detour will be New Guinea Rd.

Roberts Rd. at Braddock Rd. (County Project)

Construct a right turn lane on to Braddock Road from southbound Roberts Road next to GMU. Project is fully funded and in design. Significant utility relocations will be required. Construction expected to begin in late 2004/early 2005.

Pond Spice Ln. Sidewalk Extension – Project to install missing link in sidewalk across from Terra Centre School south of Burke Centre Pkwy. Project delayed due to additional VDOT technical requirements.

Roberts Rd. Trail Project – Project to construct 1,700 feet of 6-foot asphalt trail on western side of Roberts next to GMU to connect with sidewalk on Braddock Rd. Project funded for design and land acquisition only. Project is in the design phase while additional funding is sought from the state.

Little River Glen II, Assisted Living and Adult Day Care Facility – Project to build 60-bed assisted living facility and adult day care off Olley Ln. adjacent to the Senior Center was delayed due technical financing issues related to the state tax credit financing. Additional local funding will allow the project to go forward. Construction slated to begin this summer/fall.

At the present time, there is no waiting list for people interested in living in the Little River Glen assisted living facility. However, anyone interested in the new facility should add their name to the waiting list for the Project-Based Housing Choice Voucher Program. Burke Centre VRE Station Structured Parking Facility – Project to expand parking capacity is in the design phase. Community task force worked with county engineers to establish design criteria for compatibility, accessibility, safety and ecology friendly features. Task force will reconvene in late summer to review plans before final engineering begins. Construction is scheduled to begin in spring 2006 and be finished by fall 2007.



The dust is just beginning to settle (finally!) over the **County's FY 2005 Budget**, which was adopted unanimously on Monday, April 19th. As I draft this article, the General Assembly appears, at last, to be reaching agreement on their biennium (FY 2005 – FY 2006) budget. We do not know exactly what additional revenue we might receive, but the news is positive. There appears to be no new funding for transportation.

When the County Executive began preparing his recommended budget last fall and winter, our county was stalled in the fourth year of a trend, with residential real estate assessments increasing by double digits, while all other sources of revenue were down or flat. In FY 2005, revenue from all non-residential real estate taxes combined was projected to decrease by \$1 million from the year before. The County was petitioning the General Assembly for taxing authority equal to cities and towns (i.e., an increase in the cigarette tax, the transient occupancy (hotel/motel) tax and a meals tax) that could help us to significantly reduce our reliance on real estate taxes (now making up 60.7% of our budget). On April 19th, after two months of hearing from our constituents by mail, e-mail, phone calls, visits, community gatherings and public hearings, the Board of Supervisors collectively amended (“marked-up”) the Advertised Budget to reflect what we heard.

As we reached the end of the process, we had some good news; the economy (and thus our revenue picture) is beginning to brighten a bit. The bad news was that the General Assembly had not adopted a budget at all, leaving us in a state of considerable uncertainty. The County's Advertised budget assumed \$677.8 million (a status quo level of funding) in state revenue. We now believe there will be more State funding for the schools, public safety and mental health programs.

The **FY 2005 Budget** our Board adopted consisted of the following:

- **\$2.7 billion** in General Fund receipts and expenditures. General (non-school) County spending increases by 2.5% (\$24.5 million) over FY 04.
- A three-cent reduction in the real estate tax rate, from **\$1.16 to \$1.13**
- In accordance with the Board's Guidelines, an **increase in the School Transfer of \$81.5 million, or 6.57%**. The combined transfer for School operations and school debt service is 53% (\$1.3 billion) of the County's Budget. Additionally, the Board directed the establishment of a replacement reserve program to assist the Schools with replacement of school computers and buses.
- **\$12.6 million in reductions from the Advertised Budget**, carefully chosen to protect the “quality of life” services and programs that our constituents value and rely upon.
- **Three fees** (in use in other Northern Virginia jurisdictions) that allow us to **diversify revenue and reduce our reliance on the real estate tax**: An **Athletic Services Application Fee**, \$1.7 million, with the implementation criteria revised to reflect discussions with the athletic organizations; an **EMS Transport Fee**, which would be implemented later in the fiscal year in order to provide sufficient public outreach, education and coordination with appropriate agencies and organizations; a **Transient Occupancy (Hotel/Motel) Tax**, \$5.2 million.
- The **most up-to-date non-real estate revenue projections** to reflect improving economic conditions.
- The establishment of a **new “Scholarship-based” Reserve for job training and opportunities for Mentally Retarded Graduates** of our public schools in the amount of \$500,000. This program, based on need and circumstances, replaces an existing (non-needs based) program and will be established with the involvement of affected families, advocacy groups, the CSB, the Human Services Council, and other appropriate agencies and organizations.

OAK HILL: A VICTORY FOR HISTORIC PRESERVATION

In 1670 William Fitzhugh established one of the largest land grants in the “new world,” 21,996 acres stretching from present day Stafford County to Arlington County. The Fairfax County portion of this land was known as Ravensworth.

In 1783 Ravensworth, the fourth largest plantation in Fairfax County was divided between the five grandsons of William Fitzhugh. Richard Fitzhugh, one of the five grandsons, built Oak Hill in 1790. In the same year, Ossian Hall and another house named Dover were all constructed by the grandsons of William Fitzhugh. Today Oak Hill is the only remaining home built by the Fitzhugh family left in Fairfax County.

Oak Hill was built in the rigid symmetry of the late Georgian style which was inspired by Italian Renaissance architecture. In the 1930s renowned restoration architect Walter M. Macomber restored the house in a Colonial Revival style. Most of Oak Hill stands today as it did after the 1930s restoration. The grounds of Oak Hill are also remarkable. From Braeburn Drive to the front doors of Oak Hill is the original drive to the house. This drive is lined on both sides by boxwoods that date back to the 1790 construction of Oak Hill. It is unusual to find so much of the original landscaping including oak trees and boxwoods still intact over 200 years later.

The house was recently purchased by Seville Homes, who planned to construct new homes on the property. Neighbors, led by Oak Hill Civic Association President Janyce Hedetniemi, rallied to preserve the historic property. The costs associated with purchasing and renovating the property to operate it as a park were close to \$4 million. Instead, we were able to protect this historic landmark when the Park Authority arranged the purchase of a \$750,000 conservation easement for the house and land that

preserves and protects the property in perpetuity. Seville Homes will restore the home at their own expense. The house and yard cannot be altered or removed, and no changes can be made without permission from the Architectural Review Board. The agreement allows for public access to the house and the grounds four times a year. The Oak Hill conservation easement is a unique, cost effective, first for Fairfax County. If successful, historic easements may be a way to preserve more of our history.

OTHER PARK HAPPENINGS

- A new **Skate Park at Wakefield Park** features 21,500 square feet of activities for area teenagers and adults. Two courses accommodate varied skill levels – freestyle and competition.
- The Park Authority has awarded a contract for construction of two **60-ft. diamond fields at Wakefield Park**. Work is scheduled to start in May, and should be completed in time for next year’s softball season. Amenities will include outfield and sideline fencing, backstops, lighting, automated field irrigation, spectator seating, and 105 new parking spaces. The ball fields are being constructed to **girl’s softball** standards and will include skinned infields and sodded outfields.
- Hats off to **the Ossian Hall Park Citizen’s Task Force** for their hard work on the re-planning of Ossian Hall Park in Annandale. The new plan is meant to make the park more inviting to the community. Safety and security issues were at the top of the Task Force’s list. Much of the underbrush will be cleared, providing a more open feeling and improving visibility into the park. The existing baseball diamonds will be moved to a new location to accommodate a plaza area with a playground, picnic area and a small skate park. I’m really excited about this new design and hope that neighbors will take advantage of this little oasis in the middle of bustling Annandale.

STREET PAVING IN BRADDOCK

The state's Virginia Department of Transportation (VDOT) will be repaving certain streets this year in the following Braddock District neighborhoods: ***Kings Park, Cardinal Forest, North Springfield, Ravensworth Farms, Wakefield Chapel Estates, Long Branch, Burke Centre, Rutherford, George Mason Forest, Country Club View, Canterbury Woods, Chestnut Knolls, Middleridge, Vertain Park, Somerset*** and ***Bradfield***. Because of budget constraints, no curb, gutter or sidewalk replacement projects are planned.

VDOT is also planning to repave a number of secondary streets in Braddock. They are: ***Braddock Road*** (from Shirley Gate Road to Ox Road), ***Shirley Gate Road*** (from Braddock Road to Lee Highway) and ***EB Little River Turnpike*** (from Fairfax City to Alexandria). Both ***EB and WB Little River Turnpike*** will be repaved between the Beltway bridge and John Marr Drive in Annandale. In late April, I hosted a meeting for community association representatives impacted by this year's VDOT repaving schedule. VDOT officials explained the procedures that will be used by VDOT's subcontractors when they are working in their neighborhoods. Call my office (703-425-9300) if you have any questions.



Kudos to Paul Andino, Braddock District representative to the Fairfax County Water Authority (FCWA) Board, for providing the winning argument to the U.S. Supreme Court in the famous *Virginia v. Maryland Potomac River Off-Shore Intake case*.

In 1996, the FCWA sought permission from Maryland to build an intake pipe into the middle of the Potomac to access cleaner water. Maryland refused to grant permission, and the FCWA took the issue to court. Just when the case looked hopeless, Paul, a history buff, immersed himself in old documents in the Virginia Room of the Fairfax Library and in the County Courthouse Law Library. Paul discovered that a 1632 grant from King Charles I, giving control of the Potomac River to Maryland, was followed by a 1785 Compact which allowed Virginia "the privilege

of making and carrying out wharves and other improvements in the river."

The U.S. Supreme Court's Decision, on March 31, 2003, benefited Fairfax County by reducing the cost of chemicals (estimated at \$1 million annually) used to purify water from the Potomac. In addition, counties in Virginia no longer will be subject to Maryland's regulations regarding the construction of infrastructure needed to draw water from the Potomac.

LOTS GOING ON AT GMU

Construction at GMU will continue through the summer as the campus creates parking spaces and additions to accommodate its growing population. Potomac Heights (Housing VI) student housing, currently under construction at the intersection of Braddock Road and Roberts Road, will be ready for the fall 2004 semester, adding 500 beds for a total of 4,000 on-campus residents. The five-level Sandy Creek Parking Deck will open in December with 200

visitor spots and 1,000 permit-required spaces in the interior of Patriot Circle by Student Union II.

In the area of Parking Lot B (inside Patriot Circle, in the southwest area of the campus), ground breaks this summer for Research I, a four-story, 100,000-square-foot structure for faculty offices, research laboratories, a high-tech astronomy laboratory and rooftop observatory. Although in its early design stages, Academic V, a new building to house the College of Visual and Performing Arts is planned to be built on the remains of Parking Lot B.

GMU plans to renovate the Aquatic and Fitness Center, adding more lockers and common areas. The Patriot Center is also slated for renovations. The university will then take a break before working on the north end of campus near the City of Fairfax, in 2006 on Housing VII and Student Union Building III. These projects will be completed by 2009.



This town meeting kicks off our new **Braddock Miniseries – A Look Back at Braddock**. I suspect many of you may share my fascination for learning about what was here before our neighborhoods transformed this area of the county, once peppered with forests and farms. Throughout this series, we will explore old roads and settlements, evidence of early Native American civilization, Civil War-era dramas, and the evolution of our system of governance. We'll discuss the preservation of historic sites and learn how to conduct research in the *Virginia Room* of the Fairfax Regional Library. I'm really excited about this series and look forward to having you join me for this trip back in time.

And while we're on the subject of a trip back in time, my staff and I are working with Seville Homes, and staff from the Park Authority and Conservation Trust Fund to plan a wonderful event to **celebrate the preservation of the Oak Hill Mansion (circa 1790)** in Annandale. Plan to join us on **Saturday, October 23rd from 10 AM until noon** at Oak Hill, located at the corner of Wakefield Chapel Rd. and Braeburn Dr. The program includes food, period children's games, re-enactors, and interpretive tours of the building and grounds.

ROADWORKS UPDATE

The state biennial budget approved by the General Assembly this year provided significant increases in funding for many needs, with the exception of transportation. Projects already in the pipeline are funded, but without new money; no new projects can be added. Here is the status of road projects in the Braddock District:

Burke Lake Rd. - Widen from 2 to 4 lanes from Fairfax County Parkway to Burke Centre Parkway (State Project - 1 mile) With right-of-way acquisition completed and utilities moved, VDOT awarded the contract and proceeded with phase one, which involved the temporary closure of the road from east of Windward Dr. to just beyond Wilmington Dr. to the east. This phase was completed on time, and two lanes were open to traffic for the start of the school year. The project is scheduled to be completed by October 2005.

Rt. 236 (Little River Turnpike) Spot Capacity and Safety Improvements - Pickett Rd. to Lake Blvd. at entrance to NVCC (State project - 2 miles) A citizens' task force has been involved in design of this project. Right-of-way acquisition is being delayed pending resolution of proposed modifications to reduce impacts on properties. Bid advertisement is now scheduled for August 2006. Construction is scheduled to begin in 2007. While Rt. 236 is *ultimately* planned to be widened to 6 lanes, this project provides for *spot capacity and safety improvements at key intersections* in the corridor.

Safety improvements on Zion Dr. (east of Roberts Rd. to Windsor Hills Dr.) were approved as part of a rezoning proffer package. The developer, Stanley Martin, has completed frontage improvements along Zion Drive, including curb, gutter and a trail. A third lane on this portion of Zion was added to allow for protected left turns and the vertical elevation of the road was lowered. To minimize disruption and shorten the length of the project, Zion Drive was closed to through traffic during the summer, but opened on time for the start of the school year.

Roberts Rd. at Braddock Rd. (County Project)
Construct a right turn lane on to Braddock Road from southbound Roberts Road next to GMU. Project is fully funded and in design. Significant utility relocations issues are being worked through. Construction expected to begin in 2005.

YOUR TAX DOLLARS AT WORK FOR YOU

Pond Spice La. Sidewalk Extension – Project to install missing link in sidewalk across from Terra Centre School south of Burke Centre Pkwy was completed in time for the start of school.

Roberts Rd. Trail Project – Project to construct 1,700 feet of 6-foot asphalt trail on western side of Roberts next to GMU to connect with sidewalk on Braddock Rd. Project funded for design and land acquisition only. Additional funding is being sought from the state.

Improved access to Metro Bus Stops - Survey and utility scoping work has begun on these projects:
Olley La. Sidewalk Extension - install sidewalk on Olley La from Colbert Ct to Braddock Rd.
Guinea Rd at Falmead Rd - replace drop inlet and do drainage improvements on northbound side of Guinea. Extend trail and build bus shelter on southbound side of Guinea. Install crosswalk.

Little River Glen II, Assisted Living and Adult Day Care Facility – Project to build 60-bed assisted living facility and adult day care off Olley La. adjacent to the Senior Center was delayed due to technical financing issues. Additional local funding **has now been approved**, so construction can begin this fall.


Burke Centre VRE Station Structured Parking Facility – Project to expand parking capacity is in the design phase. Community task force worked with county engineers to establish design criteria for compatibility, accessibility, safety and ecology-friendly features. Task force will review preliminary engineered design plans in late fall, with a communitywide meeting and public hearing to follow in early 2005. After final engineering, construction is anticipated to begin in 2006. Additional surface parking (62 spaces) was completed this summer.

Burke Centre Community Library – Project to build a 17,000 square foot community library at Fred's Oak Rd. and Fairfax County Parkway. Land acquisition is completed, and the project is in the design phase. Construction is to be funded through 2004 Bond Referendum.

Streetlight installation funding has been approved to address backlog of neighborhood streetlight requests dating back to 1998. Communities are being contacted about re-activating their petitions.

Two projects to correct **house flooding problems** will also be funded as part of the recently adopted budget.

ELECTION DAY IS NOVEMBER 2



This year is a Presidential election year, as well as an election year for members of Congress. Additionally, on the ballot will be four Fairfax County Bond Referenda and two Commonwealth of Virginia Constitutional Amendments. Monday, October 4, is the final day of registration for this election. Thursday, October 28, is the deadline for receipt of absentee ballot applications for voting by mail and Saturday, October 30, is the final day for in-person absentee voting.

2004 Fairfax County Human Services Bonds

Asks voters to allow the county to borrow \$32.5 million to construct, renovate and renew several human service, mental health and Juvenile Court Services facilities in the county. The **Mount Vernon and Woodburn Community Mental Health Centers**, which serve 70% of the people who receive emergency and outpatient mental health services in the county, would be renovated and updated to address health and safety concerns, as well as improve physical site accessibility for the disabled. New buildings would be constructed to house the **Girls' Probation House**, and the **Less Secure Shelter II**, a shelter/care facility for youths who are court-ordered to be housed in a nonsecure facility before and after their court hearings.

Fairfax County Public Library Facilities Bonds

Would allow the county to borrow \$52.5 million to construct two new libraries, renovate and expand four existing libraries, and make major repairs at various library facilities. Of particular interest to Braddock District voters is the construction of a new 17,000 sq. ft. **Burke Centre Library**, to be located at the intersection of Freds Oak Rd and the Fairfax County Parkway.

Fairfax County Parks and Park Facilities Bonds

Asks voters to allow the county to borrow \$75 million, which includes \$10 million for the Northern Virginia Regional Park Authority's facilities and expansion. In addition to \$724,000 to reimburse Fairfax County for the **Oak Hill preservation easement**, there are a number of projects in the Braddock District that would be funded: irrigation and renovation for six **Wakefield Park** athletic fields; replacement of elevator, boiler and other infrastructure at the Audrey Moore RECenter at Wakefield Park; park playgrounds, starting with **Rutherford Park**; dam repairs at **Lake Accotink Park**; bridge and steps replacement on the **Danbury Forest Dr. trail** entrance to Lake Accotink Park; replacement/repair of bridges on trail south of Lake Accotink leading to Old Keene Mill Rd; \$750,000 toward the \$2 million cost of implementing the new **Ossian Hall Park** Master Plan. The updated Ossian Hall Plan includes two community plazas, a new, irrigated multi-purpose rectangular field, lighted basketball court, picnic shelter and managed woodlands.

Transportation Improvements and Facilities Bonds

Would fund the county's \$165 million share of Metro Transit Capital improvements for new rail cars and buses, additional parking, and other facility and capital equipment improvements. \$50 million is included for the County's Four-year Transportation Plan for major projects: the **Rte 29/Gallows Rd. intersection** improvements, widening **Stringfellow and Centreville Rds.** and the **Burke Centre VRE Station Structured Parking**, as well as spot intersections including **Braddock Rd/Rte 123** and **Old Keene Mill/Hillside Rds.** \$5 million would go toward **countywide pedestrian enhancements.**

Commonwealth of Virginia Proposed Constitutional Amendments

There will be two questions before the voters on whether to amend the state constitution:

1) *Every ten years redistricting occurs following the U.S. Census. Should a vacancy occur in the State House of Delegates or the U.S. House of Representatives in an off election year, should the vacancy be filled based on the existing district or the newly created district, which goes into effect during the next regularly held election?*

2) *If the Governor is unable to serve, should the list of successors be expanded?*

Public Safety Corner

As a result of last winter and spring's **Community Dialog on Gang Activity/Activities and Revitalization in the Heritage/Annandale Area of the Braddock District**, numerous county agencies are planning and implementing a variety of services and programs. Chief among these efforts is an ad hoc consortium assembled by Captain Jack Hurlock, commander of the West Springfield Police Station, and Evan Braff with the Department of Community and Recreation Services. Below are descriptions of a few of those programs. See my Web Site for more details on these and other programs and how you can help.

"Get Real About Violence" - This month-long summer program at Annandale Terrace Elementary School taught 24 fifth-graders the refusal and resiliency skills needed to combat negative peer pressure and violence.

Road Dawg Camp - a week-long camp for at-risk youths conducted in August provided an opportunity for police officers to serve as mentors and introduced the boys and girls to the public safety profession. Campers were also taught the skills necessary to prevent involvement in gang activity.

Bowling for Badges - On October 23rd Annandale youths, in conjunction with West Springfield Police personnel and Human Service agencies, will sponsor a bowl-a-thon to raise money for the Road Dawg Camp and other gang prevention activities.

Youth Speak Outs - These sessions will give young people a chance to discuss programs/services they would like to see in their community.

Heritage Mall - West Springfield police officers are working with Redwood Commercial Real Estate Services (Heritage Mall) to reduce crime by recommending changes to such environmental influences as lighting, shrubbery and fencing. On **Saturday, November 6th** the **West Springfield Police Station will come to Heritage Mall** with displays of police equipment and activities for area children and families.

Graffiti Removal Initiative - The police department's Bike Team has arranged for labor crews to remove graffiti from the Beltway footbridge leading to the Audrey Moore Recreation Center. Clean-up efforts will be ongoing.

WHAT'S HAPPENING ON CAMPUS




George Mason University has embarked on some exciting construction projects. Much of the construction is planned for the years to come, helping to make GMU one of the most innovative universities in the country. Some of these exciting projects are outlined below;

Research Building I: Will address the university's need for faculty offices and research laboratories. It will include a high-tech astronomy laboratory and a rooftop observatory. Timeline: summer 2003-summer 2005.

Aquatic and Fitness Center Addition: The existing Fitness Center has been overwhelmed with patrons from the day it first opened in 1998. This 26,000 GSF addition will add a large, multilevel fitness and workout area, double the size of the locker room facilities, add offices for intramural and club sports, and increase the equipment storage capacity. Timeline: fall 2003 – summer 2005

Parking Deck II: This facility will be a four-story concrete structure. Approximately 1,000 parking spaces will be provided, along with a retail area and offices for Parking Services. A major feature will be an additional bus stop for the CUE Bus system located at the back of the lower level of Science & Tech II. Eventually, Parking Lot B will go away completely. The new Academic V Building is going to be built on the site of what is left of Parking Lot B. Timeline: spring 2003 – spring 2005

Patriot Center Addition/Improvement: The University's Patriot Center Arena, seating 10,000, has been in continuous use since its opening in 1985. The center is in need of a major interior upgrade and expansion to continue to serve as the primary center for both university events and increasing use as an entertainment arena. The interior renovations will include: facelift and upgrade of all public areas, including the main concourse, rest rooms, concession arena, seating areas, the arena's floor conversion to a multi-purpose ice rink, with a hard surface, event and arena storage, entertainer dressing areas, athletic team locker rooms, and support services. Timeline: spring 2004 – summer 2005



FAIRFAX COUNTY PUBLIC SCHOOL RENOVATIONS

Schools in the Braddock District received one-fourth of the \$377,955,000 allocated by the 2001 Fairfax County School Bond Referendum. Projects at five separate schools in the Braddock District are underway, and some are nearing completion.

Annandale High School, which received \$11.5 million for renovations, is within one year of being completed. Renovations at **Laurel Ridge Elementary School** will be done in the next two years. **Lake Braddock Secondary**, which is having extensive renovations, including a middle school with a 12-room addition, is scheduled for completion three years from now. **Woodson High School** has completed its planning for renovations, which are scheduled for completion during the 2009-2010 school year. **Annandale Terrace Elementary** plans to have its 10-room modular addition completed for the 2006-2007 school year.

We look forward to these renovations and the benefits that children in the Braddock district will receive.

TALKING TRASH

Federal and state environmental law requires Fairfax County to prepare a long-range strategic plan for dealing with solid waste and recyclables over the next 20 years. This plan must provide an analysis of the anticipated volume and nature of the waste expected to be produced. It must describe a method of dealing with this waste that produces the least negative environmental impact.

County staff developed a solid waste plan that built in efficiencies of service, while providing for anticipated increases in population and the resultant solid waste. **Citizen and industry opposition arose to elements of the plan that called for the County to take over control of trash collection. Under this proposal, the County would enter into contracts with private haulers, rather than our current system where individuals and community associations negotiate with private haulers themselves.**

The **Board of Supervisors established a task force** of trash industry representatives, citizen organizations and other stakeholders **to resolve waste collection issues related to service quality, competition, air emissions from trucks, safety, disaster and emergency response, unified recycling activities and other issues.** A report will be delivered to the Board within 12 months regarding the outcome of the task force’s work.



EZ Bus



When I leaf back through older issues of the Braddock Byline, articles about the Virginia Railway Express make me smile.

Service began in 1992. After a brief honeymoon, on-time performance suffered and ridership fell off as we experienced conflicts with our freight railroad landlords. Newspaper headlines in 1996 shouted “Commuter Railroad headed for Doom!” What a difference today. We are reliable, convenient and (especially with Metrocheck) affordable. Our biggest challenge today is accommodating our unprecedented growth.

In addition to the Burke Centre parking structure mentioned in this issue of the Byline, County staff in the Office of Transportation has begun an innovative **subscription bus service called EZ Bus.** Riders who sign up for the service are picked up at or near their homes and delivered to the station in time for their train. The EZ Bus freed up more than 100 parking spaces at the Burke Centre lot. This pilot program is the first of its kind in the country. For more information, please call my office at 703-425-9300.

FYI: VERIZON UPGRADING ITS LINES

Verizon is a publicly held utility company, regulated by the State Corporation Commission, not the County. Verizon is expanding its infrastructure and installing fiber optics. In order for Verizon to make these upgrades, the company may dig in its easement or work on the utility poles, as Cox has done in the past when making its upgrades.

Right now Verizon is working “next door” in the Mason District. Verizon has not told us which neighborhoods it will be upgrading next. However, once Verizon is ready to work in an area, its crews will put a door hanger on your door a week in advance to let you know what they will be doing and who you can contact with concerns.
