STEP ONE:

1. A name change may not be sought for any fraudulent purpose or if it will infringe upon the rights of another.
2. You must submit the Name Change to the Circuit Court of the County in which you live.
3. Read the description page and choose the sample Petition & Order form which applies to your situation. If none of the descriptions apply to you, then you should not use these forms. The areas shaded in grey on the forms should be completed with information specific to your situation.

STEP TWO:

Preparing and Filing your Name Change Documents

1. The Petition and Order must be typed double space and submitted on separate 8 1/2" by 11" white paper; they may NOT be typed onto one piece of paper.
2. To file your Name Change you must have the following:
 - A. A notarized original Petition plus two (2) copies of the notarized Petition.
 - B. An original Order. The order shall contain no identifying information other than the applicant's former name or names, new name, and current address.

C. Name Change documentation may be submitted by mail or in person.

In person: Bring your notarized Petition and two copies, the Order, a self-addressed, stamped envelope and filing fee to the third floor Civil Intake Counter of the Circuit Court Monday through Friday from 8:00 a.m. until 4:00 p.m.

By mail: Send your notarized Petition and two copies, the Order, a certified check or money order for the filing fee, and one (2) self-addressed, stamped envelopes to the address listed above. A date stamped copy of the Petition will be returned to you for your records.

3. Upon filing, the court will assign a Civil Number to your specific case. This is the number by which the Court references your case. The number should appear on all documents regarding your case, and should be used when contacting our office for information.
4. In approximately 3 weeks, if the Judge grants your Order requesting a Name Change, you will receive a certified copy of the Order. At the time of filing, if you know that you would like more than one (1) certified copy of the Order you may pay an extra \$.50 for each page of the Order and \$2.00 (cash or money order) for each certification desired at the time of filing. You may also write our office at a later date requesting certified copies; include the case number, a self-addressed, stamped envelope and a money order for the copies requested.

INFORMATION FOR PETITIONERS WHO DESIRE TO CHANGE THE NAME OF THEIR CHILD OR WARD

1. The consent of BOTH parents must be obtained to change a child's name.
2. If one of the parents does not consent by joining in the Petition, the Petitioner must place the case on the Courts Friday Motions Day Docket without a Judge at 9:00 a.m. The Petitioner must serve the non-joining parent in accordance with Virginia Code Section §8.01-296. The non-joining parent must be served with a copy of the Petition, the proposed Order, and the Praecipe setting the hearing date. If the non-joining parent appears at the hearing to contest the name change, the matter will be heard by a Judge at 10:00 a.m.
3. If the location of one of the parents is unknown, then an Affidavit and Order of Publication must be submitted.
 - A publication can be done in any Newspaper where the Newspaper has been authorized by this Court to print legal notices and publications in accordance with §8.01-324.
 - An Order of Publication shall be published in a newspaper prescribed by the court pursuant to §8.01-317.
 - The Order must be published for four (4) consecutive weeks.
 - The amount of times that the publication is in the newspaper is prescribed by statute.

- C. At time of filing the name change forms, submit the following documentation:
 - Affidavit for Order of Publication
 - Order of Publication
 - A copy of the petition for Name Change to be served by Publication
 - An envelope addressed to the individual being served by publication at their last known address, if known
 - A completed certified mail receipt or registered mail receipt and appropriate fees for such mailing (Certified Mail \$5.00 Registered Letter/Overseas Service \$10.00) ***(Fees subject to change)***
 - Certified check or Money Order payable to the selected Newspaper

- D. Publications for the Washington Times, the Petitioner must submit a check payable to the specific Newspaper. If additional fees are required, the newspaper will bill the petitioner or counsel. For publications in a Newspaper other than the Washington Times, the petitioner must make specific arrangements with that Newspaper. The Court will process the Order of Publication, but the petitioner will make arrangements to have the documentation delivered to the newspaper for publication.
 - E. Following the publication, the newspaper will file a "proof of publication" with the Court.
 - F. The file will be submitted to a Judge. In approximately 3 weeks, if the Judge grants your Order requesting a Name Change for your child, you will receive a certified copy of the Order.
4. If the mother was NOT married at the time of birth and the father's name is NOT on the Birth Certificate, the mother may ADD the father's name to the Birth Certificate and thus change the child's last name to the father's last name. To add the father's name to the Birth Certificate, go to the Joseph Willard Health Center at 3750 Old Lee Highway in Fairfax (Phone 703-246-7100). They will provide you with the forms to add the father's name to the Birth Certificate and to change the child's last name from the mother's to the father's last name.
 5. If the couple were married at the time of birth and the mother did not place the father's name on the Birth Certificate (falsifying records) then a Petition and Order must be submitted to the Court. We strongly suggest that you contact an attorney or complete research at the Fairfax County Law Library located in the Fairfax County Courthouse, third floor.
