## **BOARD MOTIONS**

### **Approval of the FY 2009 Sewer Service Charge and Sewer Availability Fee**

#### **Sewer Service Charges**

The Board approved the amendment to the Fairfax County Code, Chapter 67.1, Article 10, Section 2, Subsection (d) Service Charges to maintain the sewer service charges on a multi year basis as included in the ordinance amendment. The effect of this approval for FY 2009 is a sewer service charge rate of \$4.10 per 1,000 gallons. This is an increase from the FY 2008 service charge of \$3.74 per 1,000 gallons.

#### **Sewer Availability Charges**

The Board approved the amendment to the Fairfax County Code, Chapter 67.1, Article 10, Section 2, Subsection (a) Availability Charges to maintain the availability charges on a multi year basis as included in the ordinance amendment. As a result of this motion, the availability fee for a single family residence increases to \$6,896 from \$6,506 in FY 2008.

## **BOARD MOTIONS**

### **Approval of the Real Property Tax Rate**

Having provided public notice and a public hearing, the Board set the real property tax rate at \$0.92 per \$100 of assessed value. As a result of this action, the real property tax rate for calendar year 2008 will increase by \$0.03 over the real property tax rate for calendar year 2007 of \$0.89 per \$100 of assessed value.

## **BOARD MOTIONS**

### **Approval of the Commercial and Industrial Real Estate Tax for Transportation**

Having conducted a public hearing as required by Virginia law, the Board approved the amendments as advertised to the Code of the County of Fairfax, Virginia, Sections 4-10-5 with an amendment to adopt an additional real property tax rate of \$0.11 per \$100 of assessed value on commercial and industrial property for transportation purposes.

### **Approval of the proposed amendments to the Code of the County of Fairfax, Virginia: Revenue Enhancements**

Having conducted a public hearing as required by Virginia law, the Board approved the amendments as advertised to the Code of the County of Fairfax, Virginia, Sections 4-26-1, to modify Section 4-26-1, Service Charge for Transport by County Emergency Medical Services Vehicle, Section 84.1-3-5, relating to fees for applications for taxi cabs and to fees for the issuance and renewal of licenses for taxi cabs, and Chapter 61, Building Provisions, and Chapter 62, Fire Protection regarding Fire Marshal Fees. The fee increases shall become effective on and after July 1, 2008. Copies of the amended sections of the Code were included in the March 31, 2008 board package.
