

**FAIRFAX COUNTY
TREE PRESERVATION AND PLANTING AWARDS
AS PART OF THE
LAND CONSERVATION AWARDS PROGRAM**

Tree Preservation and Planting Awards are presented in two categories:

1. Awards for **Tree Preservation** are presented to recognize those developers and builders who have done an outstanding job of preserving trees on a project they have constructed. Nominees shall have made a commitment toward tree preservation during the planning stages by designing the project to preserve the maximum number and the most suitable trees possible given the existing resources. This commitment shall have been further demonstrated by ensuring the installation, maintenance and honoring of tree protective devices throughout construction of the project to achieve the planned preservation.
2. Awards for **Tree Planting and Landscaping** are presented to recognize those developers and builders who have done an outstanding job of replacing trees that were unavoidably destroyed due to development. Nominees shall have made a commitment toward tree conservation in planning and implementation by planting the most suitable species and as many trees as possible to replace trees that were unavoidably destroyed due to construction of their project. Planting sites selected to take advantage of energy conservation opportunities will also be taken into consideration in this category.
