

6. Parcel 77-2((1)) 35 is planned for light industrial use up to .25 FAR. It is also appropriate for public park or public open space use. Any additional industrial development in this area should be designed to minimize visual impacts on nearby residential uses and substantial screening, buffering, and barriers should be provided.

Proposed Comprehensive Plan Designation:

6. Parcel 77-2((1)) 35 is owned by the Commonwealth of Virginia and has been set aside as for wetlands mitigation. Any development, such as the constructing of trails or a pedestrian overpass should be designed to minimize visual impacts on nearby residential uses and screening, buffering, and barriers should be provided.
