ORDER AND WRIT OF ELECTION

Whereas, on November 10, 2015, Jeanette Hough was elected as a County At-Large Member of the School Board of Fairfax County, Virginia ("School Board"), for a term of office that commenced on the first day of January 2016 and extends until the first day of January 2020; and

Whereas, Jeanette Hough has tendered her written resignation from the office of County At-Large Member of the School Board effective May 31, 2017, thereby creating a vacancy on the School Board; and


Whereas, in accordance with Va. Code Ann. § 24.2-226, the School Board has petitioned this Court for an order and writ of election to fill the vacancy caused by the resignation of Jeanette Hough from the School Board; and

Whereas, with one exception not applicable here, Va. Code Ann. §§ 15.2-802 provides in the event that the office of a member of the School Board is vacant, the Chief Judge of the Fairfax County Circuit Court shall call a special election in the County to fill that vacancy not fewer than 45 days nor more than 90 days after the occurrence of that vacancy; now, it is therefore

ORDERED pursuant to Va. Code Ann. §§ 24.2-226 and 24.2-682, that (i) a special election shall be held in Fairfax County, Virginia, on Tuesday, August 29, 2017, for the office of County At-Large Member of the School Board for the remainder of the present term of office which extends until January 1, 2020; (ii) the Secretary of the Fairfax County Electoral Board shall publish notice of this special election in accordance with Va. Code Ann. § 24.2-683 and (iii) this special election shall be conducted and the results determined in accordance with Title 24.2 of the Virginia Code; and it is


