



Fairfax County Membership Agreement Wiehle-Reston East Station Bike Room

THIS AGREEMENT is entered into between the County of Fairfax, hereinafter referred to as “The County”, and the member of the Wiehle-Reston East Station Bike Room, hereinafter referred to as “Member”. The Member must be at least 18 years of age.

In consideration of the benefits of using Wiehle-Reston East Station Bike Room and the mutual covenants contained herein, the County and the User agree as follows:

Deposit and Fees: This Agreement commences on _____ and expires on _____ unless payment for a subsequent membership period is received by Fairfax County Department of Transportation within ten (10) days prior to the expiration date. The Member agrees to pay a non-refundable membership fee established by the fee schedule (see fee schedule) plus a one-time application fee of \$15.00.

Termination or Cancellation: The County reserves the right to terminate this Agreement with the Member at any time. Upon termination by action of the County, the Member must remove all items from the room within fifteen (15) calendar days from the mailing date of the notice. The Member may terminate this agreement at any time by providing written notification to: **Fairfax County Department of Transportation, Attention Bicycle Parking Program, 4050 Legato Road, Suite 400, Fairfax, Virginia, 22033-2895**. All personal items must be removed from the room within fifteen calendar days. Electronic access to the facility will be terminated after the fifteen day grace period.

Access and Equipment Registration: The Member will receive one key fob (electronic access device) and three (3) registration decals. All bicycles in the room must have a registration decal affixed to their bicycle. The key fob is non-transferable. In order to maintain room security, the Member agrees not to share their key fob or allow entry by others.

Permitted Use: The Wiehle-Reston East Station Bike Room shall be used only for the purpose of storing a bicycle and personal bicycle-related equipment such as a helmet, jacket or other outer clothing, pack, pump and other cyclist equipment. In the event items other than those specifically permitted are stored in the Bike Room, the County reserves the right to remove those items and terminate this and any Agreement with the User immediately. Upon such termination, items will be held for fourteen (14) days after the effective date of the revocation or expiration. Thereafter, the County and its respective employees, agents, or representatives shall dispose of all such contents as unclaimed property, or take other such action as may be necessary and as may be authorized by applicable law.

Right to Inspect. The Member agrees that no part of the Bike Room interior is considered private space and that there is no expectation of privacy as to anything placed in this facility. The User hereby acknowledges and agrees that the County, the Bicycle Program Coordinator, and their respective employees, agents, or representatives may inspect the Bike Room at any time with or without cause or prior notice.

Removal of Property: If the property of the Member is to be removed for any reason authorized by this agreement, or as otherwise authorized by law, such removal of property shall be effected in accordance with VA.CODE.ANN. SECTION 8.01-156, as amended, or such other provisions that may be applicable at the time

Responsibilities. It is the responsibility of the Member to keep the interior of the room free of debris by placing trash and recyclables in the appropriate provided containers. Members using the fixit stations are responsible for picking up after themselves and properly disposing of any trash. The County will be responsible for trash removal and maintenance/upkeep of the room and all equipment within the room.

Release of Liability. The County is not responsible for any fire, theft, loss, or damage to the Member's bicycle or any other bicycle-related equipment stored in the room. The Member is responsible for properly securing his or her bicycle to the equipment within the room and making reasonable effort to secure the room when exiting. The Member assumes all risk of, and releases the County and its respective officials, employees, and agents from, any liability for any harm, injury, damage, theft or loss that may occur, whether foreseen or unseen, arising out of the use of the locker or any actions taken pursuant to this Agreement
