The Board must pass a resolution to get the signage and VDOT must issue a permit prior to installing the signs. • On County owned roads or private roads proffered to the County, the County can institute parking restrictions if the criteria in County Code 82-5-37 is met. The County Executive has delegated authority to the Director of FCDDOT to authorize the sign installation.
