1. **THREE** (3) plats of the property indicating the location of the stand and distances from all adjacent buildings and structures within 300 feet, two closest fire hydrants, all vehicle access and parking areas, and all lot lines
2. **THREE** (3) copies of a structural plan indicating the dimensions and materials used to construct the stand
3. **THREE** (3) copies of the Certificate of Insurance indicating a MINIMUM of a five million dollar (\$5,000,000.00) liability insurance which applies to the sale and storage of approved permissible fireworks
4. **ONE** (1) notarized and **TWO** (2) copies of a letter from the owner of the property granting permission for the sale of fireworks by the applicant on said property
5. **THREE** (3) copies of an approved Temporary Special Zoning Permit (TSP) or 21-Day Non-RUP for Fairfax County locations or a Temporary Zoning Permit for locations in the Town of Herndon.
6. A check or money order payable to "County of Fairfax" for the amount of \$600.00
7. The wholesale supplier's name and Fire Prevention Code Permit (FPCP) number

Fees for plan review and inspections are included in the Fire Prevention Code Permit (FPCP) Fee

All conditions, surroundings, and arrangements shall be in accordance with the Fire Prevention Code.
