3:00 p.m. Public Hearing on PCA 89-D-007 - FAIRFAX COUNTY SCHOOL BOARD, PCA Appl. to amend the proffers for RZ 89-D-007, previously approved for a public school, to permit an increase in GFA to permit site modifications and building additions with an overall Floor Area Ratio (FAR) of 0.24.
