County Executive Anthony Griffin presented his FY 2012 proposed budget plan to the Human Services Council. He summarized the Board of Supervisors' discussion of the budget that occurred that morning, during which the Board agreed to advertise a proposed tax rate of \$1.09 per \$100 of assessed value—the same rate as FY 2011. A lively discussion by the Human Services Council followed. The Council also approved a budget review work schedule that included two evenings of public testimony and a workshop for the Council members to develop their recommendations to the Board of Supervisors.
