Thank you for your August 6 letter asking for appointments to the Reagan National Airport Community Working Group. I am very pleased to see the Metropolitan Washington Airports Authority taking on the very challenging issue of airport noise.

My office has, too, been hearing from constituents regarding what they see as a new noise intrusion into their neighborhoods from National Airport, particularly in the Dranesville and Mt. Vernon districts. I appreciate that you have asked for specific representation from these two districts. Additionally, I appreciate your consideration of adding an at-large position so Fairfax County as a whole will have representation on the Working Group.

Airport noise from our two airports, National and Dulles International, has been a concern of constituents since the airports were built. Fairfax County has a standing Airports Advisory Committee to keep the Board of Supervisors abreast of constituent concerns and airport policy changes related to aircraft noise. With the recent and expected future changes to the rules governing flights at National, this Working Group has before it an urgent yet long-term mission.

Thank you again for considering the attached nominees for the Reagan National Airport Community Working Group. Please let me know if I can be of assistance.
