FS-M07-26 – Fairfax County Department of Public Works and Environmental Services, 7415 Arlington Boulevard for Thomas Jefferson Community Library

During Commission Matters

Commissioner Hall: I also have a “Feature shown.”

Vice Chairman Alcorn: Great.

Commissioner Hall: And the application number is FS-M07-26. It is for the expansion and renovation of an existing library in Mason District. It’s the Thomas Jefferson Community Library. And I would like to recommend that the PLANNING COMMISSION CONCUR WITH THE DETERMINATION FOR THE RENOVATION AND EXPANSION OF THE THOMAS JEFFERSON COMMUNITY LIBRARY, LOCATED AT 7415 ARLINGTON BOULEVARD, be a determination of Mr. Zook, that it IS IN CONFORMANCE WITH THE RECOMMENDATION OF THE COMPREHENSIVE PLAN AND SHOULD BE CONSIDERED A “FEATURE SHOWN,” PURSUANT TO SECTION 15.2-2232 OF THE *CODE OF VIRGINIA*.

Commissioner Lawrence: Second.

Vice Chairman Alcorn: Seconded by Commissioner Lawrence. Any discussion?

Commissioner de la Fe: Mr. Chairman?

Vice Chairman Alcorn: Mr. de la Fe.

Commissioner de la Fe: I have a question on that.

Vice Chairman Alcorn. Yes.

Commissioner de la Fe: We do show it here as a “feature shown.”

Commissioner Hall: Yes.

Commissioner de la Fe: Okay, it’s a different one. I’m sorry.

Commissioner Hart: It’s totally different. It’s totally different.

Commissioner Harsel: They’re renovating.

Vice Chairman Alcorn: Any additional –

Commissioner Harsel: That's the new renovation.

Commissioner de la Fe: Never mind.

Vice Chairman Alcorn: Any additional discussion?

Commissioner Lawrence: Mr. Chairman?

Vice Chairman Alcorn: Commissioner Lawrence.

Commissioner Lawrence: I think if people will hold the thought about the renovation of that particular library, we have something very nice to offer in a few minutes about that.

Vice Chairman Alcorn: Okay. With bated breath, we'll wait for that. All those in favor of the motion to – and actually we did say, "Seconded by Commissioner Lawrence." All those in favor of the motion to concur with the determination that the proposed "Feature Shown," FS-M07-26, Fairfax County Department of Public Works and Environmental Services, is in conformance with the Comprehensive Plan and consistent with Code Section 15.2232 (*sic*) of the *Code of Virginia*, please say aye.

Commissioners: Aye.

Vice Chairman Alcorn: All those opposed? That motion carries.
