



On 01-21-2016 at around 2215 I was patrolling the area of the Carl Sandburg MS when I observed a group of three male juveniles in the rear of the school. As soon as I turned around, two of the three males that were sitting stood up and ran toward the buses. I then made contact with [REDACTED] who stayed there. I observed the other two running north behind the school into the woods. [REDACTED] indicated that he was at the 711 store in Elkin St earlier and decided to go back home. [REDACTED] claimed that he walks behind the school to cut through a path to make it home. Tobacco residue was found in the area where the two individuals were sitting. This OFC transported [REDACTED] back home in which an oral counseling was held with [REDACTED] and his grandfather [REDACTED]
