Appearance of mailed Pay Advice differs somewhat from online Pay Advice as viewed by logging into your account. However, all data is the same.

Income & Deduction categories vary by individual. Not all Income and Deductions will display on each member's pay advice. Income is on the left side and Deductions are on the right side.

Adjustments such as Pre-Social Security benefits, QDRO payments to a previous spouse, and DROP annuity purchases are now broken out into their own categories. In this new format, most items have their own category which should make your pay advice easier to understand.


