


Directions for Using the Benefit Estimator on the Retirement Systems Website


To use the Benefit Estimator to calculate a Normal Service, Early Service, Deferred Vested, or DROP Estimate, you must first establish an account in Web Member Services.

Visit <http://www.fairfaxcounty.gov/retirement> and click on **Retirement Account Log In**.



- Give the system a minute to divert to secure website outside of County network
- Establish an account with **User Name** and **Password**
- Click the **Log In** button

- From this next screen, click on the link for **Benefit Estimator** and you will see a screen similar to that shown below:



- For “Estimate Type”, in the top drop-down box, choose “**Retirement**”.

- For Projected Dates, click on the **small arrow** and you will see a list of different types of eligibility dates. In order to be eligible for a DROP benefit, you must choose the first option that says “Service Retirement” – you can only enter DROP after that date listed. If you are choosing that first eligible date, to produce your DROP estimate, the two fields below will have populated themselves correctly. If you want to choose a date AFTER your first eligibility date, you can override the date in the 3rd box “Projected Date of Separation”. If you override that date, you must also override the “Projected Payments Beginning Date” by inserting a date one day later than the date above.

- Click the **Continue** button. -
- On this next screen, click the **small arrow** in the “Benefit Type” drop-down window. -
- Select “**DROP Contribution**” to calculate a DROP benefit **OR**
- Select “**Service Retirement**” to calculate a normal service retirement benefit. -
