Reston Update

- Significant growth continues along Silver Line
- 39 major zoning applications approved since 2014
 - 14.1 million square feet of commercial development
 - 13.4 million square feet of residential development
 - \$145 million towards Reston Road Fund, Athletic Fields, and Schools proffered
- 12 major zoning applications currently in process
 - 158 acres across three Transit Station Areas
 - 4.6 million square feet of commercial development
 - 9.5 million square feet of residential development



Description:

Extend Metrorail Silver Line 11.2 miles from Wiehle-Reston East to Route 772 in Ashburn. This rail extension will include the construction of six new rail stations: three in Fairfax County, one at Washington Dulles International Airport, and two in Loudoun County.

Total Project Estimate:


\$2.78 billion

Schedule:

- Overall Phase 2 97% complete
- Package A
 - Rail line, system, and stations 97%
- Package B
 - Rail yard at Dulles 97%
- Contractual Substantial Completion April 2020
 - WMATA Board to establish Revenue






Station Construction

- Reston Town Center Station Installing speakers in ceiling panels. Excavating for utility relocation near Reston Pkwy.
- Herndon Station Installing monitoring equip. in kiosk. Installing pavers at Herndon North Pavilion.
- Innovation Station Installing ceiling panels, completing touch up paint and general cleanup.









Parking Garages

• Herndon Metrorail Station:

- Total project estimate \$44.5 million
- Construction progress 100% complete
- Occupancy permit received April 2019
- Approximately 3,670 parking spaces
- Includes bike room
- Original garage has been renovated
- Replacing the existing bus loop with concrete

Innovation Center Metrorail Station:

- Total project estimate \$52 million
- Construction progress 83%
- Project Completion January 2020
- Approximately 2,100 parking spaces
- Includes bike room

Dulles Corridor Metrorail Projects

Projects	Status
Reston Parkway and Sunrise Valley Drive: Widen eastbound approach to create dual lefts, a thru lane, and a thru-right. Lengthen the northbound left turn lane on to Reston Parkway.	Construction complete. Working on permit closeout.
Sunrise Valley Drive and Herndon Station Site/Roark Drive: Widen eastbound approach to create dual lefts. Add a right-in/right-out entrance for the existing Herndon-Monroe garage assisted by a new right turn lane from Sunrise Valley Drive.	Construction complete. Working on permit closeout.
Sunrise Valley Drive and Edmund Halley Drive: Lengthen the westbound right turn lane and eastbound left turn lane on Sunrise Valley Drive. Upgrade Edmund Halley Drive to VDOT standards, so that it may be accepted into the state system upon completion of Phase 2	Construction complete. Working on permit closeout.

Soapstone Connector

Description:

Extend Soapstone Drive from Sunrise Valley Drive over the Dulles Toll Road (DTR) to Sunset Hills Road. Provide additional multimodal capacity on a new north-south alternative to mitigate congestion on Wiehle Avenue and Reston Parkway.

Total Project Estimate: ~\$214 million

Current Status:

Environmental (NEPA) stage, specifically working on Section 106 and Section 4(f) requirements to identify historical resources and develop avoidance alternatives.

Schedule:

- 2017 2025: environmental, engineering, design
- 2025 2027: right-of-way, land acquisition
- 2027: construction begins








Soapstone Connector Project Status

- Funding agreement between VDOT and Fairfax County for the implementation of the project executed December 19, 2017.
- Current Funding:
 - \$15.5 million in federal RSTP funds.
 - \$ 6.54 million in state Revenue Sharing funds.
 - \$ 122.96 million in local funds
- Grant Applications Submitted:
 - \$69 million requested from NVTA FY20-25 regional SYP. Application submitted September 27, 2019. NVTA is expected to approve final allocations in Spring-Summer 2020.





Soapstone Connector Preferred Improvement Option

Town Center Parkway DTR Underpass

Description:

Extend Town Center Parkway from Sunrise Valley Drive west of Edmund Haley Drive under the DTR to Sunset Hills Road. The facility will also include bike and pedestrian facilities linking the mixed-use areas north and south of the DTR.

Total Project Estimate:

~\$170 million

Schedule:

- VDOT selected consultant for feasibility study
 - Kick off meeting held September 2019
- Environmental, engineering, design: (~) four years
- Right-of-way, land acquisition: (~) two years
- Construction: (~) three years
- Estimated completion by 2032, subject to complete funding





Route 7 Widening (DTR to Reston Avenue)

Description:

Widen Route 7 from 4 to 6 lanes from Jarrett Valley Drive to Reston Avenue, with intersection improvements, shared use trail on both sides of road, and upgraded bus stops.

Total Project Estimate:

\$314 million

Status/Schedule:

- CTB award and NTP to the design-build contractor in July 2018
- 100% design plans complete.
- Third left turn lane from WB Route 7 to Baron Cameron complete.
- ROW Phase in progress.
- Construction start: Spring 2019, and estimated completion: Fall 2024

Hunter Mill Road and Sunset Hills Road Realignment


Description:

Realign Sunset Hills Road to intersect with Crowell Road, and improve Hunter Mill Road from Dulles Toll Road to Crowell Road, with roundabouts as the intersection control.

Status:

- Study completed
- Comprehensive plan amendment changes have been adopted by the board on March 6, 2018
- Plan Amendment (PA) 2017-III-T1

Total Project Estimate and Schedule: TBD





Fairfax County Parkway at Sunrise Valley Drive Interim Improvement

Description:

The purpose of this project is to improve the capacity of the intersection. The intersection currently operates at or near capacity and volumes are forecasted to grow significantly in the future. These improvements include converting the westbound through-left lane to an exclusive through lane, adding an additional westbound turn lane, and converting the northbound right lane to a shared through-right lane, and bike/pedestrian facility enhancements.

Total Project Estimate:

- ~\$12 million
- The Reston Service District Advisory Board and County Board of Supervisors have approved \$500,000 for the project


Status:

- Project is currently in the preliminary engineering phase
- Estimated preliminary engineering completion March 2020





Fairfax County Parkway at Sunrise Valley Drive Interim Improvement (Fairfax County)







Intersection Improvements

Projects	Proposed Funding	Status
Reston Parkway at Sunrise Valley Drive Improve congestion on the westbound approach on Sunrise Valley Drive. Project is contingent on Dulles Rail Phase 2 and developer improvements. Substantial completion of Silver Line developer projects (anticipated Summer 2019).	Service District	Project initiation stage
Reston Parkway at Baron Cameron Avenue Improve congestion on the westbound approach on Baron Cameron Avenue. \$500,000 already approved by the Board based on Service District recommendation.	Service District	Project initiation stage









Reston Multimodal Transportation Advisory Committee and Traffic Monitoring

- County staff met with MTAC twice in 2019
- Received a list of intersections outside TSAs for monitoring. Some were already on County staff's list
- Developing a monitoring plan
- Funding requested in FY 2020 Budget
- County staff provided some information on project priorities
- Waiting for additional information to be provided by Thanksgiving
- Staff will include MTAC recommendations at the spring service district advisory board meeting





March 2019 Meeting Follow Up

- Board adopted an FY 2020 service district tax rate of \$0.021/\$100 validation.
