# Board Authorization

July 14, 2020 - Board of Supervisors (BOS) authorized the consideration of a Comprehensive Plan amendment to update the Public Facilities Element of the Policy Plan and related Area Plans, including reviewing alignment of those updates with the Capital Improvement Program (CIP).

Based on Planning Commission recommendation to the BOS to incorporate the Schools Committee/Schools Board Working Group recommended edits to the Public Facilities Element of the Comprehensive Plan.

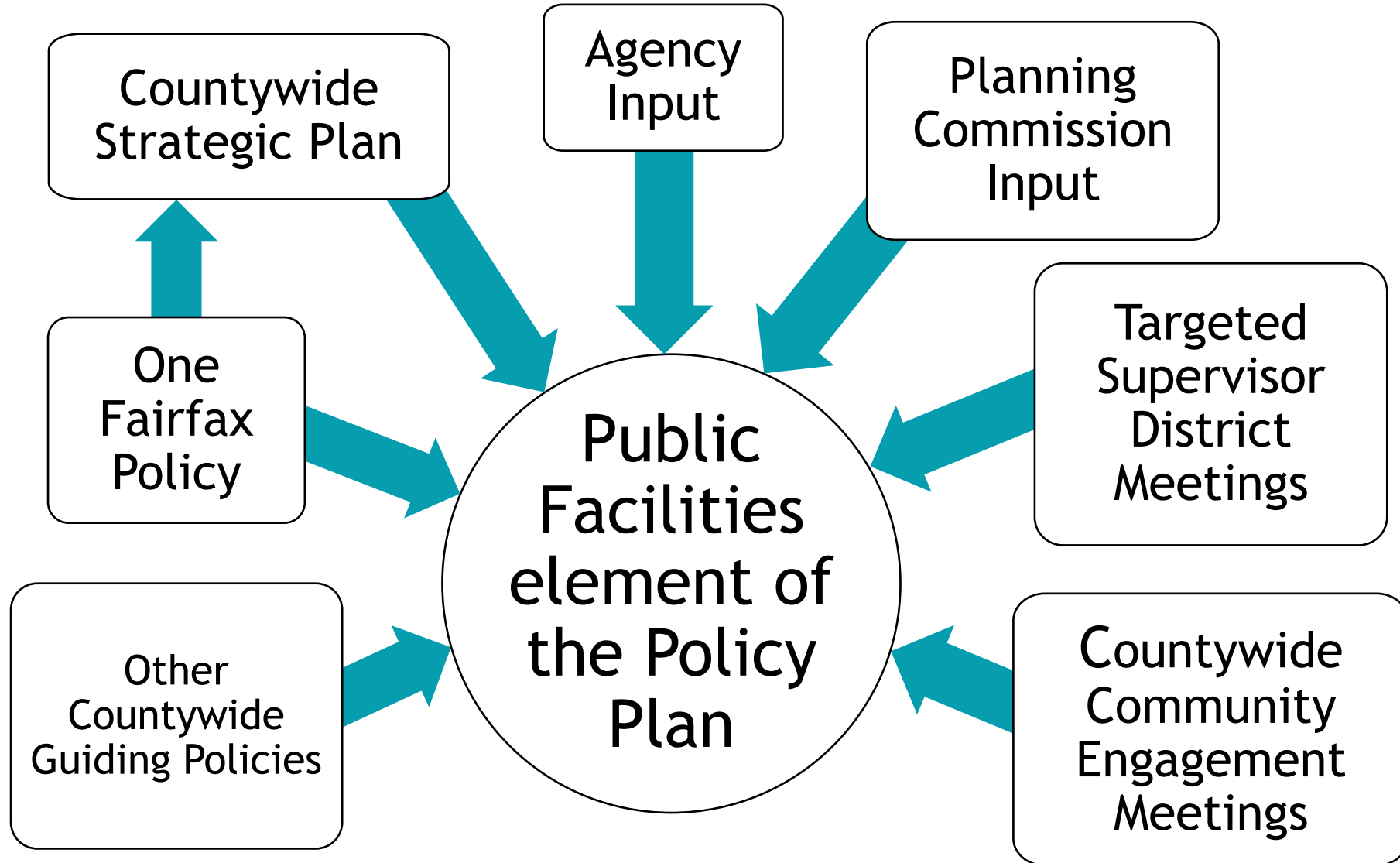

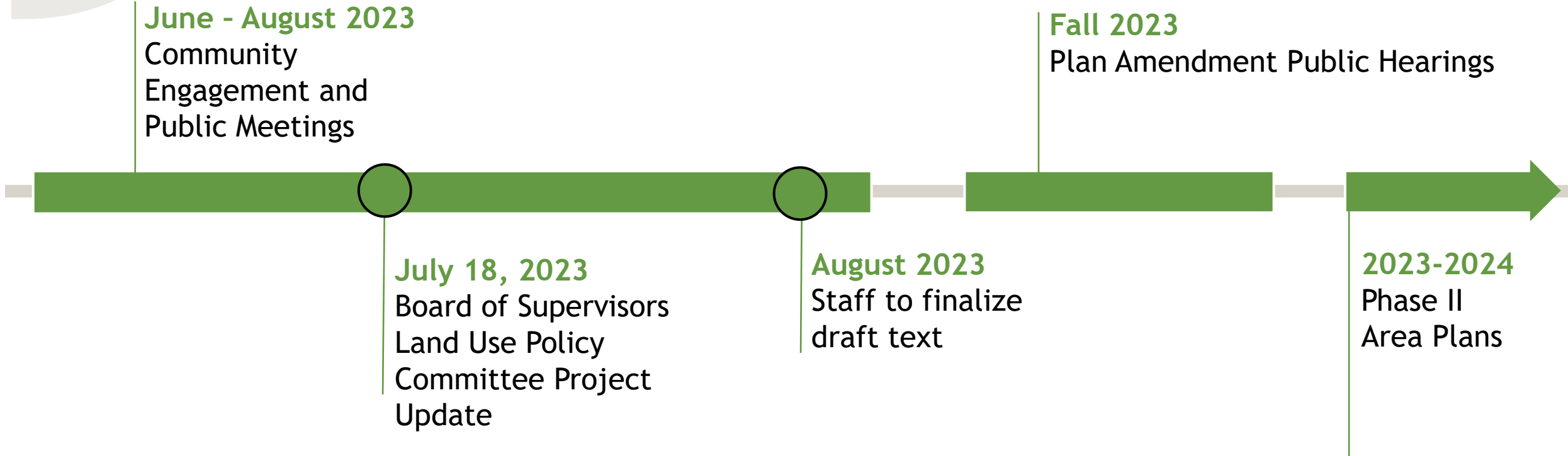
