3:00 p.m. Public Hearing to consider proposed revisions to the Comprehensive Plan for Fairfax County, VA, in accordance with the Code of Virginia, Title 15.2, Chapter 22. Plan Amendment 2015-IV-T1 concerns planned improvements for Newington Road, between Cinderbed Road and Telegraph Road, in the Mount Vernon Supervisor District. The adopted Plan for this area recommends widening Newington Road to 4 lanes, from Loisdale Road to Cinderbed Road (including improving an existing one-lane underpass under the CSX railroad tracks) and improving the 2 lane segment, from Cinderbed Road to Telegraph Road. Specific improvements are unidentified but could include widening, straightening, adding turn lanes, sidewalks, or some combination where necessary. The Trails Plan calls for a major paved trail, west of Cinderbed Road, and a minor paved trail to the east. The Board requested that staff consider the removal of all planned improvements for the segment of Newington Road located between Cinderbed Road and Telegraph Road and analyze the potential impacts of removing these planned improvements. 3:30 p.m. Public hearing on the acquisition of certain land rights necessary for the construction of Project 2G40-028-006, Hunter Mill @ Mystic Meadow Roundabout (Providence District). This project consists of the construction of a roundabout at the intersection of Hunter Mill Road at Mystic Meadow Way and the entrance to the Oakton Community Park. The project will include new pedestrian and bicycle improvements, storm drainage easements, and utility relocations. Plans and plats describing the work proposed to be done and the property interests to be acquired for this project are on file in the Land Acquisition Division of the Department of Public Works and Environmental Services, 12000 Government Center Parkway, Suite 449, Fairfax, Virginia 22035.

3:30 p.m. Public Hearing before the Board of Supervisors of Fairfax County, Virginia, to consider an ordinance to amend and readopt Fairfax County Code Sections 7-2-5 and 7-2-13 relating to Election Precincts and Polling Places to (1) divide Aldrin and North Point precincts to create a new precinct and establish its polling place, (2) move the polling place for North Point precinct, (3) move polling places for McLean, Holmes #1 and Fountainhead precincts, and (4) correct the descriptions of McLean and Kirby precincts. Virginia Code permits the governing body of each county and city to establish by ordinance as many precincts as it deems necessary with one polling place for each precinct. The Board of Supervisors is authorized to change precinct boundaries and polling place locations subject to the requirements of Virginia Code Sections 24.2-305, 24.2-307, 24.2-310 and 24.2-310.1. All active registered voters who are affected by a change in their precinct or polling place will be mailed a notice in advance of the March 1, 2016, Presidential Primary Elections. The proposed ordinance would amend and readopt Sections 7-2-5 and 7-2-13 of the Fairfax County Code to (1) divide Aldrin and North Point precincts to create a new precinct to be named "Armstrong" and to establish its polling place at Armstrong Elementary School located at 11900 Lake Newport Road, Reston; (2) move the polling place for the reconstituted North Point precinct from Armstrong Elementary School to St. Thomas à Becket Catholic Church located at 1421 Wiehle Avenue, Reston; (3) move the polling place for McLean precinct from Lewinsville Center to Lewinsville Presbyterian Church located at 1724 Chain Bridge Road, McLean; (4) move the polling place for Fountainhead precinct from Silverbrook Elementary School to Christ Church located at 7600 Ox Road, Fairfax Station; (5) move the polling place for Holmes #1 precinct from Bailey's Elementary School to the Woodrow Wilson Library located at 6101 Knollwood Drive, Falls Church; and (6) make clerical changes to the descriptions of McLean and Kirby precincts to clarify the boundary between the two precincts (no voters are affected) and to correct the date on which the Board adopted a previous ordinance.
