3:30 p.m. AF 2016-SP-001 - CHARLES E. DYER, TRUSTEE, JOANNE L. DYER, TRUSTEE, DYER LIVING TRUST, Local A&F District Appl. authorized by Chapter 115 (County Code), effective June 30, 1983, to permit to the creation of a local agricultural and forestal district. 4:00 p.m. SEA 88-S-077-07 - GOLDEN BROOK, LLC, SEA Appl. under Sect. 4-604 of the Zoning Ordinance to amend a portion of SE 88-S-077, previously approved for a service station/quick-service food store, car wash, drive-in financial institution, fast-food restaurants, hotel, vehicle rental establishment, and increase in building height, to permit an additional fast food restaurant with drive-thru window, and associated modifications to site design and development conditions. Located at Chantilly Shopping Center, Chantilly, 20151, on approx. 1.41 ac. of land zoned C-6, WS. Sully District. Tax Map 44-1 ((9)) 6.

Public hearing to consider an ordinance to amend and readopt Fairfax County Code 4:00 p.m. Sections 7-2-5, 7-2-10, and 7-2-13 relating to Election Precincts and Polling Places to (1) rename Terraset precinct; (2) relocate the polling place for Chesterbrook precinct; (3) relocate the polling place for Huntley precinct; (4) divide Tysons precinct to add a new precinct and establish its polling place; and (5) change the name of the polling place for Fair Oaks precinct. Virginia Code permits the governing body of each county and city to establish by ordinance as many precincts as it deems necessary with one polling place for each precinct. The Board of Supervisors is authorized to change precinct boundaries and polling place locations subject to the requirements of Virginia Code Sections 24.2-305, 24.2-307, 24.2-310 and 24.2-310.1. All active registered voters who are affected by a change in their precinct or polling place will be mailed a notice in advance of the November 8, 2016, General and Special Elections. The proposed ordinance would amend and readopt Sections 7-2-5, 7-2-10, and 7-2-13 of the Fairfax County Code to (1) change the name of Terraset precinct to "Hughes" to match the name of the polling location at Hughes Middle School; (2) move the polling place for Chesterbrook precinct from Arleigh Burke Pavilion to Vinson Hall, located at 6251 Old Dominion Drive, McLean; (3) move the polling place for Huntley precinct from Groveton Elementary School to St. Mark's Episcopal Church located at 6744 South Kings Highway, Alexandria; (4) divide the Tysons precinct to create a new precinct to be named "Rotonda" and establish its polling place at the Rotonda Condominiums Community Center, 8352 Greensboro Drive, McLean; and (5) change the name of the polling place for Fair Oaks precinct from Fair Oaks Church Rec Center to Expectation Church Rec Center. 4:00 p.m. Public hearing regarding the proposed revision to Chapter 3, Articles 2 and 3, of *The Code of the County of Fairfax*; *Virginia*, to revise service-connected disability benefits provided by the Uniformed and Employees' Retirement Systems by reducing the offset for Social Security benefits.

4:00 p.m. Public hearing on the matter of an amendment to Chapter 82 of the 1976 Code of the County of Fairfax (County Code) as set forth below, and the adoption of Rules and Regulations for Mobile Food Vending as follows: To amend Section 82-1-30(a) of the County Code to allow for mobile food vending from authorized public streets within Tysons in accordance with a valid Food Establishment Permit for mobile food vending, with the Virginia Department of Transportation Land Use Permit for Mobile Food Vending, once issued to Fairfax County, and in accordance with rules

and regulations adopted by the Board of Supervisors. The amendment may include regulations on where mobile food vendors may operate, when operations may be suspended, how mobile food vending zones may be established, delegation of authority to select streets within food truck zones, regulations regarding civil liability, restrictions on the type of food truck permitted, and other requirements. The amendment may also include regulations on the hours of operations, length of vending time permitted, waste disposal requirements, insurance requirements, location(s) of vending, and other related provisions. To the extent not included in the amendment to Chapter 82, any such regulations may be adopted in the form of Rules and Regulations to be enforced by the Fairfax County Department of Health.
