BOARD MATTERS

1. <u>AUGUST RECESS</u> (9:36 a.m.)

Chairman Bulova announced that this is the last Board meeting before the August recess.

2. <u>MOMENT OF SILENCE</u> (9:36 a.m.)

Chairman Bulova asked everyone to keep in thoughts Mr. John Yeatman and family. Mr. Yeatman is the former director of the Real Estate Division of the Department of Tax Administration, and a current member of the Board of Equalization. His wife, Nicole Yeatman, died recently, following a long and very courageous fight with cancer. She was a longtime County employee who retired from the Department of Planning and Zoning.

Chairman Bulova also asked everyone to keep in thoughts the family of Mr. Ed Tennyson, who died recently of cancer, at the age of 92. He was a member of the Transportation Advisory Commission (TAC). He was a renowned transit engineer and was a great advocate for electric transit and all transit. He was a staple in the transportation community and will be sorely missed.

Supervisor Hudgins said that Mr. Tennyson was persistent in remaining a transportation professional to his very last days, which is a tribute to his integrity and commitment to his profession and his community. He served on many County commissions.

Chairman Bulova asked everyone to keep in thoughts Ms. Teddy Goodson, who died recently. Chairman Bulova said she did not have any other details, but noted that she was a very politically active member of the community.

Supervisor Foust and Supervisor Hyland jointly seconded the motion and it carried by unanimous vote.

4. <u>CERTIFICATE OF RECOGNITION PRESENTED TO THE FIRE AND</u> <u>RESCUE DEPARTMENT (FRD)</u> (9:47 a.m.)

Chairman Bulova relinquished the Chair to Vice-Chairman Gross and moved approval of the Certificate of Recognition presented to the FRD for its extraordinary and heroic efforts for more than eight hours to extricate a victim buried up to the chest in a 20-foot deep trench as it continued to collapse. Supervisor Herrity and Supervisor Hyland jointly seconded the motion and it carried by unanimous vote.

Chairman Bulova noted that she and Supervisor Herrity attended the FRD Recruitment Class graduation ceremony and it was the largest class ever, thanks in part to the SAFER grant.

Vice-Chairman Gross returned the gavel to Chairman Bulova.

14. **ADMINISTRATIVE ITEMS** (11:48 a.m.)

Supervisor Gross moved approval of the Administrative Items including two additions: <u>Admin 16 - Authorization for the Fairfax-Falls Church Community</u> Services Board (CSB) to Apply for and Accept Grant Funding from the Virginia Department of Behavioral Health and Developmental Services (VDBHDS) for the Young Adult Services Initiative Grant and <u>Admin 17 – Authorization for the Department of Transportation to Apply for the 2014-2015 Virginia Federal Action Contingency Trust (FACT) Fund Grant Program</u>. Supervisor McKay seconded the motion.

Chairman Bulova called the Board's attention to <u>Admin 13 - Authorization to</u> <u>Advertise a Public Hearing to Amend the Current Appropriation Level in the</u> <u>Fiscal Year (FY) 2015 Revised Budget Plan</u>. She announced that there will be a Budget Committee meeting on September 2; the agenda for that meeting will include discussion of:

- The Carryover Review package
- A request from the Schools to address, in partnership with the Board, full-day Mondays

She noted that these issues will also be the subject of discussion at tomorrow's meeting of the Board's Joint Budget Development Committee. Discussion ensued concerning the meeting agenda.

Supervisor Smyth called the Board's attention to <u>Admin 3 - Authorization to</u> <u>Advertise a Public Hearing to Sublease Board-Leased Property at 2667 Prosperity</u> <u>Avenue to the Fairfax Symphony Orchestra and Admin 4 - Authorization to</u> <u>Advertise a Public Hearing to Sublease Board-Leased Property at 2667 Prosperity</u> <u>Avenue to the Arts Council of Fairfax County</u>. She noted that the space will not be ready until the end of August with a move-in date in September, after the public hearing.

Supervisor Smyth called the Board's attention to <u>Admin 9 – Authorization to</u> <u>Advertise Public Hearings on Proposed Amendments to the Code of the County</u> <u>of Fairfax, Chapter 112 (Zoning Ordinance), Regarding Telecommunication</u> Facilities - Modifications to Permit Antennas and Related Equipment on Existing or Replacement Utility Poles or Light/Camera Standards. She noted that since this item concerns by-right changes on equipment cabinets, however, the proposed amendment contains no reference about potential conflicts with sight-lines.

Discussion ensued, with input from Andrew B. Hushour, Deputy Zoning Administrator, Department of Planning and Zoning (DPZ), concerning:

- Current Zoning Ordinance provisions and Virginia Department of Transportation (VDOT) distance sight requirements
- Placement of cabinets in residential neighborhoods

Mr. Hushour stated that DPZ will address these concerns prior to the public hearing.

Supervisor Herrity called the Board's attention to <u>Admin 15 – Authorization for the</u> <u>Health Department to Apply for and Accept Grant Funding from the Centers for</u> <u>Disease Control and Prevention (CDC)</u>, <u>Partnerships to Improve Community Health</u> <u>(PICH)</u>. Discussion ensued concerning the cost to the County for the new positions, including fringe benefit and indirect costs, with input from Sharon Arndt, Director, Community Transformation Project, Department of Neighborhood and Community Services, and Joseph M. Mondoro, Deputy Director, Department of Management and Budget, providing a breakdown of costs.

Supervisor Gross called the Board's attention to <u>Admin 4 – Authorization to</u> <u>Advertise a Public Hearing to Sublease Board-Leased Property at 2667 Prosperity</u> <u>Avenue to the Arts Council of Fairfax County</u>. Discussion ensued concerning the lease restrictions, specifically the placement of public art on the building or grounds, with input from Marguerite Guarino, Assistant Director, Real Estate, Facilities Management Department. Supervisor Smyth noted that the agreement with the proffered space does not include outside space; that is private property.

Supervisor Cook called the Board's attention to several grant applications that have been submitted prior to Board approval. He stated that this is an issue the Board has previously discussed and reiterated the need for the Board to have timely access to the consideration of such items.

Supervisor Cook called the Board's attention to <u>Admin 14 – Authorization for the</u> <u>Fairfax County Police Department (FCPD) to Apply for and Accept Grant Funding</u> from the US Department of Justice (DOJ), Office of Community Policing Services (<u>Cops</u>), <u>Cops Hiring Program</u>. Discussion ensued, with input from Edward L. Long Jr., County Executive, concerning:

- Additional County funds that are required to be spent if this grant is awarded
- The County's five-year public safety staffing plan

Supervisor Cook asked unanimous consent that the Board direct staff to include on the agenda for the September 2 Committee meeting, consideration of recommendations from the Infrastructure Finance Committee, including the infrastructure sinking fund and clarification of the 20 percent of unencumbered Carryover funds and how that is calculated. Without objection, it was so ordered.

Supervisor Smyth raised a question concerning the Invasive Management Area (IMA) contribution in Carryover and inclusion of this funding in the Park Authority's regular budget as it is an on-going program and maintains Park land. Chairman Bulova relinquished the Chair to Vice-Chairman Gross and asked unanimous consent that the Board direct staff to include this issue on the September 2 Committee meeting agenda. Without objection, it was so ordered.

Vice-Chairman Gross returned the gavel to Chairman Bulova.

Following additional discussion, Supervisor Gross asked unanimous consent that the Board direct the County Executive to provide a status report, prior to the September 2 Committee meeting, regarding the history of Board discussion; actions, including those by staff; requests; and directives related to Carryover. Without objection, it was so ordered.

Following additional discussion regarding the Carryover package, including recommendations by the County Executive and identification of monies saved through close management initiatives, the question was called on the motion and it carried by unanimous vote, Supervisor Cook, Supervisor Foust, Supervisor Frey, Supervisor Gross, Supervisor Herrity, Supervisor Hudgins, Supervisor Hyland, Supervisor McKay, Supervisor Smyth, and Chairman Bulova voting "AYE."

32. REQUEST TO WAIVE PERMIT AND INSPECTION FEES FOR THE 2015 WORLD POLICE AND FIRE GAMES (12:33 p.m.)

Supervisor McKay said, as the Board is aware, the World Police and Fire Games, the largest sporting event of its kind, will be held in the County next summer. This event is huge, and size and scope of the games continues to grow, with both the attendance and number of participating countries steadily increasing. It is projected to draw 15,000 to 30,000 competitors and visitors to the County and its environs during this 10-day event.

These games would put the County on the map, were it not already on numerous maps for the excellent schools, economic stability, amenities, and the numerous other elements that ensure enviable quality of life. Many participants and visitors will experience that quality of life, and in doing so provide an economic windfall as they remain in the area or arrive early to vacation here.

To create the venues required to host such an event, Fairfax 2015, Incorporated, is a dedicated group of volunteers tasked with organizing the events at a variety of locations both inside and outside of the County. Key to these preparations is obtaining the necessary building and trade permits for construction of the games' facilities. Fairfax 2015, Incorporated, has agreed to assume the costs of these permits.

Supervisor McKay said that after consulting with the County Attorney regarding waiving the fees associated with building, electrical, and other similar permits for the World Police and Fire Games, he was advised that Fairfax 2015, Incorporated, is a 501(c)(3) corporation and such permit fees may be waived.

Therefore, Supervisor McKay moved that the Board direct the County Executive to advise all County agencies that Fairfax 2015, Incorporated, not be charged permit and inspection fees for the World Police and Fire Games. Chairman Bulova seconded the motion and it carried by unanimous vote.

33. <u>REQUEST TO EXTEND THE STREET NAME JEFF TODD WAY TO</u> <u>THE SEGMENT OF ROUTE 619 FROM POLE ROAD TO TELEGRAPH</u> <u>ROAD CURRENTLY KNOWN AS MULLIGAN ROAD (LEE DISTRICT)</u> (12:35 p.m.)

In a joint Board Matter with Supervisor Hyland, Supervisor McKay said that in 2012, the Board approved renaming a section of Route 619 between Richmond Highway and Pole Road, formerly known as Old Mill Road and later Mulligan Road, as Jeff Todd Way in commemoration of an extraordinary individual whose untimely death in August 2011 was a real blow to the Mount Vernon and Lee communities.

Mr. Todd was a towering presence in the County, especially in South County. A successful entrepreneur who owned and operated several Roy Rogers family

restaurants in Mount Vernon and Lee, he was a civic leader as well as a business one.

Supervisor McKay noted that Mr. Todd chaired the Mount Vernon Lee Chamber of Commerce, served on the boards of numerous nonprofit organizations such as Good Shepherd Housing and UCM, and provided free meals to civic volunteers. Mr. Todd also gave his time and talents to Mount Vernon High School athletics, sponsored the annual Roy Rogers Bowl, participated in the Mount Vernon Men of Vision and Purpose Program that supports at-risk students, collected money and toys for local charities, held fundraisers for local schools, and actively encouraged other businesses to give back to the community.

Supervisor McKay expressed the opinion that it is fitting that this critically important connecting road be named for an individual who, himself, created connections.

Supervisor McKay said he has discussed this matter with the office of the Director of the Department of Public Works and Environmental Services.

Therefore, Supervisor McKay moved that the Board direct staff to extend the street name Jeff Todd Way to the segment of Route 619 from Pole Road to Telegraph Road currently known as Mulligan Road, so the entire Route 619 from Route 1 to Telegraph Road would be known as Jeff Todd Way. Supervisor Hyland seconded the motion and it carried by unanimous vote.

34. <u>ENCLOSING TRASH CONTAINERS (LEE AND MOUNT VERNON</u> <u>DISTRICTS)</u> (12:36 p.m.)

In a joint Board Matter with Supervisor Gross and Supervisor Hyland, Supervisor McKay said that since the 1970's, the County has implemented ordinances and best management practices to protect its waterways. Currently, new zoning applications and site plan submissions are required to enclose trash containers to keep the waterways free of litter. However, legacy sites do not have these requirements. Of particular concern is the area along the length of Richmond Highway where older sites have trash containers adjacent to storm drains and other areas that have direct links to County creeks, streams, rivers, and lakes.

Every year during trash clean up events, volunteers remove hundreds of tons of trash from the waterways. However, their good work is often undercut by the presence of trash containers in the vicinity of storm drains that feed into the waterways. Not only does this litter affect the quality of life of the area's residents, but as it washes down the storm drains of Richmond Highway. This litter makes its way to Quander Brook, Cameron Run, the Potomac River, and ultimately the Chesapeake Bay.

After consulting with the County Attorney's office, it was confirmed that the County has the authority to regulate the location of trash containers. Under

Virginia Code Section15.2-928, "[a]ny locality may . . . regulate the times and placement of waste and waste containers set out for collection, such regulation to require notice as to allow removal by the owner of the waste or waste containers prior to imposition of a civil penalty."

Supervisor McKay expressed the opinion that it is incumbent to adopt such an ordinance to protect not only the County's delicate ecosystems and resources but also the larger region and the Chesapeake Bay. Not only will this be a major step to protect the environment, but such an ordinance will also have a positive impact on the bottom line, reducing the costs associated with park and waterway maintenance.

Therefore, jointly with Supervisor Hyland, Supervisor McKay moved that the Board direct staff report with best practices recommendations and proposed ordinance language for trash container placement that establishes a minimum distance between the location of a trash container and a storm drain or waterway. Supervisor Gross and Supervisor Hyland jointly seconded the motion.

Following discussion regarding a timeframe, Supervisor McKay amended his motion to direct staff to report with the information prior to the end of the year, and this was accepted.

Supervisor Herrity asked to amend the motion to direct staff to provide outreach efforts to industry as well, and this was accepted.

The question was called on the motion, as amended, and it carried by unanimous vote.

35. FEDERATION OF CITIZENS ASSOCIATIONS RESOLUTION – JOINT BOARD/FAIRFAX COUNTY PUBLIC SCHOOLS INFRASTRUCTURE FINANCING COMMITTEE (12:41 p.m.)

Supervisor McKay said that the joint Board of Supervisors/Fairfax County Public Schools Infrastructure Financing Committee (originally called the Capital Facilities and Debt Management Working Group) was established in April 2013 as a working group to collaborate and review both the County and School's capital needs.

One of the challenges of this committee has been to understand the different methodologies, criteria, and rating systems used by the County and Schools to determine the conditions of facilities and assess renovation priorities.

Recently, Board Members received a resolution passed by the Fairfax County Federation of Citizens Associations. That resolution commends both boards for their cooperation in addressing County and Schools facility needs and asks both boards to continue to work together. The resolution makes several specific recommendations. Therefore, Supervisor McKay moved that the Board direct staff to provide the resolution to the County Executive and the Fairfax County Public Schools Superintendent for review and feedback. Chairman Bulova seconded the motion and it carried by unanimous vote.

36. <u>MARCH OVER THE VETERANS BRIDGE – THE BRIDGEWALK (LEE</u> <u>DISTRICT)</u> (12:42 p.m.)

Supervisor McKay said that on Tuesday, August 26, at 7:30 p.m., members of the Springfield community will march over Veterans Bridge in the heart of the Springfield revitalization district and hold a community celebration at the American Legion end of the bridge. The celebration will feature music, food from local restaurants, and—quite possibly—a few notables will feel the urge to say a few words.

This year's BridgeWalk will be the thirteenth annual and will continue the tradition of renewing the Army/Community Covenant signing that began in 2009. The covenant is an affirmation of support by State and local communities to active, guard, and reserve service members and their families.

Supervisor McKay said that local elementary schools—Garfield, Crestwood, and Lynbrook—have always been enthusiastic participants of this event and he looks forward to their participation again this year.

The BridgeWalk is a community building event that began 13 years ago to mark the installation of new lighting on Veteran's Bridge in central Springfield. Veterans Bridge (also known as the Amherst Avenue Bridge) crosses over Old Keene Mill Road and links both sides of Springfield's commercial revitalization area. The bridge is a gateway to central Springfield. With its acorn lights, wide sidewalks, pedestrian stairway, and attractive façade, it dovetails nicely with the community's vision for a revitalized Springfield and is an attractive gateway to the central business district.

Supervisor McKay invited his colleagues to join him on August 26 and experience how they celebrate community in Lee District.

Supervisor McKay asked unanimous consent that the Board direct the Office of Public Affairs to advertise this event. Without objection, it was so ordered.

37. REQUEST FOR RECOGNITION OF MS. CAROLE KIHM – 2014 OUTSTANDING MIDDLE SCHOOL PRINCIPAL OF VIRGINIA (DRANESVILLE DISTRICT) (12:44 p.m.)

Supervisor Foust announced that Carole Kihm has been named the 2014 Outstanding Middle School Principal of Virginia by the Virginia Association of Secondary School Principals. Ms. Kihm has served as principal of Longfellow

Middle School in McLean since May 2008. Previously Ms. Kihm won the Fairfax County Public Schools First-Year Principal of the Year award in 2009.

Ms. Kihm is praised as being a collaborative and innovative leader who spends most of her time in classroom observations, providing immediate feedback to teachers. She is encouraging of students' involvement in after-school programs. Over half of the students at Longfellow participate in one of 38 clubs, including the Homework Club, designed to help students improve their grades. During her tenure, the school created a rain garden with cistern and vegetable garden to promote environmental education and stewardship.

One of her most significant achievements was improving the performance of students on the Virginia Standards of Learning math tests. As a result of changes she implemented, the pass rate for economically disadvantaged students rose from 73 to 92 percent; from 63 to 91 percent for students with disabilities; and 62 to 91 for African-American students the following year. As is characteristic of Ms. Kihm, she credits the rise in test scores to a "total team effort."

Therefore, Supervisor Foust asked unanimous consent that the Board direct staff to invite Ms. Kihm, along with her family and school officials, to appear before the Board on September 23, 2014, to be recognized for her significant achievements. Without objection, it was so ordered.

A brief discussion ensued, with input from Tony Castrilli, Director, Office of Public Affairs, regarding the number of presentations scheduled for September 23.

REQUEST FOR RECOGNITION OF MR. DOUG DOWNER AND HERNDON DULLES CHAMBER OF COMMERCE FRIDAY NIGHT LIVE COMMITTEE (DRANESVILLE DISTRICT) (12:45 p.m.)

Supervisor Foust said that since 1994, there have been free outdoor concerts on the Herndon Town Green every Friday evening during the summer months. The man behind the concerts is Mr. Doug Downer who initiated the concert series 20 years ago. Mr. Downer and the Herndon Dulles Chamber of Commerce Friday Night Live Committee organize and run the concert program, which provides a safe and relaxing family friendly venue for residents and visitors to the Herndon area.

Tip money from beverage sales is donated to the Herndon High School Drug and Alcohol-Free Celebration Committee for the All Night Grad party. Proceeds from "glow necklaces" are presented to the Parent-Teacher organizations of four elementary schools in Herndon. Other organizations that have benefited from contributions include: Herndon Optimist Club, Veterans Memorial Fund, Boy Scouts of America, Herndon High School Girls Softball, and the Town of Herndon. Therefore, Supervisor Foust asked unanimous consent that the Board direct staff to invite Mr. Downer, Founder and Chair of the Herndon Dulles Chamber of Commerce Friday Night Live Committee, and his team of hard-working volunteers, to appear before the Board on October 28, 2014, to be recognized for their excellent work on behalf of the community. Without objection, it was so ordered.

39.

REQUEST FOR RECOGNITION OF POLICE OFFICER FIRST CLASS SCOTT DAVIS – SCHOOL RESOURCE OFFICER AT McLEAN HIGH SCHOOL (DRANESVILLE DISTRICT) (12:46 p.m.)

Supervisor Foust announced that Police Officer First Class Scott Davis, who serves as the School Resource Officer at McLean High School, has been named the 2014 Fairfax County Public Schools (FCPS) Distinguished School Resource Officer.

Officer Davis is an active member of the school community and has developed and implemented safety programs in the school. He routinely attends after-school events. Nominators say he is routinely viewed by students as a role model, mentor, and friend. Students and parents feel comfortable bringing to him any matters of concern, even at 2 a.m.

Therefore, Supervisor Foust asked unanimous consent that the Board direct staff to invite Officer Davis to appear before the Board on September 23 to be recognized for his outstanding service to students of the County. Without objection, it was so ordered.

40. REQUEST FOR RECOGNITION OF THE SEVENTY-FIFTH ANNIVERSARY OF THE HERNDON WOMEN'S CLUB (DRANESVILLE DISTRICT) (12:47 p.m.)

Supervisor Foust said that for 75 years, the Herndon Women's Club has been giving back to the community. The Club was formed originally in 1939 as the Junior Woman's Club of Herndon, sponsored by the Herndon Fortnightly Club. At that time, federated state rules limited membership to single women 25 and under. Today, the club has no limit on age or marital status.

The Herndon Women's Club has served as an instrumental part of the Herndon community. During World War II, club members rolled bandages to raise money and sent wedding gowns to war brides in England.

Since 1947, the club has presented an Outstanding Girl Athlete award to a Herndon High School student; and since 1963, has given a scholarship to a Herndon High School senior. The club annually sends a Herndon high school sophomore to the Hugh O'Brian Youth Leadership (HOBY) State conference.

The club also sends a special needs child to Camp Easter Seal and has been a major contributor to LINK, providing food for the hungry in the Herndon and Sterling area. This year, the GFWC Signature Project is Domestic Violence Prevention.

Supervisor Foust asked unanimous consent that the Board direct staff to invite Club President Pat Stark and members of Herndon Women's Club to appear before the Board on September 23, 2014, to be recognized for their contributions to the Herndon community for the past 75 years of service. Without objection, it was so ordered.

41. <u>ADDRESS CHANGES REQUESTED - THE MERIDIAN GROUP</u> (PROVIDENCE DISTRICT) (12:49 p.m.)

Supervisor Smyth said that the Meridian Group recently purchased three office buildings on the former SAIC Tysons campus located at Tax Maps 29-3((15)) 4E1, 4F1 and 4G. The Meridian Group has requested that the Board help change the addresses of the buildings to better reflect the new mix of tenants now occupying two of the three buildings.

Therefore, Supervisor Smyth moved that the Board direct the Department of Public Works and Environmental Services (DPWES) to make the following address changes for properties identified as Tax Map 29-3 ((15)) 4E1, 4F1 and 4G:

- Parcel 4F1 Change the address from 1707 SAIC Drive to 1710 SAIC Drive
- Parcel 4E1 Change the address from 1710 SAIC Drive to 1700 Greensboro Station Place
- Parcel 4G Change the address from 1709 SAIC Drive to 1705 Greensboro Station Place

This motion recognizes that the final building numbers of the new Greensboro Station Place buildings could change based on the standard numbering convention that DPWES staff utilizes. Supervisor Herrity seconded the motion and it carried by a vote of nine.

42. <u>PARKING SIGNS AT OAK MARR RECREATION CENTER</u> (PROVIDENCE DISTRICT) (12:50 p.m.)

Supervisor Smyth said it came to her attention, with the renovations to the Oak Marr Recreation Center, that there are concerns with the new parking signage in front of the building. She noted that new parking signage is about LEED certification and it sets up nine parking spaces as hybrid/alternative fuel. There

are 11 handicap parking spaces and some of those spaces are further from the door than some of the hybrid/alternative fuel spaces.

Supervisor Smyth asked unanimous consent that the Board direct the County Executive to revisit the action the Board previously took in a similar situation in December 2011 and determine if the same options can be applied to this situation. Without objection, it was so ordered.

43. NATIONAL PAYROLL WEEK - JULY 29, 2014 (12:53 p.m.)

Supervisor Gross said that most employees take for granted that they will be paid on time, correctly, each and every pay day, but it is payroll professionals who attend to all of the details and tax compliance requirements to ensure that it happens. In the County, expert professional employees handle the myriad of requirements for more than 11,000 County employees.

Supervisor Gross announced that National Payroll Week appropriately falls during the same week in which the nation observes Labor Day and she asked unanimous consent that the Board:

- Proclaim the week of September 1, 2014, as *"Payroll Week"* in Fairfax County
- Direct staff to prepare an appropriate proclamation to be presented at a later date

Without objection, it was so ordered.

(NOTE: Later in the meeting, there was an additional item regarding National Payroll Week. See Clerk's Summary Item #46.)

44. <u>CODE COMPLIANCE CONFERENCE FOR COMMUNITY AND</u> <u>NEIGHBORHOOD LEADERS</u> (12:55 p.m.)

In a joint Board Matter with Supervisor McKay, Supervisor Gross said that in 2007, the Board established Code Enforcement Strike Teams to help address a proliferation of illegal boarding houses in the County. During the following three years, Strike Team members investigated and resolved more than 700 of these very difficult cases, while also conducting more than 70 community outreach and education events. The collaborative effort by cross-agency personnel was so successful that, in 2010, code enforcement functions were consolidated into a new agency, the Department of Code Compliance (DCC). Deputy County Executive Robert Stalzer was instrumental in helping DCC improve services by enhancing customer service and intake processes, cross-training technical staff to promote code efficiencies, improve collaboration with sister agencies, and promote code compliance in the community by outreach and education.

Supervisor Gross noted that DCC continues to refine its mission and processes to best meet the needs and trends in the community. It also continues to conduct numerous ad hoc community and outreach sessions each year, sessions that many have been able to participate in. She added that a Code Compliance Conference could help educate community leaders about how DCC and the County can work with them to recognize and address many differing neighborhood trends and challenges.

Therefore, Supervisor Gross moved that the Board direct the County Executive to work with the staff of DCC and other relevant agencies to plan and conduct a Code Compliance Conference, as soon as feasible, to educate and collaborate with numerous and diverse community and neighborhood leaders. If successful, and as resources allow, staff should also look at conducting similar sessions on a regular basis in the future. Supervisor McKay and Chairman Bulova jointly seconded the motion and it carried by unanimous vote.

45. <u>COUNTY CONVENTION AND VISITORS CORPORATION'S</u> <u>"FOUNDING FATHERS CAMPAIGN"</u> (12:58 p.m.)

Supervisor Herrity said in 2013, residents of Philadelphia, New York City, and the District of Columbia were surprised when posters of the Founding Fathers greeted them at bus stops, train stations, and parks. These posters, with a QR code in place of the Founders' mouths, were scanned by curious onlookers who were treated to a video version of the mouth that talked about the County. The Founding Fathers Campaign, the brain child of the County Convention and Visitors Corporation, Visit Fairfax, went viral and received more than 16 million media impressions earning them nearly 1,000 new Facebook followers and over 17,000 consumer actions. A rough estimate indicates that this single campaign brought over \$5 million in new visitor spending to the County, representing a 110 to 1 return on investment. Needless to say, the Founding Fathers Campaign was an immense success,

As a further testament to the success, Visit Fairfax received 16 national awards for this campaign including two Gold National American Advertising Federation ADDY Awards, one Platinum award and the Best of Show at the 2013 Hospitality Sales and Marketing Association International Adrian awards. Other accolades include three HSMAI Gold Adrian awards and one Silver Adrian, two Gold District AAF ADDY awards, five local Washington, DC area AAF ADDY awards and a 2014 Virginia Association of Convention and Visitors Bureaus Virgo award.

Therefore, Supervisor Herrity asked unanimous consent that the Board direct staff to invite representatives from Visit Fairfax to appear before the Board to receive a resolution congratulating it for the immensely successful "Founding Fathers Campaign." Without objection, it was so ordered.

46. **PAYROLL PROFESSIONALS DAY** (1 p.m.)

(NOTE: Earlier in the meeting, there was an item regarding National Payroll Week. See Clerk's Summary Item #43.)

Supervisor Herrity said that this year, the County will host the annual conference of the Virginia chapter of the American Payroll Association. The conference will be October 9-10 and will feature hundreds of payroll professionals from across the Commonwealth.

Although not frequently recognized, payroll professionals are one of the most critical groups in any business, government, and non-profit. Human capital is the backbone of every organization and payroll professionals ensure that human capital is taken care of. Being a payroll professional can be a thankless job, much like public servants; people often don't think to call the payroll department until there is a problem. It is great to see the County hosting this conference and recognizing the contributions of payroll professionals.

Therefore, Supervisor Herrity asked unanimous consent that the Board declare October 9, 2014, as "Payroll Professionals Day" in Fairfax County and that a resolution be presented to the Virginia chapter of the American Payroll Association. Without objection, it was so ordered.

47. <u>SICKLE CELL AWARENESS MONTH</u> (1:01 p.m.)

Supervisor Hudgins said that Sickle Cell Disease is the most common inherited blood disorder in the United States. Sickle cell is particularly common among people whose ancestors came from sub-Saharan Africa; Spanish-speaking regions in the Western Hemisphere, Saudi Arabia; India; and Mediterranean countries such as Turkey, Greece, and Italy.

September is National Sickle Cell Awareness Month. Because it is "back to school" month for most children, the Sickle Cell Disease Association of America wants the public to reflect on the children and the adults whose lives, education, and careers have been affected by this disease. The observance originated in 1975.

The effort to have Sickle Cell Month officially recognized at all levels succeeded in 1983 when the House of Representatives unanimously passed the resolution, introduced by the Congressional Black Caucus, asking President Reagan to designate September as "*National Sickle Cell Anemia Awareness Month*." The President signed the resolution in August of 1983.

Therefore, Supervisor Hudgins asked unanimous consent that the Board:

• Proclaim September as "Sickle Cell Awareness Month" in Fairfax County

- Direct the Office of Public Affairs to help publicize this event
- Direct staff to invite Dr. Gloria Addo-Ayensu, Director, Health Department, to appear before the Board at its September 9 meeting to be presented with the proclamation

Without objection, it was so ordered.

48. **REQUEST TO RECOGNIZE THE HONORABLE JEAN PACKARD** (1:03 p.m.)

In a joint Board Matter with the Board, Supervisor Hudgins said that this month, the Honorable Jean Packard is retiring after many years of service to the County and the Northern Virginia region.

Supervisor Hudgins referred to her written Board Matter outlining Ms. Packard's many accomplishments and asked unanimous consent that the Board:

- Recognize Ms. Packard, for many years of service and environmental leadership to the County and the Northern Virginia region.
- Direct staff to invite Ms. Packard to attend a Board meeting to receive its thanks. If this is not possible, staff will investigate an alternative presentation.

Without objection, it was so ordered.

49. <u>CAR FREE DAY</u> (1:04 p.m.)

In a joint Board Matter with Supervisor Smyth, Supervisor Hudgins said that September 22 has been designated as Car Free Day in the Washington Metropolitan area. The Car Free Day is sponsored by the Metropolitan Washington Council of Government's Transportation Planning Board (TPB). Organized in 1,500 cities in 40 countries throughout the world to encourage people to use more environmentally friendly transportation modes, the Car Free Day correlates with International Mobility Week, occurring September 16-22, which celebrates sustainable mobility.

Supervisor Hudgins said that everyone is invited to pledge to go *car free* at <u>www.carfreemetrodc.com</u> and to register to win great prizes. She noted that the TPB asks that individuals pledge whether they are currently using transportation alternatives.

Therefore, Supervisor Hudgins asked unanimous consent that the Board direct staff from the Department of Transportation and the Office of Public Affairs to

help publicize this event through County government outreach tools. Without objection, it was so ordered.

50. HIGHWAY TRUST FUND (1:06 p.m.)

In a joint Board Matter with Supervisor McKay, Supervisor Hudgins noted the importance of a Highway Trust Fund and that it is urgent that the Board send a letter to its Congressional Delegation urging the importance of finding a solution and saving the trust fund.

Therefore, Supervisor Hudgins moved that the Board approve sending the letter contained in her written Board Matter to the County's Congressional delegation and request that it support legislation to address the federal Highway Trust Fund shortfall, and work towards a long-term surface transportation reauthorization that address transportation needs. Supervisor Gross and Supervisor McKay jointly seconded the motion.

Supervisor Gross noted that the second page of the proposed letter was missing and Supervisor Hudgins said that she would bring the item back for consideration when copies of the letter had been re-distributed to Board Members.

Supervisor Hyland asked to amend the motion to direct staff to forward the letter to the National Association of Counties (NACo), and this was accepted.

(NOTE: Later in the Board took action regarding the Highway Trust Fund. See Clerk's Summary Item #52.)

51. <u>PLAN AMENDMENT - 10819 LEESBURG PIKE (HUNTER MILL</u> <u>DISTRICT)</u> (1:08 p.m.)

Supervisor Hudgins said that Singh Development, a developer of independent living, assisted living, and memory care projects, is requesting that the Board authorize a Plan amendment to consider approximately 24.63 acres located at 10819 Leesburg Pike for a mix of senior living facilities, including potentially independent living, assisted living, and other facilities. It will be designed to serve the aging population of the County, in a manner consistent with sound land use policy that may advance the important policy goal of providing much needed senior housing in proximity to the communities where these seniors have lived, worked and/or have strong social connections, such as church or family.

Therefore, Supervisor Hudgins moved that the Board:

• Authorize a Plan Amendment for the property identified as Tax Map 12-3 ((1)), Parcel 4, consisting of approximately 24.63 acres, which parcels are located in the Upper Potomac Planning District under the current Comprehensive Plan and designed for residential use at .5-1 dwelling units. The Plan amendment should consider the appropriateness of the parcel developing as a senior housing facility at an overall intensity up to .30 floor area ratio (FAR) to include up to 150 independent living facilities and up to 100 assisted living/memory care units, exclusive of any affordable dwelling units.

Direct the Department of Planning and Zoning concurrently process this Plan amendment with any zoning applications, filed with respect to the property.

This motion should not be construed as a favorable recommendation on this proposed Plan amendment or any subsequent rezoning or other applications with respect to the property. Chairman Bulova seconded the motion.

Following a brief discussion regarding the location of the proposed Plan amendment, the question was called on the motion and it carried by a vote of nine, Supervisor Herrity being out of the room.

ACTION REGARDING THE HIGHWAY TRUST FUND ISSUE 52. (1:12 p.m.)

(NOTE: Earlier in the meeting there was discussion regarding the Highway Trust Fund. See Clerk's Summary Item #50.)

Chairman Bulova announced that the Board had been provided with the entire letter and she restated Supervisor Hudgins motion, as amended:

- That the Board approve sending the letter contained in her written • Board Matter to the County's Congressional delegation and request that it support legislation to address the federal Highway Trust Fund shortfall, and work towards a long-term surface transportation reauthorization that address transportation needs
- That the Board direct staff to send a copy of the letter to the National Association of Counties (NACo)

The question was called on the motion, as amended, and it carried by unanimous vote.

53. **<u>RECOGNITION OF MS. VIVIAN WATTS</u>** (1:12 p.m.)

Supervisor Hudgins recognized Vivian Watts, former Virginia Secretary of Transportation and Public Safety, for her efforts in finding transportation funding sources for Phase I and II of the Silver Line rail.

54.

COLONNADE AT UNION MILL TAX MAP 55-3((l)) 47A, 47B, 47C, 47F, AND 66-I-((l))16D, 16E, 16G PROFFERED CONDITION AMENDMENT APPLICATION (1:14 p.m.)

Supervisor Frey stated that on July 11, 1988, the Board approved Proffered Condition Amendment/Conceptual Development Plan Amendment Application PCA/CDPA 81-S-090-2 with concurrent special exception applications to permit construction of a retail center located at the intersection of Union Mill Road and Braddock Road, known as the Colonnade at Union Mill. The property is zoned Proffer 16 associated with that approval prohibited certain uses C-6, WS. including a veterinary hospital, which is otherwise a permissible use in the C-6 District. The shopping center owner would like the flexibility to include veterinary uses in the center and has met with the Sully land use committees who have no objection. Given that there is no construction proposed, the review of this application should be uncomplicated. Consequently, the applicant has asked that the application be expedited so that the Board's public hearing can occur prior to the end of the calendar year. Supervisor Frey stated that he has reviewed the request with the Department of Planning and Zoning (DPZ) and was told that the timetable is feasible.

Therefore, Supervisor Frey moved that the Board authorize DPZ to schedule a public hearing to be held before the Board for this application to occur prior to the end of the year. The applicant understands that this motion should not be considered as a favorable recommendation by the Board on the proposed application and does not relieve the applicant from compliance with the provisions of all applicable ordinances, regulations, and/ or adopted standards. Supervisor Herrity seconded the motion and it carried by unanimous vote.

55. **POSSIBLE PLAN AMENDMENT 34-3-((13)) 1,2,3,4 (SULLY DISTRICT)** (1:16 p.m.)

Supervisor Frey announced that on June, 2, 2003, the Board approved Proffered Condition Amendment Application PCA 95-Y-016-4 and Special Exception Amendment Application SEA 95-Y-016-4, to permit construction of a furniture store on Tax Map Parcel 34-3-((13)) 3. Since that time, there has been a decline in the national and local furniture market, and construction of the anticipated store is not economically viable. The owner of Parcel 3 has received considerable interest from a variety of other retail uses; however the current Comprehensive Plan recommendation for Parcel 3 permits only hotel, recreational and, under certain circumstances, a furniture store. In talking with staff, it appears that any alternate retail uses would require a Comprehensive Plan Amendment. This site is located within the Dulles Suburban Center, which is currently being reviewed as part of Fairfax Forward, however, the timetable for that review is approximately three years. Given the limited size and scope of this amendment, Supervisor Frey stated his belief that it can be reviewed independently and has discussed this request with staff and they concur. Therefore, Supervisor Frey moved that the Board authorize staff from the Department of Planning and Zoning (DPZ) to evaluate a Comprehensive Plan amendment to consider alternative retail uses on Tax Map 34-3-((13))3, which may run concurrently with a proffered condition amendment and/or special exception amendment for Parcel 3. The applicant understands that this motion should not be construed as a favorable recommendation on the Comprehensive Plan amendment or on any subsequent proffered condition amendment applications for the subject property, nor does it relieve the applicant from compliance with the provisions of all applicable ordinances, regulations, and/ or adopted standards, in any way. Supervisor Gross seconded the motion and it carried by unanimous vote.

56. <u>COMPANION ANIMALS</u> (1:18 p.m.)

Supervisor Frey stated that over the years his office has received calls from people who just acquired a pet and found out it was not allowed to be kept as a companion animal in the County. In many cases these animals were recently acquired at the local pet supply store. Looking at the definition of "commonly accepted pets" in the Code of the County of Fairfax it is easy to see that it has not been updated in quite some time. There are also inconsistencies in what the County has been allowing citizens to seek approval of through the special permit process and the Code definitions of wild animals, creating further confusion.

Supervisor Frey asked unanimous consent that the Board:

- Refer this issue to Animal Shelter and Health Department staff to review and update
- Direct staff to include the Animal Services Advisory Committee in this review

Supervisor Frey noted that animal welfare and the humane treatment of the animals will be an important part of this, as well as a desire not to encourage the keeping of wild or exotic animals as domestic pets. However there are numerous animals that are accepted everywhere as wonderful companions that the County does not currently allow. It is long overdue for modernizing.

Without objection, it was so ordered.

57. **<u>NEIGHBORHOOD SPEEDING INITIATIVE</u>** (1:22 p.m.)

Supervisor Cook announced that the neighborhood speeding initiative originally funded by the Board in 2013 will be kicking off next month. He added that Board Members will be receiving a "Save the Date" for the official launch in the next few days. The initiative is comprised of a vigorous awareness campaign that will remind drivers to slow down in neighborhoods. The campaign will feature the slogan, "Slow Down: You live here, we live here," and will include many community education events throughout the fall.

Supervisor Cook noted that this effort began on June 19, 2012, with a Board Matter sponsored by himself, Supervisor Hyland, and Supervisor McKay. Following extensive review and analysis by staff, a draft plan was presented to the Board on July 27, 2012. The Board approved the first phase of the plan last year through funding at Carryover.

The robust campaign is a collaborative endeavor between Supervisor Cook's office, the Board, the Office of Public Affairs, and the Police Department.

58. **SUICIDE PREVENTION WEEK** (1:23 p.m.)

Supervisor Cook announced that in the US, one person dies by suicide every 18 minutes, and it is estimated that five million people in the US have lost a loved one to suicide in the past 25 years. Suicide is the tenth leading cause of all deaths in the US, and mental health problems will strike one in five adults each year regardless of age, gender, race, ethnicity, religion or economic status. Suicide is the third leading cause of death among youth between the ages of 15 and 25, and the second leading cause of death for college students, with tragic consequences not only for themselves but others as well.

Supervisor Cook said that the vast majority of suicidal individuals display warning signs. Organizations such as CrisisLink are dedicated to reducing the frequency of suicide attempts and deaths, and the pain for survivors affected by the suicides of loved ones through educational programs, research projects, intervention services, and bereavement services.

The Fairfax-Falls Church Community Services Board (CSB) has partnered with CrisisLink to make it possible for people of all ages, and really anyone in the community, to text concerns to CrisisLink for prompt response, counsel and referral. All you have to do is text NEED HELP to 703-940-0888. In the County alone last year there were over 150 suicides. CrisisLink handled 2,699 calls including follow-up calls to those at high risk. Of those calls, 311 were suicide-related and required de-escalation by a volunteer crisis counselor.

As unnecessary deaths from suicide continue to increase, particularly in times of economic crisis, the urgency to reach out to those in need is heightened. Therefore, to raise awareness, Supervisor Cook asked unanimous consent that the Board:

- Proclaim September 8–14, 2014, as "Suicide Prevention Week" in Fairfax County.
- Direct staff to invite a representative from the CSB and CrisisLink to appear before the Board at its September 9 Board meeting to

speak about the organization and be recognized for the vital service it provides in the community.

Without objection, it was so ordered.

59. <u>CONSIDERATION ITEM FOR CARRYOVER - REQUEST FOR LAKE</u> <u>ACCOTINK PARK SITE ANALYSIS AND AREA USE</u> <u>RECOMMENDATION STUDY</u> (1:26 p.m.)

In a joint Board Matter with Supervisor Herrity and Supervisor McKay, Supervisor Cook said that Lake Accotink Park, an unpolished gem in the County, is comprised of a 55 acre lake and 493 acres of surrounding park land. Recently, the Park Authority has begun to reimagine its potential and is about to embark on an approximately 18 month re-master planning effort. This new master plan seeks to turn this underutilized park into one of the County's crown jewels.

Supervisor Cook noted that before that effort begins, however, the Park Authority has recommended that a preliminary Site Analysis and Area Use Recommendation Study be conducted to inform and establish parameters for the planning process. He said that included with his Board Matter is an outline and budget for the proposed study, which is expected to take six months for completion. While the Park Authority is currently working with the Northern Virginia Regional Commission to identify potential grant funding opportunities, there is no indication that such talks will be successful. He is asking the Board to take action today because it will not meet again before the NVRC and the Park Authority are able to determine if an additional avenue for funding this study exists.

Therefore, Supervisor Cook moved that funding in the amount of \$179,000 for the preliminary review, as outlined in his written Board Matter, be included as a Consideration Item for Carryover. Supervisor Herrity, Supervisor Hyland, and Supervisor McKay seconded the motion.

Following discussion regarding whether Park Authority funding is available, the question was called on the motion and it carried by unanimous vote.

60. **ORDERS OF THE DAY** (1:32 p.m.)

Supervisor Foust asked unanimous consent that the Board hold the 4:30 p.m. public hearing regarding the amended and restated real estate exchange agreement between the Board and Rocks Engineering Company and Nugget Joint Venture, LC (Collectively, "Reco") prior to the 4:30 p.m. public hearing Proffered Condition Amendment Application PCA C-696-10 and Rezoning Application RZ 2009-HM-017. Without objection, it was so ordered.

Chairman Bulova distributed bookmark souvenirs to Board Members from her recent trip to Key West, where she attended a retirement celebration for her sister who was a nurse at the Adult Detention Center.
