At a regular meeting of the Board of Supervisors of Fairfax County, Virginia, held in the Board Auditorium of the Government Center at Fairfax, Virginia, on Tuesday, May 13, 2014, at 9:34 a.m., there were present:

1. **MOMENT OF SILENCE** (9:34 a.m.)

Supervisor Herrity asked everyone to keep in thoughts the family of Reverend Father Richard B. Martin, pastor of the Church of the Nativity in Burke, who died of complications from diabetes. Rev. Fr. Martin's legacy will be Operation StarFish, a humanitarian effort begun to help the poor and the needy of Haiti; that mission is now shared by over 300 churches, schools, and organizations. Rev. Fr. Martin was a role model, a good person, a mentor to many, and will be sorely missed by the community.

Supervisor Foust asked everyone to keep in thoughts the family of Sean Logan, a tenth grade student at Herndon High School, who died this past weekend from injuries suffered in an automobile accident. He was kind, good-natured, and an excellent student who will be greatly missed.

2. **INTRODUCTION OF INTERNS** (9:37 a.m.)

Supervisor Hyland introduced Samra Asghedom, a rising sophomore at the College of William and Mary, who is interning in the Mount Vernon District office, and warmly welcomed her to his staff.

Chairman Bulova introduced Adam Coleman, a senior at Longwood University majoring in political science, who is interning in her office, and warmly welcomed him to the Board Auditorium.

3. <u>CERTIFICATE OF RECOGNITION PRESENTED TO MEMBERS OF THE LONGFELLOW MIDDLE SCHOOL SCIENCE BOWL TEAM (DRANESVILLE DISTRICT)</u> (9:38 a.m.)

Supervisor Foust moved approval of the Certificate of Recognition presented to members of the Longfellow Middle School Science Bowl Team for exceptional and outstanding knowledge in biology, chemistry, Earth science, physics, energy and math, resulting in first place at the middle school regional completion of the US Department of Energy Science Bowl in Newport News, Virginia. Supervisor Hyland seconded the motion.

Discussion ensued concerning the high priority of science, technology, engineering, and mathematics (STEM) education in County public schools.

The question was called on the motion and it carried by unanimous vote.

4. <u>RESOLUTION OF RECOGNITION PRESENTED TO MR. LEO SCHEFER</u> (9:46 a.m.)

Supervisor Herrity moved approval of the Resolution of Recognition presented to Mr. Leo Schefer for 24 years of distinguished leadership and service to the County and the region. The motion was unanimously seconded.

Discussion ensued concerning Mr. Shefer's many contributions and accomplishments, including serving as president of the Washington Airports Task Force; the planning and opening of the Udvar-Hazy Center of the National Air and Space Museum; the creation of a coalition of cities resulting in an Open Skies agreement; the reopening of Reagan National Airport following the 9/11 terrorist attacks; development of the Dulles International Airport; and his chairmanship of the Private Energy Task Force.

The question was called on the motion and it carried by unanimous vote.

5. <u>RECOGNITION OF FORMER SUPERVISOR ELAINE McCONNELL</u> (SPRINGFIELD DISTRICT) (10:05 a.m.)

Chairman Bulova recognized the presence of former Springfield District Supervisor Elaine McConnell and warmly welcomed her to the Auditorium.

6. RESOLUTION OF RECOGNITION PRESENTED TO THE MESSIAH UNITED METHODIST CHURCH (BRADDOCK DISTRICT) (10:05 a.m.)

Supervisor Herrity moved approval of the Resolution of Recognition presented to the Messiah United Methodist Church for its fiftieth anniversary and outstanding service to the community. Supervisor Cook and Supervisor Hyland jointly seconded the motion.

Following discussion concerning its participation in many community service projects and the contributions of Mr. and Mrs. "Mac" McConnell, Supervisor Herrity noted that Reverend Ralph Rowley, pastor of the church, will be assigned to a new church in Virginia Beach, and wished him well as he embarks on this new journey.

The question was called on the motion and it carried by unanimous vote.

7. RESOLUTION OF RECOGNITION PRESENTED TO THE PENDERBROOK COMMUNITY ASSOCIATION (PROVIDENCE DISTRICT) (10:17 a.m.)

Supervisor Smyth moved approval of the Resolution of Recognition presented to the Penderbrook Community Association for its outstanding accomplishments resulting in a 2013 Community Association of the Year award from the Washington

Metropolitan Chapter of the Community Association Institute. Supervisor Foust seconded the motion and it carried by unanimous vote.

8. CERTIFICATES OF RECOGNITION PRESENTED TO MEMBERS OF THE RESTON MASTER PLAN SPECIAL STUDY TASK FORCE (HUNTER MILL DISTRICT) (10:25 a.m.)

Chairman Bulova noted the presence of Robert Simon, founder of Reston, and warmly welcomed him to the Auditorium.

Supervisor Hudgins moved approval of Certificates of Recognition presented to members of the Reston Master Plan Special Study Task Force for exceptional efforts and dedication, working with the community to develop texts to update the Reston Master Plan and Comprehensive Plan. Chairman Bulova seconded the motion.

Following discussion concerning the development of and plans for redevelopment of Reston, the question was called on the motion and it carried by unanimous vote.

9. RESOLUTION OF RECOGNITION PRESENTED TO THE McLEAN VOLUNTEER FIRE DEPARTMENT (DRANESVILLE DISTRICT) (10:39 a.m.)

Supervisor Foust moved approval of the Resolution of Recognition presented to the McLean Volunteer Fire Department, which was chartered in 1923 and designated Company 1, for its service to the community and placement on the Inventory of Historic Sites by the County History Commission. Supervisor Gross seconded the motion.

Supervisor Foust noted that a recent publication, "The History of the McLean Volunteer Fire Department," had been distributed to the Board.

The question was called on the motion and it carried by a vote of nine, Supervisor Hyland being out of the room.

Homer Johns, Volunteer, Department of Fire and Rescue, noted a number of firsts for the department including: establishment of the first Ladies Auxiliary; purchase and installation of the first aerial platform in Northern Virginia; admission of the first female volunteer; hiring of the first minority County firefighter; and employment of the first career woman firefighter.

10. PROCLAMATION DESIGNATING MAY 18–24, 2014, AS "EMERGENCY MEDICAL SERVICES WEEK" IN FAIRFAX COUNTY (10:49 a.m.)

Chairman Bulova relinquished the Chair to Vice-Chairman Gross and moved approval of the Proclamation to designate May 18–24, 2014, as "Emergency Medical Services Week" in Fairfax County and urged all residents to observe the week with appropriate recognition and appreciation of the value of emergency medical services

programs and teams. Supervisor Herrity and Supervisor McKay jointly seconded the motion and it carried by a vote of nine, Supervisor Hyland being out of the room.

Vice-Chairman Gross returned the gavel to Chairman Bulova.

Richard Bowers, Fire Chief, FRD, announced that the department will be recognizing US military personnel serving in the department, other public safety agencies and County government that are currently serving in any capacity, their family members, as well as those who have lost their life. Department personnel will be wearing a camouflage type of tee shirt with emblems saying: "We'll Never Forget" and "Supporting our Troops." All donations received during the week the shirts are worn will be forwarded to the Fort Belvoir Wounded Warrior Program.

11. PROCLAMATION DESIGNATING MAY 2014 AS "OLDER AMERICANS MONTH" IN FAIRFAX COUNTY (10:58 a.m.)

Supervisor Herrity moved approval of the Proclamation to designate May 2014 as "Older Americans Month" in Fairfax County and urged all residents to recognize the contributions made to the community by older adults. Supervisor Foust seconded the motion.

Following discussion of this year's theme, "Safe Today, Healthy Tomorrow" which focuses on injury prevention, and the revision of the 50+ Plan which has been distributed in preparation for next week's meeting, the question was called on the motion and it carried by a vote of nine, Supervisor Hyland being out of the room.

12. PROCLAMATION DESIGNATING MAY 18–23, 2014, AS "PUBLIC WORKS WEEK" IN FAIRFAX COUNTY (11:07 a.m.)

Supervisor Gross moved approval of the Proclamation to designate May 18-23, 2014, as "Public Works Week" in Fairfax County and urged all residents to acquaint themselves with the various services and programs provided by the Department of Public Works and Environmental Services and to recognize the commitment exhibited by staff to the community's health, safety and welfare. Supervisor Hyland and Supervisor McKay jointly seconded the motion.

Following discussion of the myriad of community needs that the department is responsible for, and its efficient and professional response to those needs, the question was called on the motion and it carried by unanimous vote.

13. <u>10:30 A.M. – PRESENTATION OF THE VOLUNTEER FIRE</u> COMMISSION (VFC) ANNUAL REPORT (11:20 a.m.)

Tim Fleming, Chief, Franconia Volunteer Fire Department, the Chair of the VFC, presented its annual report.

Discussion ensued concerning:

- Maintenance of canteens and their value during sustained responses

At the request of Supervisor Gross, Chief Fleming expanded upon length-of-service awards.

Discussion continued concerning recruitment efforts and cooperative collaboration.

Chairman Bulova thanked the VFC for its reports and the work it does in partnership with career firefighters and emergency medical technicians (EMTs).

Supervisor McKay said that Ms. Melissa Porfirio, a first grade teacher at Crestwood Elementary School and the 2014 Virginia Teacher of the Year was one of four finalists for the national Teacher of the Year award and was honored by President Obama at a White House ceremony on May 1, 2014.

Ms. Porfirio, a Crestwood Elementary School teacher since 2005, is known as a mentor to new teachers and a gifted educator who instills a love of learning in her students. She has been recognized for her creative and effective teaching by the Virginia Department of Education and received the *Washington Post's* 2013 Agnes Meyer Outstanding Teacher Award. She was named Fairfax County Public School (FCPS) 2013 Teacher of the Year in the County. She received Crestwood Elementary School's 2008 Human Relations Award in 2008. Ms. Porfirio's dedication to her students does not end with the afternoon school bell. She assembled a team of parents and teachers to plan Crestwood Elementary School's first International Night, bringing the culturally diverse community together for music, dance, food, and information. She is a buddy runner in the school's Girls on the Run program, attends Parent Teacher Association (PTA) fundraisers, dance recitals, sports competitions, works on the Crestwood Partners in Print program, and visits student homes to build relationships with their families.

Therefore, Supervisor McKay asked unanimous consent that the that the Board direct staff to invite Ms. Porfirio, her first grade students, and Timothy Kasik, Crestwood Elementary School principal, to appear before the Board to be recognized at the June 17 Board meeting. Without objection, it was so ordered.

31. REQUEST FOR RECOGNITION OF CHANTILLY DRUMLINE - BRONZE MEDAL WIN AT THE 2014 WINTER GUARD INTERNATIONAL CHAMPIONSHIPS (SPRINGFIELD DISTRICT) (12:39 p.m.)

Supervisor Herrity said that at the Winter Guard International Championships in Dayton, Ohio this year, Chantilly High School became the first group from Virginia to medal in this prestigious class by claiming third place and winning the bronze medal. The Winter Guard International Championships is the "Super Bowl of Indoor Drumline competitions" and Chantilly represented the Commonwealth and the County in an outstanding and professional way.

Therefore, Supervisor Herrity asked unanimous consent that the Board direct staff to invite members of the Indoor Drumline from Chantilly High School to appear before the Board to receive a resolution recognizing them for their tremendous achievement. Without objection, it was so ordered.

32. <u>SILAS BURKE PROPERTY - REVIEW OF PLAN AMENDMENT PROPOSAL (SPRINGFIELD DISTRICT)</u> (12:40 p.m.)

Supervisor Herrity said that the property located at 9617 Burke Lake Road identified as Tax Map Reference 78-3 ((1)) 4 (the subject property) is owned by Suzanne S. Fowler (the owner) and developed with the historic Silas Burke House. The owner has long contemplated future plans for the subject property

with a particular interest in preserving the historic home. Mr. Silas Burke and his wife Hannah Coffer built the home in 1824. The historical value of the home lies in the fact that Lieutenant Colonel Burke donated a considerable portion of his property for the development of Burke Station on the Orange and Alexandria Railroad. This donation helped put Burke and the surrounding area on the map. The home sits on approximately five acres and continues to be an important landmark to the community.

Supervisor Herrity noted that the owner has signed a contract with Edward Burnett (contract purchaser) to establish an assisted living community (medical care facility) on the subject property which is in keeping with the County's goal of increasing the stock of senior housing. The proposed density for the assisted living facility is at 2-3 dwelling units per acre (du/ac). Additionally, as part of the proposed development, the owner and contract purchaser are committed to preserving the Silas Burke House in perpetuity. The subject property is currently planned for 1-2 du/ac. Accordingly, a Comprehensive Plan amendment will be necessary to permit an assisted living facility on the subject property.

Therefore, Supervisor Herrity moved that the Board direct staff from the Department of Planning and Zoning (DPZ) to:

- Review the Plan amendment proposal for the property identified as Tax Map 78-3 ((1)) 4 which is located in the Main Branch Community Planning Sector (P2) of the current Comprehensive Plan. The review should consider the appropriateness of the parcel redeveloping as an assisted living facility up to approximately 54,000 gross square feet
- Concurrently process this Plan amendment along with any rezoning, or any other application necessary to permit the proposed assisted living facility, filed with respect to the subject property.

This motion should not be construed as a favorable recommendation for this proposed Plan Amendment or any subsequent rezoning or other applications. Chairman Bulova seconded the motion and it carried by unanimous vote.

33. NO BOARD MATTERS FOR SUPERVISOR COOK (BRADDOCK DISTRICT) (12:43 p.m.)

Supervisor Cook announced that he had no Board Matters to present today.

34. LAND UNIT J PLAN AMENDMENT (SULLY DISTRICT) (12:44 p.m.)

Supervisor Frey said that on July 9, 2013, the Board adopted the Comprehensive Plan Amendment Work Program, which authorized a study of the Dulles Suburban Center and estimated its completion in early 2016. The primary

purpose of the study will be to evaluate the effect of the pending Countywide Transit Network Study on the area. The study is also scheduled to review the feasibility of the adopted Plan guidance for a mixed use focal point in Land Unit J, specifically for Tax Map parcel 44-3 ((1))15. This 50-acre property is bordered by Route 28, Westfield Boulevard, and Stonecroff Boulevard. Limited road access and the presence of an extensive Chesapeake Bay Resource Protection Area will influence the development pattern of this last remaining large vacant area in Land Unit J. The property owner is poised to submit a rezoning application for this site that proposes to implement the planned mixed use concept, and although it does not increase the anticipated intensity of the site, it does propose a larger residential component than the current language suggests. This development could potentially reduce planned vehicle trips by offering an alternative mix of uses, could advance the enhanced transit envisioned in both the Comprehensive Plan and the ongoing Countywide Transit Network Study, and protect valuable environmental features.

Therefore, Supervisor Frey moved that the Board authorize staff to consider an amendment to the current Comprehensive Plan ordinance for the mixed use focal point on Tax Map parcel 44-3((1))15. In particular, the consideration should examine the appropriate amount of and placement of planned residential use, and potential road improvements to alleviate congestion in the area. The amendment should also consider to the extent feasible a design that is compatible with the location of the transit stops under review in the Countywide Transit Network Study. This motion should not be construed as a favorable recommendation for a potential Plan amendment or any subsequent rezoning or other applications. Chairman Bulova seconded the motion and it carried by unanimous vote.

35. <u>DULLES DISCOVERY (DD) SOUTH RETAIL LC (SULLY DISTRICT)</u> (12:46 p.m.)

Supervisor Frey said that DD South Retail LC, a related entity of the Peterson Companies (the applicant), is processing Proffered Condition Amendment Application PCA 2003-SU-035-02 and Special Exception Application SE 2013-SU-017 for Dulles Discovery South (DDS) Retail, a 6.36-acre parcel surrounded by the Dulles Discovery North and the Dulles Discovery South office campuses. Together, the campuses contain approximately 132 acres and are approved for a total of approximately 2.4 million square feet of office and accessory uses to be occupied by the same tenant.

To address the need for retail and support services for the office use, the applicant proposes to modify the approved Conceptual Development Plan/Final Development Plan (CDP/FDP) to permit a child care center, drive-in bank, fast food restaurant, and service station/quick service food store. The proposed uses will be located at the main entrance to the DDS office campus and within walking distance for employees of both campuses. The gross floor area proposed is 26,400 square feet at a 0.09 floor area ratio (FAR), which is significantly less than

that currently entitled on the property. The special exception application is to permit the fast food restaurant.

The applicant has requested permission to begin concurrently processing the site plan and requested that the Board hearing be scheduled as soon as possible after the June 18 Planning Commission public hearing. The applicant has worked with the community and the Sully Foundation, and is working with staff to address green building commitments.

Therefore, Supervisor Frey moved that the Board direct staff to:

- Schedule the Board public hearing on Proffered Condition Amendment Application PCA 2003-SU-035-02 and Special Exception Application SE 2013-SU-017 to occur as soon as practicable after June 18
- Accept and concurrently process the associated site plan and other plans with Proffered Condition Amendment Application PCA 2003-SU-035-02 and Special Exception Application SE 2013-SU-017

This motion does not relieve the applicant from complying with all regulations, ordinances, or adopted standards, and will not prejudice the consideration of this application in any way. Supervisor Herrity and Supervisor Hyland jointly seconded the motion and it carried by unanimous vote.

36. THIRD ANNUAL CHANTILLY DAY (SULLY DISTRICT) (12:50 p.m.)

Discussion ensued, with input from Ms. Duca; Paul Emerick, Assistant County Attorney; Thakur Dhakal, Engineer IV, Land Development Services (LDS), Department of Public Works and Environmental Services (DPWES); Mary Ann Welton, staff to the Wetlands Board, Planning Division, DPZ;

Supervisor Foust raised questions regarding:

- Additional applications like this one pending approval
- Outstanding violations for similar conduct

Discussion ensued, with input from Barbara Berlin, Director, ZED, DPZ; William Mayland, Branch Chief, ZED, DPZ; Ms. Duca and Ms. Welton.

Mr. Hickman had filed the necessary notices showing that at least 25 adjacent and/or interested parties had been notified of the date and hour of this public hearing and he proceeded to present his case.

Supervisor Foust raised questions regarding the absence of the applicant and the slope stability issue, with input from Mr. Hickman.

Supervisor McKay raised a question regarding whether a permit was issued for the fill, with input from Mr. Hickman and Ms. Duca.

Following the public hearing, Supervisor Hyland moved to waive the reading of the staff and Planning Commission (PC) recommendations. This motion died for lack of a second.

Ms. Duca presented the staff and PC recommendations.

Supervisor Hyland moved approval of:

- Special Exception Application SE 2013-MV-011, subject to the development conditions dated May 12, 2014.
- The accompanying Resource Protection Area Encroachment Exception #5203-WRPA-010-2 and Water Quality Impact Assessment #5203-WQ-019-2, subject to the development

conditions contained in Appendix Two of the Staff Report Addendum.

Chairman Bulova seconded the motion.

Supervisor Smyth announced that she will be abstaining from the vote and expressed her concerns.

With regard to Appendix 8 of the Staff Report, Supervisor McKay raised a question regarding the series of emails attached to it with significant portions blanked out and discussion ensued, with input from Kanthan Sivapalarasah, Senior Engineer III, LDS, DPWES.

Discussion continued, with Board Members expressing their concerns with the application.

Supervisor Hyland raised questions regarding the:

- Expense to the applicant for the work already completed
- Expense to correct it in the future
- Number of applications similar to this one

Discussion ensued, with input from Mr. Hickman and Ms. Welton.

Supervisor Gross announced that she will not be supporting the motion and expressed her concerns and discontent with the application.

Following addition discussion, with Board Members expressing their concerns, Supervisor Hudgins stated that in the future this issue needs to be considered from a legislative standpoint with a statute that individuals will be penalized at the point of violation, not at the point of correcting it.

The question was called on the motion and it <u>CARRIED</u> by a recorded vote of six, Supervisor Smyth, Supervisor Foust, and Supervisor Gross voting "NAY," Supervisor Frey being out of the room.

Supervisor Smyth suggested that the Board provide staff with guidance on future development conditions for similar applications that should be recorded with the property deed so future owners understand the implications and expectations of compliance. Discussion ensued, with input from Ms. Welton who noted that Development Condition Number 15 of the revised conditions requires recording.

Supervisor Smyth raised a question regarding whether such recording will be done on a regular basis, with input from Ms. Welton.

Chairman Bulova relinquished the Chair to Vice-Chairman Gross and asked unanimous consent that the Board direct staff to:

- Create a standard development condition that requires recording with the property deed.
- Schedule for discussion, at a future Development Process Committee meeting, what type of information should be provided when someone purchases waterfront property, so that the owner has special guidance regarding what is allowed/not allowed.
- Confer with the realtor association to ensure the information is provided to the new waterfront property owners at the time of sale.

Without objection, it was so ordered.

Vice-Chairman Gross returned the gavel to Chairman Bulova.

55. <u>4 P.M. – PH ON PROPOSED PLAN AMENDMENT S13-IV-LP1 (VULCAN QUARRY) (MOUNT VERNON DISTRICT)</u> (5:11 p.m.)

Supervisor McKay moved to defer the public hearing on Plan Amendment S13-IV-LP1 until <u>June 3, 2014, at 3 p.m.</u> Chairman Bulova seconded the motion and it carried by a vote of seven, Supervisor Foust, Supervisor Frey, and Supervisor Hyland being out of the room.

56. 4:30 P.M. – PH ON PROFFERED CONDITION AMENDMENT APPLICATION PCA 2000-MV-034 (FURNACE ASSOCIATES, INCORPORATED) (MOUNT VERNON DISTRICT)

AND

PH ON SPECIAL EXCEPTION AMENDMENT APPLICATION SEA 80-L/V-061-02 (FURNACE ASSOCIATES, INCORPORATED) (MOUNT VERNON DISTRICT) (5:12 p.m.)

The Proffered Condition Amendment Application PCA 2000-MV-034 property is located on the west side of Furnace Road, approximately 2,693 feet south of Lorton Road and 2,693 feet north of the I-95 underpass, Tax Map 113-1 ((1)) 12 and 13.

The Special Exception Amendment Application SEA 80-L/V-061-02 property is located at 10001, 10201, 10209, 10215, 10219, and 10229 Furnace Road, Lorton, 22079, Tax Map 113-1 ((1)) 5pt., 7, 8; 113-3 ((1)) 1, 2, and 4.

Mr. Francis A. McDermott reaffirmed the validity of the affidavit for the record.

Supervisor Hyland disclosed that he has not had any campaign contributions within the past year. However, in years prior, he has received campaign contributions in excess of \$100 from Mr. Conrad R. Mehan, agent for the applicant.

Although not required legally, Chairman Bulova disclosed that when she ran for Chairman in 2009 she received contributions from ESI and Mr. Conrad R. Mehan, but she has not received any contributions within the past year.

Mary Ann Tsai, Staff Coordinator, Zoning Evaluation Division, Department of Planning and Zoning, gave a Powerpoint slide presentation depicting the application and site location.

Supervisor Hyland raised questions which resulted in a lengthy discussion, with input from Ms. Tsai and William Mayland, Branch Chief, ZED, DPZ; and Elizabeth Teare, Deputy County Attorney, regarding:

- The number of trucks that visit the site daily
- If the application were to be approved, the estimated number of trucks that would continue to visit the site
- Whether the application is a request for expansion of the existing landfill
- Why the pending application does not include the language "no further expansion of the landfill," which was included in a development condition of the previously approved application in 2007
- Whether the removal of language from the development conditions was coordinated and approved by the County Attorney's Office
- The Task Force's attempt to resolve matters of concern
- The outcome of a proposed development condition providing that the applicant would record a covenant requiring the closure of the landfill on a date certain
- The proposed berm
- The additional capacity requested
- The green energy proposals
- Whether staff has verified studies provided by the applicant

- The character of the communities closest to the landfill
- What would happen to the site if the application is not approved
- Additional development conditions

Discussion continued, with input from James W. Patteson, Director, Department of Public Works and Environmental Services, regarding:

- The disposal of construction debris, if the application is not approved
- The extent of other construction debris facilities available in the region
- Where the County disposes of its construction debris
- Whether the County has a policy for recycling construction debris, and if not, is it considering developing a policy
- Green energy policy

Discussion continued, regarding the berm height, with input from Ms. Tsai and Mr. Mayland.

Mr. McDermott had filed the necessary notices showing that at least 25 adjacent and/or interested parties had been notified of the date and hour of this public hearing and he proceeded to present his case.

Mr. McDermott distributed a resource binder regarding the application to Board Members.

Supervisor Hyland raised a question regarding why the applicant is unwilling to enter into an agreement which would guarantee the closure of the landfill on a date certain, so that there is certainty of it happening. Discussion ensued with input from Mr. McDermott.

Chairman Bulova announced that the public hearing is estimated to last approximately five hours due to the large number of speakers registered to present testimony. The Board will need to reflect on all of the testimony provided and would like to give staff and the applicant the opportunity to respond, so the record will remain open to receive written testimony. She also noted that a motion will be made later in the meeting to defer decision on this item until the next Board meeting on June 3, 2014.

Supervisor Hyland noted that the June 3 agenda is rather full, and suggested that the Board consider deferring decision until the June 17, 2014, meeting. Chairman Bulova stated she would consider that when making the motion.

Chairman Bulova provided instructions regarding the rules of order for the meeting.

(8:28 p.m.)

Following the testimony of Mr. Joe Vidulich (Speaker 28), discussion ensued concerning:

- The location of his residence
- Recycling of construction debris
- Concessions made to the community by the applicant
- Tysons redevelopment and LEEDS certification as it relates to recycling and/or landfilling

(8:37 p.m.)

Following the testimony of Mr. Ken Garrison, a representative of the Heavy Construction Contractors Association (Speaker 30), a brief discussion ensued regarding landfilling versus recycling.

Chairman Bulova raised a question regarding whether ESI recycles its concrete and debris, with input from Mr. McDermott.

(9:06 p.m.)

Following the testimony of Doug Webber, a representative of Teamsters Local 639 (Speaker 36), Supervisor Hyland raised a question regarding whether the employees of ESI were informed of the landfills closure date, in 2007 when the application was previously approved, with input from Mr. Webber.

(9:17 p.m.)

Following the testimony of Colin Campbell, a representative of the Habitat for Humanity (Speaker 39), Supervisor Hyland raised a question regarding recycling, burning, or landfilling materials donated to Habitat for Humanity, with input from Mr. Campbell.

(10:38 p.m.)

Following the testimony of Mr. John Jennison (Speaker 63), discussion ensued concerning:

- Inclusion of the ESI property as part of the Green Energy Triangle
- Consideration of this topic by the County Federation of Citizens Associations at its May 15 meeting

(10:45 p.m.)

Following the testimony of Ms. Holly Dougherty (Speaker 64), discussion ensued regarding:

- The membership of the Mount Vernon/Lee Chamber of Commerce
- Reconciling the position of the Mount Vernon/Lee Chamber with that of the South County Chamber
- Precedence of local community interests versus County-wide interests

Following the public hearing, which included testimony by 84 speakers, Chairman Bulova announced that the record will remain open to receive written testimony.

Mr. McDermott introduced ESI's Renewable Energy Specialist, Dr. Jeremy Morris, Geosyntec Consultants, who gave a presentation.

Mr. McDermott proceeded to present his rebuttal.

Supervisor Hyland raised questions, with input from Mr. McDermott, regarding:

- The present capacity of the landfill
- The estimated life of the landfill if the applicant continues to landfill at the present rate
- When ESI decided not to terminate landfill operations in 2018
- Whether ESI, when it discussed the possibility of the Green Energy Park with citizens in Lorton, also communicated at that time that it wanted to extend the life of the landfill
- Whether ESI has any present plans to sell the landfill if the application is approved

- The literature distributed to citizens who live in the vicinity of the landfill
- The anticipated number of trucks to visit the recycling facility if the landfill closed

Ms. Tsai presented the staff and PC recommendations.

Supervisor Hyland noted, for the record, that the PC Chairman Peter Murphy did not support the application, but voted in favor of the application to send it to the Board for final decision.

Supervisor Foust raised a question regarding the PC recommendation and the six additional consideration items, with input from Ms. Tsai.

Chairman Bulova relinquished the Chair to Acting-Chairman McKay and moved to defer decision only on Special Exception Amendment Application SEA 80-L/V-061-02 and Proffered Condition Amendment Application PCA 2000-MV-034 until **June 17, 2014, at 4:30 p.m.** Supervisor Herrity seconded the motion.

Following a brief discussion regarding the deferral, the question was called on the motion and it <u>CARRIED</u> by a recorded vote seven, Supervisor Hyland voting "NAY," Supervisor Frey and Supervisor Gross being out of the room.

Acting-Chairman McKay noted that the public hearing is closed, but the record will remain open until action is taken on June 17, 2014.

Acting-Chairman McKay returned the gavel to Chairman Bulova.

Chairman Bulova noted that Supervisor Gross and Supervisor Frey had to leave early, but they were present for part of the public hearing and will be reviewing the testimony from the rest of the evening.
