BOARD MATTERS

1. **LATE ARRIVAL OF CHAIRMAN BULOVA** (9:33 a.m.)

Vice-Chairman Gross announced that Chairman Bulova has been delayed and will be arriving later in the morning.

2. **MOMENT OF SILENCE** (9:34 a.m.)

Supervisor Herrity asked everyone to keep in thoughts the 69 men and women of the County's Virginia Task Force 1 Urban Search and Rescue Team who are deployed to Kathmandu, Nepal, assisting with the earthquake rescue efforts. He expressed well wishes for a successful deployment and safe return.

Supervisor Cook asked everyone to keep in thoughts the family of Braddock District resident Larry Kunkel, who died recently. He was a retired Navy Captain with 30 years of military service. He provided over 20 years of service to the County as a seasonal employee in the Office of Elections, first as an elections officer and then as a rover with the Electoral Board. He is survived by his wife of 57 years, Regina, and their three sons, Jeffrey, Stephen, and Thomas, seven grandchildren, and four great-grandchildren.

4. PROCLAMATION DESIGNATING MAY 4–8, 2015, AS "TEACHER APPRECIATION WEEK" IN FAIRFAX COUNTY (9:57 a.m.)

Supervisor Herrity moved approval of the Proclamation to designate May 4–8, 2015, as "Teacher Appreciation Week" in Fairfax County and thanked and congratulated all teachers in Fairfax County Public Schools for the excellent work they do. Supervisor Foust seconded the motion and it carried by a vote of nine, Chairman Bulova not yet having arrived.

5. PROCLAMATION DESIGNATING MAY 3–9, 2015, AS "CHILD CARE PROFESSIONALS WEEK" IN FAIRFAX COUNTY (10:04 a.m.)

Supervisor Hudgins moved approval of the Proclamation to designate May 3–9, 2015, as "Child Care Professionals Week" in Fairfax County and urged all residents to recognize child care professionals for their important work in the community. Vice-Chairman Gross seconded the motion and it carried by unanimous vote.

Vice-Chairman Gross relinquished the gavel to Chairman Bulova upon her arrival.

6. PROCLAMATION DESIGNATING MAY 2015 AS "FOSTER CARE AND FOSTER FAMILY RECOGNITION MONTH" IN FAIRFAX COUNTY (10:13 a.m.)

Supervisor Herrity moved approval of the Proclamation to designate May 2015 as "Foster Care and Foster Family Recognition Month" in Fairfax County and urged all residents, during the month and throughout the year, to volunteer their time and talents on behalf of children in foster care, and to support and recognize the commitment of foster families and professional staff who work with these children. Supervisor Foust and Supervisor Hyland jointly seconded the motion and it carried by a vote of nine, Supervisor Frey being out of the room.

7. PROCLAMATION DESIGNATING MAY 2015 AS "PARENTS WHO HOST LOSE THE MOST MONTH" IN FAIRFAX COUNTY (10:22 a.m.)

14. <u>BOARD ADOPTION OF THE FISCAL YEAR (FY) 2016 BUDGET PLAN</u> (11:38 a.m.)

(Rs)(FPR) Real Property Tax Rate

Having provided public notice and a public hearing in accordance with Virginia Code §58.1-3321 (B), and because it is necessary to set the real property tax rate higher than the lowered tax rate specified in Virginia Code §58.1-3321 to support the FY 2016 Adopted Budget, Chairman Bulova relinquished the Chair to Vice-Chairman Gross and moved that the Board set the real property tax rate at \$1.090 per \$100 of assessed value. As a result of this action, the real property tax rate for calendar year 2016 will be maintained at the present rate of \$1.09 per \$100 of assessed value. Vice-Chairman Gross and Supervisor Hyland seconded the motion and it **CARRIED** by a recorded vote of eight, Supervisor Cook, Supervisor Foust, Supervisor Frey, Supervisor Hudgins, Supervisor Hyland, Supervisor McKay, Vice-Chairman Gross, and Chairman Bulova voting "AYE," Supervisor Herrity, and Supervisor Smyth voting "NAY."

Supervisor Gross called the Board's attention to Admin 2 – Authorization to Advertise a Public Hearing on a Proposed Amendment to the Public Facilities Manual (PFM) Regarding Sidewalk Modifications and Waivers and raised a question regarding whether District Supervisors will have input in reviewing waivers. Discussion ensued, with input from Paul Shirey, Director, Code Development and Compliance, Department of Public Works and Environmental Services (DPWES) and James W. Patteson, Director, DPWES, regarding:

- Consultation with Board Members before waivers are granted
- Streamlining the process to avoid delays in processing waivers
- Use of walkway contingency funds
- Revision of the language to reflect suggested changes

16. ADMIN 5 – AUTHORIZATION FOR THE FAIRFAX-FALLS CHURCH COMMUNITY SERVICES BOARD (CSB) TO APPLY FOR AND ACCEPT FUNDING FROM THE VIRGINIA DEPARTMENT OF BEHAVIORAL HEALTH AND DEVELOPMENTAL SERVICES (DBHDS) FOR A CRISIS INTERVENTION TEAM (CIT) ASSESSMENT SITE GRANT (12 noon)

Chairman Bulova relinquished the Chair to Vice-Chairman Gross and moved that the Board authorize CSB to apply for and accept funding, if received, from DBHDS for CIT Assessment Site funds. Funding in the amount of \$1,402,058 per year for two years for a total of \$2,804,116 will support a secure assessment site at Merrifield Center open 24 hours a day, 7 days a week, 365 days a year for individuals experiencing a mental health crisis. A total of 10 new grant positions and 5 new Police Officer II merit positions for a total of 15 new positions are associated with this funding. A required local match of 20 percent in the first year and 30 percent in the second year will be met with in-kind resources. Supervisor Cook seconded the motion and it carried by unanimous vote.

Vice-Chairman Gross returned the gavel to Chairman Bulova.

Chairman Bulova relinquished the Chair to Vice-Chairman Gross and, jointly with Supervisor Cook, noted that, last month, she met with Sheriff Stacey Kincaid, Mental Health Advocate Reverend Jennifer McKenzie, Deputy County Executive Patricia Harrison, Fire Chief Richard Bowers, Police Chief Edwin Roessler, and Fairfax-Falls Church Community Services Board (CSB) Director Tisha Deegan, to discuss grant opportunities to assist in the development of a Collaborative Mental Health program in the County.

At this meeting, they discussed some of the gaps in the current mental health system and learned that many sister jurisdictions in Virginia already have programs in place for jail diversion for mentally-ill persons committing non-major crimes. Crisis Intervention Training (CIT) is part of the Criminal Justice Academy's training for recruits who go on to serve in the Jail or in the Police Department and that is important.

A large proportion of inmates at the County Adult Detention Center (ADC) have been identified as needing some level of mental health care during incarceration. While there are some processes in place for diversion, they typically are insufficient to prevent someone with a serious mental illness and/or co-occurring

substance abuse issues from entering the ADC. In addition, first responders in the community do not have all the necessary tools and systems in place to accept custody of such individuals.

Therefore, Chairman Bulova moved that the Board direct staff from the County and the Fairfax-Falls Church Community Services Board to work with branches of Public Safety and the Criminal Justice Advisory Board to pursue the development of a Countywide collaborative mental health program that would include improving and streamlining both diversion from the ADC, as well as for individuals already detained. Supervisor Hudgins and Supervisor Cook jointly seconded the motion.

Supervisor Hudgins asked unanimous consent that the Board direct staff to provide information regarding the history of CIT training programs. Following a brief discussion, without objection, it was so ordered.

Supervisor Cook expressed his hope that this issue be put on the agenda of a future Board's Public Safety or Human Services Committee meeting.

The question was called on the motion and it carried by unanimous vote.

Vice-Chairman Gross returned the gavel to Chairman Bulova.

Supervisor Foust asked unanimous consent that the Board direct staff to provide information and costs associated with the elimination of the State process. Without objection, it was so ordered.

The question was called on the motion and it carried by unanimous vote, Supervisor Cook, Supervisor Foust, Supervisor Frey, Supervisor Gross, Supervisor Herrity, Supervisor Hudgins, Supervisor Hyland, Supervisor McKay, Supervisor Smyth, and Chairman Bulova voting "AYE."

20. A-3 - APPROVAL OF ADDITIONAL FUNDING FOR ROUTE 29 WIDENING FROM LEGATO ROAD TO SHIRLEY GATE ROAD (BRADDOCK DISTRICT) (12:17 p.m.)

On motion of Supervisor Cook, seconded by Supervisor Foust, and carried by unanimous vote, the Board concurred in the recommendation of staff and approved the use of \$3 million in 2007 transportation bond referendum revenues for the construction of the Route 29 Widening project from Legato Road to Shirley Gate Road.

21. A-4 – APPROVAL OF THE PROPOSED FIVE-YEAR CONSOLIDATED PLAN FOR FISCAL YEARS (FY) 2016-2020 AND PROPOSED CONSOLIDATED PLAN ONE-YEAR ACTION PLAN FOR FY 2016 (12:17 p.m.)

On motion of Supervisor Hudgins, seconded by Supervisor McKay, and carried by a vote of nine, Supervisor Herrity being out of the room, the Board concurred in the recommendation of staff and:

- Adopted the Proposed Five-Year Consolidated Plan for FY 2016-2020 and Proposed Consolidated Plan One-Year Action Plan for FY 2016 as issued by the Consolidated Community Funding Advisory Committee with funding allocations as outlined in the Board Agenda Item dated April 28, 2015
- Authorized signature of the Consolidated Plan Certifications and Federal funding application forms (SF424s) required by the US Department of Housing and Urban Development (HUD) by May 15, 2015

22. TO EXECUTE AUTHORIZATION THE **ISLANDING** AGREEMENT **BETWEEN VIRGINIA ELECTRIC AND** COMPANY D/B/A DOMINION VIRGINIA POWER (DVP) AND THE COUNTY TO FACILITATE THE USE OF STANDBY GENERATORS AT THE NOMAN M. COLE, JR., **POLLUTION CONTROL** (12:18 p.m.)

On motion of Supervisor Hyland, seconded by Supervisor McKay, and carried by unanimous vote, the Board concurred in the recommendation of staff and authorized the County Executive to execute the Islanding Agreement between the County and DVP to facilitate the operation of standby generators at the Noman M. Cole, Jr., Pollution Control Plant. This will allow plant staff to disconnect the plant from the DVP grid and operate the standby generators in an islanding mode in anticipation of severe weather events providing uninterrupted operation of the plant.

23. <u>A-6 – ENDORSEMENT OF COMMENTS ON HOUSE BILL HB 2 (2014)</u> <u>IMPLEMENTATION POLICY GUIDE</u> (12:19 p.m.)

Tom Biesiadny, Director, Department of Transportation (DOT) gave background information regarding this item.

Discussion ensued with input from Mr. Biesiadny and Noelle Dominguez, Coordination and Funding Division, DOT, regarding local sources of revenue and project cost increases.

Following discussion, Supervisor McKay moved that the Board concur in the recommendation of staff and endorse a letter to the Commonwealth Transportation Board (CTB) regarding the HB 2 (2014) Implementation Policy Guide related to funding distribution of State transportation funding. The letter comments on various issues within the policy guide pertaining to submission eligibility; project screening; evaluation measures; weighting schemes; project cost for analysis; and changes in project costs and scopes. The motion, the second to which was inaudible, carried by unanimous vote.

24. <u>I-1 – PLANNING COMMISSION (PC) ACTION ON PUBLIC FACILITIES APPLICATION 2232A-L09-13-2, T MOBILE, 6500 BYRON AVENUE (LEE DISTRICT)</u> (12:37 p.m.)

The Board next considered an item contained in the Board Agenda dated April 28, 2015, announcing the PC's approval of Public Facilities Application 2232A-L09-13-2. The PC noted that the application met the criteria of character, location, and extent, and was in conformance with Section 15.2-2232 of the Code of Virginia. The application sought approval to install three additional panel antennas on the existing stealth monopine tower.

25. <u>I-2 - CONTRACT AWARD - ENVIRONMENTAL CONSULTING AND SERVICES</u> (12:37 p.m.)

The Board next considered an item contained in the Board Agenda dated April 28, 2015, announcing that staff is awarding a contract to HDR Engineering, ARCADIS US Incorporated, and CDM Smith Incorporated, for environmental consulting and services. The contract will total approximately \$3 million over a five-year term from the award date.

26. **I-3 – INTERNATIONAL BUILDING SAFETY MONTH** (12:37 p.m.)

(NOTE: Earlier in the meeting, the Board recognized Building Safety Month. See Clerk's Summary Item #11.)

The Board next considered an item contained in the Board Agenda dated April 28, 2015, announcing that, in observance of International Building Safety Month, May 2015, the Department of Public Works and Environmental Services (DPWES) is conducting a campaign to promote public awareness of building safety in the County. This is in keeping with DPWES' mission to enforce building codes and related County ordinances to ensure the construction of safe buildings in the County.

- 27. <u>ADMIN 2 AUTHORIZATION TO ADVERTISE A PUBLIC HEARING ON A PROPOSED AMENDMENT TO THE PUBLIC FACILITIES MANUAL (PFM) REGARDING SIDEWALK MODIFICATIONS AND WAIVERS (12:38 p.m.)</u>
- (A) (NOTE: Earlier in the meeting, this item was deferred. See Clerk's Summary Item #15.)

Supervisor Gross moved that the Board authorize the advertisement of a public hearing to be held before the Planning Commission on May 20, 2015, and before the Board on <u>June 23, 2015, at 4 p.m.</u>, to consider proposed revised amendments to the PFM as distributed around the dais. The amendment clarifies when the requirement to install a sidewalk may be modified or waived, and when an escrow is required for future construction. The proposed amendment will become effective at 12:01 a.m. on the day following adoption. Supervisor Smyth seconded the motion and it carried by unanimous vote.

28. **REQUEST FOR RECOGNITIONS** (12:39 p.m.)

Chairman Bulova relinquished the Chair to Vice-Chairman Gross and asked unanimous consent that the Board direct staff to invite representatives from the following organizations to appear before the Board:

- Department of Public Works and Environmental Services to accept a proclamation recognizing May 18-22, 2015, as "Public Works Week" in Fairfax County, to be presented at the Board meeting on May 12, 2015
- Annandale Rotary Club to accept a proclamation recognizing their fiftieth anniversary, to be presented at the Board meeting on June 23, 2015
- Park Authority to accept a proclamation recognizing July 2015 as "National Recreation and Parks Month" in Fairfax County, to be presented at the Board meeting on June 23, 2015

In addition, that a proclamation be prepared for:

- The Leather and Lace Motorcycle Club recognizing May 2015 as "Motorcycle Safety Month" in Fairfax County, to be presented in her office on May 1, 2015. She invited Board Members to attend the presentation.

29. <u>USE OF 'TYSONS' IN OFFICIAL COMMUNICATIONS</u> (12:41 p.m.)

Chairman Bulova said the area formerly known as Tysons Corner is now being referred to as Tysons in County communications. Recently, the Tysons Partnership was told by Wikipedia that, due to the seemingly interchangeable usage of both terms on the County website, Wikipedia would not drop Corner from the Tysons page. While both Tysons and Tysons Corner can still be used as addresses, the Tysons Partnership, of which the County is a member, is marketing the area to potential businesses and residents as simply Tysons.

Therefore, Chairman Bulova asked unanimous consent that the Board direct staff to, in all forms of official communication, use Tysons exclusively and whenever feasible and practical, and change previous instances to reflect the new Tysons designation. Without objection, it was so ordered.

Supervisor Smyth reminded the Board that there is a Tysons Corner Metro Station and Tysons Corner Center, so 'Corner' cannot be eliminated entirely because it is institutionalized in some ways.

Supervisor Hyland noted the disparity for a portion of County residents who have an Alexandria postal code, and are referred to as the "Alexandria section" of Fairfax County.

Supervisor Gross also noted that Thomas Jefferson High School (TJHS) for Science and Technology is often referred to as Alexandria's TJHS for Science and Technology, but it is Fairfax County's TJHS for Science and Technology.

Vice-Chairman Gross returned the gavel to Chairman Bulova.

Supervisor Hudgins also noted the disparity in the Herndon/Reston boundaries.

30. NO BOARD MATTERS FOR SUPERVISOR GROSS (MASON DISTRICT) (12:46 p.m.)

Supervisor Gross announced that she had no Board Matters to present today.

31. RECOGNIZING WILLIAM BATES AS 2015 FAIRFAX COUNTY PUBLIC SCHOOLS (FCPS) PRINCIPAL OF THE YEAR (12:47 p.m.)

Supervisor Foust said that he would like to congratulate William Bates for being named the "2015 FCPS Principal of the Year." He is also one of the recipients of the *Washington Post's* Distinguished Educational Leadership Awards. He has served as principal of Herndon High School since 2009 and has worked for the school system for 15 years. He currently serves as president of the FCPS High School Principals Association.

Mr. Bates is praised for artfully creating an environment at Herndon High that is conducive to learning and fosters creativity and personal development. He is known for his philosophy as a Hopeologist - giving all children hope for their future. With his backing, Herndon High and the Herndon Pyramid have adopted the national Kids at Hope program which inspires organizations serving youth to create an environment where all children experience success. A PRIDE (participation, respect, integrity, diligence, and empathy) matrix is a part of all activities at Herndon High.

The mission for Herndon High states "All Hornets are capable of success... No Exceptions!" Staff members are challenged to support this mission. Mr. Bates with his staff have succeeded in changing the culture at Herndon by improving school spirit and ownership. He is fully engaged with his students during both school hours and extracurricular activities. He discusses with students topics ranging from bullying and suicide awareness, to the physical conditions of the school, student perceptions of staff members, and expectations for academic achievement.

Therefore, Supervisor Foust asked unanimous consent that the Board direct staff to invite Mr. Bates, along with his family and school officials, to appear before the Board on June 23, 2015, to be recognized for his significant achievements. Without objection, it was so ordered.

32. **ANIMAL SERVICES** (12:49 p.m.)

Supervisor Frey noted that in the late 1990's the Department of Animal Control had essentially hit bottom. The public had little confidence in either animal control programs or the animal shelter. The County was unable to attract qualified candidates during several searches for a director, and the Animal Advisory Commission wouldn't even let staff attend their meetings.

In search of solutions, the County Executive and the Board turned to the Police Department, and under the leadership of then Chief Tom Manger and his successor Dave Rohrer, a transformation began. Karen Diviney was brought in, and with the help of new staff, both sworn and civilian over the next 12-15 years, a true success story developed. More humane, innovative practices were implemented, particularly in the shelter, volunteer programs were initiated that are flourishing, and true citizen input and involvement were sought, including numerous partnerships with rescue and humane organizations. Under the leadership today of Tawny Hammond and Chief Ed Roessler, the County received special recognition last summer from Wayne Pacelle, President of the Humane Society of the United States (HSUS).

While the County has achieved much, it should never stop striving for better. The world of animal welfare services is rapidly evolving around the country. New and more effective adoption policies are being developed, better shelter management and humane health practices are being implemented, and more focus on human and wildlife interactions is needed as populations grow and wildlife habitat is intruded upon.

Supervisor Frey said that he believes that, as successful as the nearly 20 years under the Police Department has been, if the County is to continue to progress and improve, it needs to seriously look at reorganization. More and more jurisdictions around the country are moving animal services out of police or other larger departments and creating standalone animal services departments. The County needs to do the same.

While this is the organizational structure the County used to have, and were forced to change, there are several major and significant differences between then and now. The County now has a Deputy County Executive for Public Safety to oversee it, which it didn't have then. The County has a tremendous staff with strong backgrounds in animal services, and most importantly we have an open, transparent operation with tremendous public participation and strong partnerships with the Animal Services Commission, breed, rescue, and humane groups, as well as all of our neighboring jurisdictions.

Therefore, Supervisor Frey moved that the Board direct the County Executive and the Deputy County Executive for Public Safety to undertake an organizational review of the County's animal control services and the animal shelter. The review should specifically evaluate removing these functions from the Police Department to a standalone Department of Animal Services. This should also include the programs operated by the Wildlife Biologist.

One issue that will need special attention is the sworn animal control officer, and whether that is still needed for animal control. There are numerous ways it is being done around the country, from all sworn officers to none, replacing them with humane investigators, and combinations of the two. The County also needs to look at the training these officers go through whatever decision is reached about their sworn status.

Finally, Supervisor Frey noted that this is a process that jurisdictions all over are going through and there are numerous organizations that have helped in implementing new structures and developing best practices. Among these are the HSUS, the National Animal Control Association, and the Washington Humane Society. He recommended that the County reach out to groups such as those for their help and expertise.

This motion was multiply seconded. Following a brief discussion, the question was called on the motion and it carried by unanimous vote.

33. <u>SIX-YEAR INTERSTATE, URBAN, PRIMARY, AND TRANSIT IMPROVEMENT PROGRAM</u> (1 p.m.)

Supervisor McKay said that on April 16, 2015, the Virginia Department of Transportation (VDOT) released its Draft Six—Year Interstate, Urban, Primary, and Transit Improvement Program for Fiscal Years (FYs) 2016 through 2021.

By law, the Commonwealth Transportation Board (CTB) has the responsibility to hold public hearings and adopt a final program based on the official revenue forecast by July 1, 2015. For Northern Virginia, the public hearing will be held on Tuesday, April 28, 2015, at VDOT's Northern Virginia District Office. Unfortunately, this scheduling did not allow County staff time to prepare a formal Board Item for consideration.

The General Assembly's passage of HB 2 and HB 1887 directs the CTB to develop a process for allocating State transportation funds after July 1, 2016. As a result, funding for some projects which have not completed the State environmental review process or the Federal National Environmental Policy Act (NEPA) process has been removed from the plan, and other changes of this type are expected prior to final adoption of the plan. This will affect projects Statewide, including a number of projects in the County and Northern Virginia.

Supervisor McKay said that staff has prepared draft testimony based on review of the Adopted FYs 2015 – 2020 Six-Year Improvement Program and the Board's testimony on the FYs 2016 – 2021 Program which was presented at the October 16, 2014, public hearing.

Therefore, Supervisor McKay moved that the Board:

- Approve the April 28, 2015, testimony to be forwarded to the Virginia Secretary of Transportation
- Authorize Tom Biesiadny, Director of Transportation, to present the Board's comments to the CTB at the Six-Year Program hearing, since the Board meeting may not be finished before the public hearing starts

Chairman Bulova seconded the motion. Discussion ensued, with input from Mr. Biesiadny, regarding design and funding for Rolling Road.

Chairman Bulova relinquished the Chair to Vice-Chairman Gross and asked to amend the motion to include:

- Projects that were approved by the Northern Virginia Transportation Authority (NVTA) and those that are priorities for the County
- Those projects that may be candidates for future funding under different programs

This was accepted.

Vice-Chairman Gross returned the gavel to Chairman Bulova.

Supervisor McKay amended the motion to include all projects that were funded by NVTA.

The question was called on the motion, as amended, and it carried by unanimous vote.

34. <u>COMMUNITY ACTION ADVISORY BOARD (CAAB) FOOD BANK</u> (1:07 p.m.)

Supervisor McKay said that the CAAB advises the Board of Supervisors on the needs, concerns ,and aspirations of low-income persons and recommends policies that promote meaningful change. Its mission is to make a positive difference in the lives of low-income families and individuals in the County.

Last summer, the CAAB held its first summer food bank collection, selecting the summer months because, although the need is high, local food pantries are at their lowest levels and students in need do not have school meals available.

Last summer, the CAAB collected 2,673 pounds of food and \$300 that it delivered to Food for Others. The CAAB will hold the drive again this summer with the goal of exceeding last year's totals and partnering with local institutions to expand the number of collection sites.

Collection boxes will be set up throughout the County and locations posted on the County's Board, Authorities, and Commissions (BACs) website http://www.fairfaxcounty.gov/bacs/. Additional information is available by emailing CAAB@fairfaxcounty.gov.

Therefore, Supervisor McKay asked unanimous consent that the Board direct the Office of Public Affairs to publicize this summer food bank drive and that members of the CAAB be invited to appear before the Board for recognition on June 23. Without objection, it was so ordered.

35. **SPRINGFIELD DAYS (LEE DISTRICT)** (1:08 p.m.)

Supervisor McKay announced that this year will be the Twenty-Seventh Annual Springfield Days celebration held on Saturday, May 30, and Sunday, May 31. Saturday, May 30 will feature PetFest and an entertainment stage at South Run REC Center, the Springfield Days Stride, headquartered at the Springfield Town Center, and a farmers market, also at the Springfield Town Center. New to the festival this year is the Springfield Market Expo for small business vendors at the Springfield Methodist Church. Also on Saturday, American Legion Post 176 will again host a vintage car show in its parking lot from 10 a.m. to 2 p.m.

This celebration has many partners that make this event possible, including, to name only a few, Safford Chrysler Jeep Dodge of Springfield, the presenting sponsor; Greater Springfield Chamber of Commerce; Fairfax County Park Authority; Felix and Oscar-Pet Food...Naturally; Metro Run and Walk; Olde Towne Pet Resort, Springfield Town Center and American Legion Post 176.

Supervisor McKay noted that on Sunday, May 31, the Cardboard Boat Regatta will again set sail at Lake Accotink Park.

Therefore, Supervisor McKay asked unanimous consent that the:

- Board direct staff to prepare a proclamation declaring May 30 and May 31 as "Springfield Days" in Fairfax County and invite all residents of the County to celebrate this community event
- Proclamation be presented to the Springfield Days Committee at the PetFest entertainment stage on May 30

Without objection, it was so ordered.

Supervisor McKay announced that the Springfield 15K/5K race is not being held in conjunction with Springfield Days but is being planned for a fall run associated with Lake Accotink Park.

36. **LYME DISEASE** (1:10 p.m.)

(NOTE: Earlier in the meeting, there was a discussion regarding Lyme disease. See Clerk's Summary Item #10.)

Supervisor Herrity referred to his written Board regarding Lyme Disease tests and asked unanimous consent that the Board direct staff to invite Temple Douglas, Dr. Petricoin and members of the Center for Applied Proteomics and Molecular Medicine in the School of Systems Biology Health Department at George Mason University to appear before the Board in June to receive a resolution acknowledging their breakthrough efforts to find a better test for Lyme Disease. Without objection, it was so ordered.

37. <u>FIRST FARM BREWERY IN THE COUNTY (SPRINGFIELD DISTRICT)</u> (1:11 p.m.)

Supervisor Herrity said that recently an application was made to the Virginia Department of Alcoholic Beverage Control for the first farm brewery in the County. The farm brewery is proposed to be located on approximately 20 acres of land zoned to the Residential-Conservation (RC) District, located at the corner of Yates Ford and Clifton Road in the Clifton community. As the Board is probably aware, last year the General Assembly passed (almost unanimously) and the Governor signed into law Senate Bill (SB) 430, known as the Farm Brewery Bill, with an effective date of July 1, 2014. This bill created a new limited brewery license for breweries that manufacture no more than 15,000 barrels of beer per calendar year, are located on a farm and on land zoned agricultural, and use agricultural products that are grown on the farm in the manufacture of their beer. More importantly, the bill also limits local regulation of farm breweries, similar to the farm winery bill that was passed by the Virginia Legislature and signed into law in 2006, and specifically preempts local government regulation of, among others: the manufacturing of beer, and the production and harvesting of agricultural products for its manufacturing; the on premises sale, tasting or consumption of beer during regular business hours, the sale of beer related items that are incidental to the sale of beer; and the hosting of on- site activities and events customary to such operations.

As stated in Virginia Code Section 15.2-2288.3:1, the approved legislation reads: "...local restriction upon such activities and public events of breweries...to market and sell their products shall be reasonable and shall take into account the economic impact on such licensed brewery of such restriction, the agricultural nature of such activities and events, and whether such activities and events are

usual and customary for such licensed breweries. Usual and customary activities and events at such licensed breweries shall be permitted unless there is a substantial impact on the health, safety, or welfare of the public."

In response to this farm brewery proposal, a number of citizens in the Clifton community have expressed concerns regarding the proposed brewery, ranging from whether the use is permitted in the R-C District to environmental issues with regard to water usage, water quality, and septic controls, to other land use impacts such as traffic, noise, and frequency of events which may impact the surrounding properties. It appears that a farm brewery would be deemed an agriculture use under the County's Zoning Ordinance, and agriculture is a permitted use in the R-C District as well as other zoning districts available in several magisterial districts.

In light of this legislation and the concerns expressed by members of the Clifton community in response to the proposed farm brewery, Supervisor Herrity moved that the Board direct the County Executive to prepare a memorandum for the Board on currently available and potential regulatory options to address farm breweries. The memorandum should be added to the agenda for the next Development Process Committee meeting. Chairman Bulova seconded the motion and it carried by unanimous vote.

38. **RECOGNITION OF MS. MARY AGEE** (1:15 p.m.)

Supervisor Herrity said that Board Members understand the importance that non-profits play in helping citizens, especially those in need, obtain services and Northern Virginia Family Service (NVFS) is one of those non-profits.

Supervisor Herrity referred to his written Board Matter and noted that Ms. Mary Agee has been with NVFS for over 40 years and has served as Chief Executive Officer (CEO) for the last 27 of those years. He noted that Ms. Agee has been instrumental in making NVFS what it is today, dedicating her life for the betterment of others.

Therefore, Supervisor Herrity moved that the Board:

Nicholas Rogers, Planner, Zoning Evaluation Division, Department of Planning and Zoning (DPZ), gave a PowerPoint slide presentation depicting the applications and site location.

Supervisor Hyland, with input from Mr. Rogers, raised questions concerning:

- Whether staff walked the southern trail alignment
- Truck traffic to and from the quarry
- Plan amendment language and development conditions as it pertains to the Board of Zoning Appeals (BZA) determination on a Special Permit Application (SPA)

Following additional questioning concerning noise and vibration impacts/levels, with input from Erin M. Haley, Planner II, DPZ, Supervisor McKay noted a development condition update which had been distributed. He inquired about proffer number 20, concerning landscape buffers, with input from Mr. Rogers.

Messrs. Riegle and McGranahan had filed the necessary notices showing that at least 25 adjacent and/or interested parties had been notified of the date and hour of this public hearing. Mr. McGranahan made a brief presentation then introduced Charles Murray, General Manager, Fairfax Water, who proceeded to present the case.

Following Mr. Murray's presentation, Supervisor Hyland, noting his concern about the trail alignment, raised a question concerning easements and stated that it was his intent to defer decision until May 12, in order to address issues which need to be resolved. He also asked that reconsideration be given to a southern alignment, with fencing to address security issues.

Discussion continued on easement clarification.

Following the presentation of Mr. Lawrence Clark, Speaker 2, discussion ensued concerning the facts he was seeking.

Following the public hearing, which included testimony by nine speakers, Supervisor Hyland stated that he had items to submit for the record.

Discussion ensued regarding an information request concerning blasting methods.

Supervisor Hyland requested information from the applicants concerning the following, which would be shared with the Board:

- RPA encroachment exception clarifying acreage calculations

Chairman Bulova announced that Board Members have requested a private briefing on security issues; the briefing will occur on May 12. Supervisor Hyland noted that some Board Members have also requested the opportunity to walk the southern trail alignment and expressed his hope that Fairfax Water would accommodate that request.

Supervisor Hyland moved that the Board defer decision, with the record remaining open for written comment, until **May 12, 2015, at 3:30 p.m.**, for:

- Proffered Condition Amendment Application PCA 1998-MV-032

Supervisor Foust seconded the motion and it carried by a vote of nine, Supervisor Hudgins being out of the room.
