#### **BOARD MATTER**

#### 1. MOMENT OF SILENCE (9:33 a.m.)

Supervisor Gross asked everyone to keep in thoughts the family of her 98 year old neighbor Ms. Valeria Owens, who died last week. She was a wonderful neighbor and will be sorely missed. Supervisor Gross said that she will be leaving the meeting later to attend her funeral.

Supervisor Foust asked everyone to keep in thoughts the family of Mr. Michael Zook, who died recently. He was a teacher and administrator in Fairfax County Public Schools for 26 years and served as Assistant Principal of McLean High School since 2010. He was also the brother of Jim Zook, former Director of the Department of Planning and Zoning.

Supervisor Foust asked everyone to keep in thoughts the family of Mr. Mark Turner, III, who died recently. His grandfather was a former Board Member and dairy farmer. His family owned the Turner Farm which was acquired by the Park Authority and is now known as Turner Farm Park. A few years ago Mr. Turner sold his home to the Park Authority and it became the first property entered into the Resident Curator Program.

Supervisor Hudgins asked everyone to keep in thoughts the family of Ms. Judith Azzara, former Principal of Louise Archer Elementary School, who died recently. Ms. Azzara oversaw the education of a generation of students in the 24 years she served the school. She is remembered for being a positive force and influencing the lives of students.

#### 12. <u>10:10 A.M. – PRESENTATION OF THE HISTORY COMMISSION</u> <u>ANNUAL REPORT</u> (11 a.m.)

Carole Herrick, Chairman of the History Commission, introduced the following members of the History Commission who were present in the Board Auditorium:

Ms. Herrick presented a summary of the History Commission's annual report, noting that the Commission had another outstanding year in preserving, promoting, and making the public aware of the County's fabulous heritage.

- Several commissioners gave lectures or presentations before various groups, many of which focused on newer residents within the County, seniors, and school-age youth.
- The financial arrangement of the Commission with the County changed all funds are now maintained through the County's financial system.
- Three new roadside markers erected and dedicated: The Pines (Mason District); the Original Mount Vernon High School (Mount Vernon District); and Copperthite Racetrack (Springfield District). An additional tabletop marker was installed and dedicated at Riverbend Park commemorating the area's role during the War of 1812 (Dranesville District). In addition, two markers were refurbished: the Cross Farmhouse (Sully District) and Ivakota Farm (Springfield District).
- The twelfth annual History Conference delivered an outstanding event. The conference was titled "Fairfax County's Founding Father The Masons are Coming! The Masons are Coming." Three authors were presented awards for their contributions to the history of the County.

- Members represented the Commission on the Community Technical Advisory Committee which oversees the Resident Curator Program for historic properties.
- Members will be representing the Commission on the County's committee for the 275<sup>th</sup> celebration of the County, with the main event taking place on June 17, 2017.
- The Commission updated its bylaws, revised the County Inventory of Historic Sites, and expanded the Langley Fork Historic Overlay District to include the Mackall/Hall House.

Chairman Bulova commemorated Commissioner Jack Hiller who died unexpectedly in February of last year and noted that at the County's 275<sup>th</sup> anniversary celebration on June 17 the Board's Lord and Lady Fairfax honorees will be recognized. She also noted that a Lord Fairfax descendant, Nicholas Fairfax, and his wife, will be attending the celebration.

Supervisor L. Smyth suggested that the History Commission explore what types of mechanism or planning tools would be necessary to help the 50+ community preserve, protect, and/or maintain the nature of their homes or neighborhoods. A brief discussion ensued, with input from Ms. Herrick and Ms. Lipsey.

Supervisor Hudgins, noting that she served on the Monument Committee which was set up by the General Assembly, raised a question regarding whether the History Commission has received feedback from the Monument Committee regarding roles in the local community. A brief discussion ensued with input from Ms. Herrick and Ms. Lipsey.

#### 17. **REQUEST TO RENAME THE EXCEPTIONAL DESIGN AWARDS PROGRAM** (11:36 a.m.)

Chairman Bulova relinquished the Chair to Acting-Chairman McKay and announced that former Supervisor and State Representative James M. Scott was a strong advocate for many quality-of-life issues during his 15-year tenure, January 5, 1972 - December 14, 1987, as the Providence District Supervisor. As a Supervisor in the mid 1980's, he recognized the importance of high quality architecture to the County's rapidly growing and evolving future and was a strong advocate for the establishment of the County's Exceptional Design Awards Program. He had the foresight to work with the Board and planning and zoning staff to make the program a reality in 1984, just as construction and development in the County was poised to take off.

The Program honors exemplary works of residential, commercial, and institutional architecture and design within the context of the surrounding landscape. To date, the Program has honored over 200 projects and stands as a distinctive platform for recognizing the County's exceptional architectural, planning, and design efforts.

Mr. Scott's vision and leadership to establish the Exceptional Design Awards Program, now in its third decade, has literally raised the bar for design excellence in the County.

The staff team that implements the Exceptional Design Awards Program has suggested that the design awards program be renamed in his honor and Chairman Bulova stated that this is not only a great idea but also a fitting way to honor Mr. Scott. Therefore, Chairman Bulova moved that the Board:

- Authorize the renaming of the design awards program as the "James M. Scott Exceptional Design Awards"
- Direct staff to invite his family to this year's awards program which is scheduled for later this year

Supervisor L. Smyth seconded the motion. Discussion ensued concerning the formal name of the award.

The question was called on the motion and it carried by a vote of nine, Supervisor Gross being out of the room.

Acting-Chairman McKay returned the gavel to Chairman Bulova.

## NATIONAL GUN VIOLENCE AWARENESS DAY IN FAIRFAX COUNTY (11:40 a.m.)

Supervisor Foust noted that Supervisor Hudgins had a similar Board Matter and asked unanimous consent that her Proclamation, which was attached to her written Board Matter, be incorporated into this item as a joint Board Matter. Without objection, it was so ordered.

Supervisor Foust said that gun violence in society is an epidemic and touches all of us. Each day, 93 Americans are killed by gun violence. Americans are 25 times more likely to be killed by guns than people in other developed countries. In a fraction of a second, lives can be tragically altered, not only for victims but for the loved ones left behind to cope with their loss. One such tragedy occurred in Chicago in January 2013. Ms. Hadiya Pendleton, a college-bound high school honors student marched with her high school band in the parade for President Obama's second inauguration in Washington D.C. Tragically, just one week later, Ms. Pendleton, an innocent bystander, was shot and killed. To honor Ms. Pendleton, many of her friends decided to wear orange on June 2, 2013, her birthday, as part of a Wear Orange for Gun Safety campaign. The color orange was chosen because it is the color that hunters use to make themselves seen to other hunters when out in the woods; it also symbolizes the value of human life.

The event grew into National Gun Violence Awareness Day, sponsored by Moms Demand Action for Gun Sense and other organizations. June 2 marks the fourth anniversary of the event and would be Ms. Pendleton's 20<sup>th</sup> birthday.

All of us have a responsibility to do all we can to raise awareness about gun violence, keep firearms out of the wrong hands, and encourage responsible gun ownership. We all have a right to live a life free from gun violence.

Therefore, jointly with Supervisor Hudgins, Supervisor Foust asked unanimous consent that the Board show its solidarity for families and communities torn apart by gun violence by:

- Proclaiming June 2, 2017, as "*National Gun Violence Awareness Day*" in Fairfax County
- Directing the Office of Public Affairs to distribute information publicizing this event and encourage the wearing of orange on June 2

Discussion ensued concerning personalizing the proclamation by including reference to gun violence in Virginia and the role of organizations in promoting gun safety. Without objection, it was so ordered.

#### 19. RECOGNIZING LONGFELLOW MIDDLE SCHOOL FOR WINNING FIRST PLACE AT THE VIRGINIA STATE SCIENCE OLYMPIAD TOURNAMENT (DRANESVILLE DISTRICT) (11:45 a.m.)

Supervisor Foust congratulated Longfellow Middle School for winning first place at the Virginia State Science Olympiad tournament, held on March 25 at the University of Virginia. The team will represent Virginia at the National Science Olympiad Tournament to be held on May 20 at Wright State University in Ohio.

Supervisor Foust noted that the Science Olympiad is an academic competition for middle and high school students that tests their knowledge in a variety of active, hands-on group events in the Science, Technology, Engineering, and Mathematics (STEM) disciplines of genetics, earth science, chemistry, anatomy, physics, geology, mechanical engineering and technology. Science Olympiad has been dedicated to improving the quality of K-12 science education for the last 33 years, providing rigorous, standards-based challenges to over 7,600 teams in 50 states through the Science Olympiad tournaments, incorporating Science Olympiad into classroom curriculum, and attending professional development workshops.

Therefore, Supervisor Foust asked unanimous consent that the Board direct staff to prepare a certificate, signed by the Chairman and himself, to be presented to the Longfellow Middle School Olympiad team at an event to be held on June 21, 2017, congratulating its excellent academic achievement. Without objection, it was so ordered.

#### 20. **ORDERS OF THE DAY** (11:47 a.m.)

Chairman Bulova announced that Supervisor Gross was attending a funeral. Discussion ensued concerning the presentation of her Board Matter.

#### 21. **<u>FIRE STATION SPRINKLERS</u>** (11:48 a.m.)

Supervisor McKay, noting the fire at the fire station on Edsall Road, asked unanimous consent that the Board direct staff to provide information concerning the status of sprinkler systems in the County's fire stations. Without objection, it was so ordered.

Supervisor Cook asked unanimous consent that the Board direct staff to provide the information in time for Carry-over decisions. Without objection, it was so ordered.

#### 22. **ARCLAND PROPERTIES (MASON DISTRICT)** (11:49 a.m.)

(A) On behalf of Supervisor Gross, Supervisor McKay said that Rezoning Application RZ 2016-MA-029 and Special Exception Application SE 2016-MA-023 are concurrent applications originally filed on two parcels of land located in Land Unit C of the Beltway South Industrial Area in the southwestern quadrant of the interchange of Edsall Road and I-395. The applicant, Arcland Property Company, is seeking to rezone a small residual strip of residentially zoned land to I-6, consistent with the surrounding properties and to receive approval of a special exception application to increase the maximum floor area ratio (FAR) from 0.50 to 1.0 to permit the development of a three-story mini-warehouse facility, with a cellar, on property zoned R-2 and I-6. During the review of these applications, a number of technical issues arose, many of which centered around the applicant's failure (at that time) to consolidate a third parcel of land to the immediate west of the application property which, due to its small size and location at the intersection of Edsall Road and Industrial Drive, required significant modifications to the applicant's proposed development to ensure that the unconsolidated parcel would be able to develop in the future. Although the applicant had tried unsuccessfully in the past to consolidate this parcel, on April 20, 2017, the applicant requested that the applications be deferred indefinitely to allow time for the applicant to attempt to consolidate and resolve the outstanding issues. He noted that the applicant has succeeded in consolidating this parcel and has just submitted the revised applications, now for all three parcels, to staff for final review. As this application was already significantly far along in the review process, and the applicant has used the deferral time to consolidate the missing parcel and address the major outstanding issues, the applicant has requested that its application be re-activated and scheduled in a timeframe which would permit the Board to hear the applications prior to the August recess, and has also requested that the Board approve concurrent processing of the site plans to permit this project to commence without further delay. Although staff just received the revised plans and has not completed the final review, he has been assured that it is the intent of the applicant to address the issues previously identified by staff.

Therefore, Supervisor McKay moved that the Board direct:

- Staff to schedule Rezoning Application RZ 2016-MA-029 and Special Exception Application SE 2016-MA-023 for a public hearing by the Planning Commission on July 19, 2017, and a public hearing by the Board on July 25, 2017, at 4 p.m.
- The Director of the Department of Public Works and Environmental Services (DPWES) to concurrently process any site plans submitted in association with these applications.

The approval of this motion does not in any way relieve the participants from compliance with the provisions of all applicable ordinances, regulations, or adopted standards, nor does it prejudice in any way the Board's consideration of the pending applications. Chairman Bulova and Supervisor Hudgins jointly seconded the motion and it carried by a vote of nine, Supervisor Gross being out of the room.

#### 23. <u>NO BOARD MATTERS FOR SUPERVISOR L. SMYTH (PROVIDENCE</u> <u>DISTRICT)</u> (11:52 a.m.)

Supervisor L. Smyth announced that she had no Board Matters to present today.

#### 24. **LYME DISEASE PREVENTION STUDY** (11:53 a.m.)

(NOTE: Earlier in the meeting the Board proclaimed May as "*Lyme Disease Awareness Month*" in Fairfax County. See Clerk' Summary Item #9.)

Supervisor Herrity said that Lyme disease affects approximately 200 families in the County with the number of diagnoses increasing every year. It has been discovered that the exploding population of white-footed mice are now the most popular hosts for black-legged ticks, the main carrier of Lyme disease. With more mice, ticks can more easily find a host body on which to live and later reproduce, passing down Lyme disease to the nymphs. The nymphs have the highest rate of transmitting the disease because they are incredibly difficult to notice, being about the size of a poppy seed. Moreover, black-legged ticks have increased their range by 20 percent from 1998 and are now found in 50 percent of US counties. One way to combat Lyme is rodent-targeted tick control using a tick tube. This rodent-targeted tick control may reduce black-legged tick loads on small mammals in a highly populated suburban environment, such as the County. The tubes are a method of host-based tick control that focus on treating whitefooted mice. The tubes are short, open-ended, biodegradable, cardboard tubes filled with cotton balls that are treated with the insecticide permethrin. Mice collect the cotton to use in their burrows as nesting material where the permethrin is spread to their fur. A preliminary conversation with the Budget Office indicates there may be funding for such a study in Fund 40080, the Disease Carrying Insect Program.

Therefore, Supervisor Herrity moved that the Board direct the County Executive to explore the feasibility to conduct a research study on the use of these tubes to reduce the tick loads on small animals and report to the Board. Chairman Bulova seconded the motion.

Following a brief discussion regarding the motion, Supervisor L. Smyth asked to amend the motion to make more information available to the public. This was accepted.

The question was called on the motion, as amended, and it carried by a vote of nine, Supervisor Gross being out of the room.

25. FIVE OAKS PROPERTIES – REQUEST TO EXPEDITE CONCURRENT PROCESSING (11:57 a.m.)

> Supervisor Herrity said that on April 7, 2017, and May 10, 2017, applications for a Final Development Plan Amendment (FDPA) and a Conceptual Development Plan Amendment (CDPA) were accepted for review and comment by the County. The applicant, Five Oaks Properties, LLC, requests approval to amend an approved FDPA and CDPA to permit a college or university as a secondary use in the existing building. No changes are proposed to the building or site. The applicant is also seeking a waiver of Paragraph 5 of Section 6-206 of the Zoning Ordinance to permit the gross floor area of all other secondary uses to exceed 25 percent of the gross floor area of all principal uses. The subject property is located at 4375 Fair Lakes Court, Tax Map Number 45-4 ((1)) 25D. The applicant has a formal public hearing scheduled before the Planning Commission on July 27, 2017. The applicant has requested authorization to process a concurrent site and building plans for the project in advance of that hearing and has asked for a date certain for a hearing before the Board.

Therefore, Supervisor Herrity moved that the Board direct the:

- Director of the Department of Public Works and Environmental Services to accept for concurrent and simultaneous review a site plan, architectural drawings, building permits and other plans as may be necessary to implement the improvements contemplated by the applicant with the FDPA and CDPA applications.
- Clerk to the Board schedule this application for a public hearing before the Board on September 12, 2017.

The applicant is aware that this motion should not be considered as a favorable recommendation by the Board on the proposed applications and does not relieve the applicant from compliance with the provisions of all applicable ordinances, regulations, and/or adopted standards, nor does it prejudice, in any way, the Board's consideration of this pending application. Supervisor L. Smyth seconded

the motion and it carried by a vote of nine, Supervisor Gross being out of the room.

#### 26. <u>MOBILE AND LAND BASED TELECOMMUNICATIONS POLICY</u> <u>PLAN AMENDMENT</u> (11:59 a.m.)

Supervisor Herrity said that in February 2012, Section 6409(a) of the Spectrum Act (codified at 47 USC Section 1455) was enacted to govern state and local government review of requests to modify existing telecommunications facilities. Section 6409(a) prohibits a state or local government from denying, and requires the approval of, any request for collection, removal, or replacement of an existing wireless tower or base station that does not substantially change its physical dimensions.

On January 24, 2017, Supervisor Herrity offered a motion to authorize staff to prepare a Mobile and Land Based Telecommunications Policy Plan amendment incorporating the telecommunications review process of Section 6409(a) of the Spectrum Act. The motion was carried by unanimous vote. In the 2017 Virginia General Assembly Session, Senate Bill 1282, which is related to the Wireless Communications Infrastructure, was proposed to provide a uniform procedure for the way in which localities review and approve small cell facilities on existing As enacted, the new law requires the Virginia Department of structures. Transportation to grant access to wireless service provider and wireless infrastructure provider applicants to install and maintain small cell facilities on existing structures in public rights-of-way and limits localities' ability to regulate such uses of public rights-of-way. The zoning approval process prescribed in the new law supersedes the 2232 review process with respect to small cell facilities. Today, the Board authorized advertisements of amendments to the Zoning Ordinance (ZO) to address Senate Bill 1282 and the Spectrum Act.

Therefore, in response to this legislation and to the proposed ZO amendments, Supervisor Herrity moved that the Board authorize staff to prepare a Mobile and Land Based Telecommunications Policy Plan amendment. This amendment will be directed at modifying the Policy Plan language to bring it current in light of the telecommunications review process of Section 6409(a) of the Spectrum Act (codified at 47 USC Section 1455) and the ZO amendments authorized today implementing Senate Bill 1282 relating to Wireless Communications Infrastructure. Supervisor Cook seconded the motion.

Discussion ensued, with input from Chris Caperton, Assistant Director, Department of Planning and Zoning, regarding simplifying the Policy Plan language.

Supervisor L. Smyth asked to amend the motion to simplify the Policy Plan to cover future updates to prevent frequent amendments. This was accepted.

The question was called on the motion, as amended, and it carried by a vote of nine, Supervisor Gross being out of the room.

#### 27. CLIFTON DAY (SPRINGFIELD DISTRICT) (12:05 p.m.)

Supervisor Herrity referred to his written Board Matter and said that every year the Clifton Betterment Association (CBA) hosts "Clifton Day" with this year being its fiftieth anniversary on Sunday, October 8, 2017. He urged all Board Members to stop by and see what this enchanting part of the County has to offer.

In recognition of the contribution to the community spirit this event brings, Supervisor Herrity asked unanimous consent that the Board direct staff to invite Ms. Michelle Stein of the CBA to appear before the Board to accept a proclamation congratulating the CBA on its hard work and fiftieth anniversary. Without objection, it was so ordered.

#### 28. RECOGNIZING THE FIFTIETH ANNIVERSARY OF VILLAGE WEST POOL (12:06 p.m.)

Supervisor Herrity referred to his written Board Matter and said that Village West Pool has been serving the West Springfield community for the past 50 years.

Supervisor Herrity asked unanimous consent that the Board direct staff to prepare a proclamation with dual signatures recognizing Village West's fiftieth anniversary to be presented at its celebration on June 3, 2017. Without objection, it was so ordered.

Supervisor Hudgins said the Board, together with Inova Health Services, Incorporated, is pursuing the redevelopment of the approximately 47-acre Reston Town Center North site. Currently, the site is comprised of a number of irregularly shaped parcels owned by the Board or by Inova. Specifically, the Board owns Tax Map Number 17-1 ((1)), parcels 3F, 12, 13, 14B, 14C, 14D, and Tax Map Number 17-1 ((17)), parcel 5A, while Inova owns Tax Map Number 17-1 ((11)), parcels 14A, 14E, and 14F.

The Comprehensive Plan envisions that the Reston Town Center North area will be redeveloped into an urban mixed-use development site with a grid of streets and walkable blocks consistent with those in the Urban Core of Reston Town Center. To that end, in 2015 the Board approved and executed an interim agreement with Inova, which committed the Board to jointly seek, with Inova, an initial, "Phase 1" zoning action to consolidate the entire Reston Town Center North site area under a unified development plan to create the grid of streets and developable blocks, as reflected in the Comprehensive Plan. If the initial Phase 1 zoning actions are approved, the Board and Inova, or their respective successors, as applicable, would subsequently seek additional land use approvals for the detailed site design and mix of uses on a block-by-block basis. The proposed Reston Town Center North redevelopment would establish a large Central Green park feature as well as new public facilities, including the redevelopment of the Reston Regional Library and the Embry Rucker Community Shelter. Over the past several years, County and Inova staff have been developing and refining the proposal as a result of extensive community outreach. Staff will also brief each Board Member on the project in the coming weeks. Staff has scheduled a further community information meeting to be held on May 31, 2017.

Supervisor Hudgins stated her understanding that County staff and Inova intend to file the necessary zoning applications to establish the Reston Town Center North overall development plan with the grid of streets, streetscape, and development blocks in the near future.

Therefore, Supervisor Hudgins moved that the Board:

- Authorize and concur in the filing of all necessary zoning applications to implement Phase 1 of the Reston Town Center North redevelopment, including any determinations, as applicable, under Section 15.2-2232 of the Code of Virginia
- Designate staff from the Department of Public Works and Environmental Services (DPWES) – specifically, James Patteson, Director; Ron Kirkpatrick, Deputy Director; Carey Needham, Director of the Building Design and Construction Division; Katayoon Shaya, Branch Chief, Public Private Partnerships; and Joan Beacham, Project Coordinator – to act on behalf of the Board as its representative agent to expeditiously file and process, together with Inova, these applications with the Department of Planning and Zoning (DPZ)
- Authorize the County Executive to execute any proffers that may be required with such applications
- Authorize the Director of the Zoning Evaluation Division, DPZ, to expeditiously process the zoning applications and schedule the public hearings before the Planning Commission and the Board
- Authorize the Director of Land Development Services (LDS) to concurrently process any related land development review actions

This motion should not be construed as a favorable recommendation on the applications by the Board and does not relieve the applicant from compliance with the provisions of any applicable ordinances, regulations, or adopted standards. This action in no way prejudices the substantive review of the applications. Chairman Bulova seconded the motion and it carried by a vote of nine, Supervisor Gross being out of the room.

#### 39. PROFFERED CONDITION AMENDMENT APPLICATION PCA 2012-SU-010 (SULLY DISTRICT) (12:27 p.m.)

Supervisor K. Smith said that on March 7, 2017, an application for Proffered Condition Amendment PCA 2012-SU-010 was accepted for review and comment. The applicant NVHI I and Chantilly AL Investors LLC, requests approval to amend an approved rezoning application, previously approved to permit a 166-bed skilled nursing facility and a separate 100-unit independent and 66-bed assisted living facility per Rezoning/Final Development Plan Application RZ/FDP 2012-SU-010, to modify Proffer 17 to eliminate the covered walkway between the two buildings. This is the only item being addressed with this PCA. The subject property is located at 2978 and 2980 Centreville Road, Tax Map 24-4 ((1)) 11C and 11D.

The applicant has a formal public hearing scheduled before the Planning Commission on June 29, 2017. The applicant has requested authorization to process a concurrent site plan for the project in advance of that hearing and asked for a date certain for a hearing before the Board.

Therefore, Supervisor K. Smith moved that the Board direct the:

- Director of the Department of Public Works and Environmental Services to accept for concurrent and simultaneous review a site plan, architectural drawings, and other plans as may be necessary to implement the improvements contemplated by the applicant with this proffered condition amendment application.
- Clerk to the Board schedule this application for a public hearing before the Board on July 11, 2017.

The applicant is aware that this motion should not be considered as a favorable recommendation by the Board on the proposed applications and does not relieve the applicant from compliance with the provisions of all applicable ordinances, regulations, and/or adopted standards nor does it prejudice in any way the Board's consideration of this pending application. Supervisor L. Smyth seconded the motion and it carried by a vote of nine, Supervisor Gross being out of the room.

## REQUEST FOR EXPEDITED PROCESSING - VERIZON WIRELESSANDMILESTONECOMMUNICATIONS(SULLYDISTRICT)(12:30 p.m.)

Supervisor K. Smith said that on December 4, 2014, Verizon Wireless and Milestone Communications received Planning Commission approval for public facilities application 2232-Y-14-7, to permit the construction of a new telecommunications facility (monopole) in the northern corner of the Northern Virginia Electric Company (NOVEC) property identified as 6309T Bull Run Post Office Road, Tax Map 52-2 ((1)) 11E. This approval was for what was then a by-right facility in the Residential-Conservation (R-C) District. However, since the approval of the application two significant changes have occurred:

- NOVEC has made improvements to its approved substation on the site which encroach into the area which was originally planned to be used by the applicants for the monopole, thereby resulting in the delay of its construction.
- The Board approved Zoning Ordinance Amendment ZO-16-453, effective June 22, 2016, which changed the approval process for monopoles and telecommunication towers. This amendment established a requirement for special exception approval by the Board of Supervisors, prior to the installation of any monopole or tower which would have formerly been permitted by-right. This amendment affects the RC zoned property which was the subject of the previous 2232 approval and consequently the proposed facility is no longer allowed by-right and requires the approval of a special exception.

Due to the improvements made by NOVEC to its facility, the applicants (Verizon Wireless and Milestone Communications) are now seeking to relocate the proposed telecommunications facility to the southern limit of the subject property, and are seeking approval of a 2232 and a special exception.

Consequently, as there has already been significant delay in constructing this facility, the applicants are requesting expedited processing of the necessary requirements to ensure that this project move forward without further delay.

Therefore, Supervisor K. Smith moved that the Board direct that the concurrent 2232 public facilities application and the special exception application be expeditiously processed and scheduled for public hearing by the Board as soon as practicable, and that any additional plans and permits needed to permit the construction of the telecommunications facility also be granted concurrent processing. The approval of this motion does not in any way relieve the participants from compliance with the provisions of all applicable ordinances, regulations, or adopted standards nor does it prejudice in any way the Board's consideration of the pending applications. Supervisor Foust and Supervisor Herrity jointly second the motion and it carried by a vote of nine, Supervisor Gross being out of the room.
