Under Review

- ▶ Independent Oversight and Investigations 2, 2a relate to recommended independent investigators for Commonwealth's Attorney's Office, preliminary discussion with CWA
- ▶ Undergoing legal review and discussion – Use of Force 8h, 32, 35
- ▶ Mental Health & CIT 19 – preliminary discussions of Mental Health dockets
- ▶ Mental Health & CIT 5, 21, 22 – involve further discussion primarily between CSB, Police Department, Sheriff's Office
- ▶ Mental & Health 11 – requires County and agency focus, targeted recruiting and hiring, and strategic planning
