The following is a summary of the highlights of the discussion from the **October 11, 2016** meeting.

Item I Supervisor Gross called the meeting to order at 1:05 p.m.

A Review of Meeting Summary (May 24, 2016) was presented and accepted into the record.

Item II Environmental Vision Update Process: Overview of public input received through the on-line survey and the July 2016 public meetings

Kambiz Agazi, Environmental Coordinator, CEX Noel Kaplan, Senior Environmental Planner, Planning Division, DPZ

Kambiz Agazi and Noel Kaplan provided a general overview of community involvement and the results of the public survey and community meetings that took place in June and July of 2016.

Kambiz provided the committee with a schedule of activity and events regarding past and future community involvement. Future activity included working with both Board member offices and EQAC prior to posting a draft Vision on the county's dedicated web page for public review and comment, which is anticipated early next year.

Noel Kaplan provided an overview of the results of the online survey and public meetings. The presentation included the number of respondents and participants and an overview of the categories identified based on the participation.

Item III Public Maintenance of Private Storm Water Management Facilities

Karlee Copland, Chief, Maintenance and Stormwater Management, DPWES

Karlee provided the committee with a recap of a conversation staff has had with the committee since 2013 regarding the issue of the county looking to take over maintenance of certain qualified stormwater management facilities.

The presentation highlighted that currently the county is only considering residential wet and dry pond facilities located on HOA property or specified outlots. It's estimated that the total number of facilities admitted into the program would be less than 20 per year. It was also mentioned that once the voluntary program is approved, new pond facilities will be given the option during development to be publicly maintained.

Some additional program highlights included:

- 1. Voluntary program to include residential wet and dry ponds on outlots are eligible.
- 2. Facility must be in "functional" condition before transfer.
- 3. Cost-Share Program.
- 4. Extensive program outreach.
- 5. Ongoing maintenance responsibilities defined.

Responses to questions from the board's committee:

Gross It has been a year since the Board last discussed this item so today will be an update. DPWES will bring this back at the next Environmental Committee meeting prior to it being a regular board item.

Cook Don't agree with the county tax payers taking over and fixing private properties however maybe the county can provide assistance under a contract similar to the county trash service. I do like the county's contractors list.

Storck List of contractors is a wonderful list. Try to connect the list with some of the data we already have for those companies such as information in Consumer affairs.

Next steps, staff will prepare a memo – explaining: The communities that have already requested assistance. Discuss the impacts off site drainage on some facilities. Discuss off site credits. Discuss contract options with the County Attorney. Offer individual briefings to Board members and plan to come back at the next BOS EC meeting.

Item IV Stormwater Updates - Consolidated MS4 Program Plan and Annual Report, Upcoming Draft TMDL Action Plans

Kate Bennett, MS4 Program Coordinator, Storm Water Planning, DPWES

Kate provided updates on the status of MS4 permits in Virginia, which have now all been renewed.

The county's renewed permit required an update of the MS4 program plan, and staff used the efforts that had gone into the tactical planning process to re-engage the agencies and partners involved in implementing the MS4 program. The updated program plan was submitted to DEQ on September 30, 2016.

Kate also provided a brief update on the Chesapeake Bay TMDL Action Plan being developed by the county and on the 2017 mid-point assessment of the Chesapeake Bay TMDL. The county is also developing TMDL Action Plans for local TMDLs.

Finally, Kate provided an update on the replacement TMDL for Accotink Creek, which will be developed for sediment and chloride (primarily from road salts).

Responses to questions from the board's committee:

Gross EPA is working with state and local governments to determine how much

progress has been made toward the Chesapeake Bay restoration goals. Virginia is taking the lead and working with local governments to develop a Phase III

watershed implementation plan (WIP).

John Cook Would street sweeping help with Road salt? Street sweeper leaves behind a lot of

sediment.

Kate At the frequency that the county currently sweeps, the Majority of chloride is

washed away before sweeping occurs.

Randy We'll be looking at a lot of options.

Smyth Offsite credit – are we seeing more of those? How many more builders are asking

for those?

James We're starting to see a lot of them.

Foust Credits for stream restoration - we're having a hard time getting those.

Bartlett 2010 – we couldn't get them. Stream restoration – most cost effective way.

The amount of credits we're getting has changed. With local stream TMDLs – we

actually get more credit.

Item V Stormwater Program Business Plan Development

James Patteson, Director, DPWES

James indicated in his presentation that the stormwater program business plan was a multi-year plan with the goal of documenting stormwater program drivers, needs and wants. It was anticipated that the kick-off for the business plan would be June 2017

Item VI <u>Virginia Tech/Old Dominion University Stormwater Research Center</u> James Patteson, Director, DPWES

James indicated that staff has been working with Virginia Tech on the idea of developing a Center for Stormwater Research to help advance the science of effectively treating stormwater. Currently no such center exists in Virginia. The main purpose of the center would be to:

- Improve the science of stormwater to facilitate better decision making on what practices provide the best bang for the buck.
- Promote studies / information on performance of practices over time and what maintenance protocols should be employed.
- Create a partnership between the Commonwealth, local governments, VDOT, the private sector, and state universities to support a research center to better address national and state clean water goals.

James indicated that ultimately the research center would be used by the Commonwealth to guide future decision making in ordinance and permit requirements and:

- Improve the science with improved knowledge comes better decision making, smarter investments, and more predictable outcomes.
- Support adaptive management feedback with DEQ partnership and stakeholder governance research will be directed and utilized to improve implementation of clean water goals.
- Provide credibility of results state universities bring an unbiased and heightened scientific rigor to the research efforts and performance results.
- Prepare future thought leaders partnership with the universities will fund graduate level research that will help prepare future leaders.

- Provide for a path forward for innovative practices and technology development – research center can support the acceptance of innovative practices.
- Provide a Virginia solution to water quality issues unique to Virginia.
- Provide outreach and education to the practicing community.
- Foster stakeholder partnerships.

James indicated that the next step would be to draft a bill which the county could support.
